### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Heritage Credit Union 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Heritage Credit Union 401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### ***Responsibilities of Management for the Financial Statements***

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of the Heritage Credit Union 401(k) Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Heritage Credit Union (the "Employer") who have completed three months of service and reached the age of 21. Participants may enter the Plan on the first day of the quarter after meeting the service and age requirements. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### Plan Merger

On January 3, 2022, Heritage Credit Union members voted in favor of a merger with Connexus Credit Union which was legally finalized on March 1, 2022. Subsequent to that date, contributions to the Plan ceased, with employees becoming participants of the Connexus Credit Union 401(k) Plan. The Plan merged effective January 1, 2023, and its investments and notes receivable were subsequently transferred to the Connexus Credit Union 401(k) Plan.

#### Contributions

Each year, participants may contribute up to 100% of eligible compensation on a pre-tax or after-tax basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation. The Employer matches 100% of participant salary deferral contributions up to 5 percent of eligible compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions, and allocations of plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting and Forfeitures

Participants are immediately vested in their contributions plus actual earnings thereon. A participant is vested in the Employer's matching contributions and earnings thereon according to the following schedule:

<u>Years of Service</u>	<u>Vesting %</u>
Less than 2 years	0 %
2 years	20 %
3 years	40 %
4 years	60 %
5 years	80 %
6 or more	100 %

Notwithstanding the above vesting schedule, Employer matching contributions are 100% vested upon death, disability, or the attainment of retirement age.

Plan forfeitures arise as a result of participants who terminate service with the Employer before becoming 100% vested in the Employer matching contributions. Under the Plan, forfeitures may be used to pay Plan expenses or to reduce future Employer matching contributions. For the year ended December 31, 2022, Employer matching contributions were reduced by \$14,751 and \$1,500 of expenses were paid from forfeited nonvested accounts. Unused forfeitures at December 31, 2022 and 2021 were \$46,963 and \$0.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of 50% of their vested balances or \$50,000. Loan terms range up to five years, unless made for the purchase of a primary residence. Loans are secured by the participant's investment accounts and bear interest at 1% above the prime rate. Interest rates on existing loans equal 4.25%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest payments are paid through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or separation from service with the Employer, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installments over a period of not more than the expected life expectancy of the beneficiary, or an annuity. In-service distributions from fully-vested accounts are available to participants who have attained age 59 ½ or who have incurred a financial hardship.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### **Investment Valuation and Income (Loss) Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

### **Note 2: Summary of Significant Accounting Policies** (Continued)

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to benefit payments, administration of notes receivable from participants, and Plan administration and recordkeeping expenses are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 11, 2023, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of level 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* The fair value of collective trust funds is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Underlying investments of the collective trust funds are generally valued as follows: domestic and foreign fixed income securities are valued at fair value based on market values obtained from independent pricing services, quotes by dealers who are market makers in these securities, or by a methodology approved by the investment contract's trustee.

### Note 4: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan invests in a FBRIC with CMFG Life Insurance Company (CMFG) in the form of a guaranteed investment contract (GIC). CMFG maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. CMFG is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on the best interest rate that is consistent with the performance of CMFG's general account assets.

Certain events limit the Plan's ability to transact at contract value with CMFG including plan termination and other events as specified in the GIC.

### **Note 5: Information Prepared and Certified by Custodians**

The plan administrator has elected the method of annual reporting compliance by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, investment contracts and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company and CMFG Life Insurance Company, the custodians of the Plan.

### **Note 6: Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are managed by CMFG, a custodian as defined by the Plan, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan to CMFG for the Plan administration and recordkeeping services were \$34,930 for the year ended December 31, 2022. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Certain legal and accounting fees and certain administrative expenses relating to the maintenance of employee records are paid by the Employer.

### **Note 7: Plan Termination**

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On January 3, 2022, Heritage Credit Union members voted in favor of a merger with Connexus Credit Union which was legally finalized on March 1, 2022. As a result, management has made plans to merge the Heritage Credit Union 401(k) Plan and Trust into the Connexus Credit Union 401(k) Plan, which was completed during early 2023.

### **Note 8: Tax Status**

The Employer has adopted a nonstandardized pre-approved plan which the IRS has determined to be qualified under Section 401(k) of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan is qualified and the related trust was tax-exempt at the financial statement date.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
