To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the LIFE-NWPA 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1. Plan Description

The following description of the LIFE-NWPA 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan was formed effective January 1, 2022. The Plan is a defined contribution plan sponsored by LIFE Northwestern Pennsylvania, LLC (the Plan Sponsor), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Subsequent to year-end, effective January 1, 2023, the Plan adopted a resolution to change the plan name to the One Senior Care, Inc. 401(k) Plan and the plan sponsor to One Senior Care, Inc. The Plan Sponsor's management is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility:

Employees of the Plan Sponsor, except for non-resident aliens, union employees, leased employees or those employees who work less than 20 hours per week, as defined by the Plan, are eligible to participate in the Plan. Subsequent to year-end, effective January 1, 2023, the Plan was amended to grant eligibility to those who work less than 20 hours per week. Eligible employees are enrolled immediately. Participants are eligible to receive discretionary employer matching contributions once they have reached the age of 21 and completed one year of service, as defined. Subsequent to year-end, effective January 1, 2023, the Plan was amended to remove age and service requirements for discretionary employer matching contributions. All eligible participants will immediately be eligible to receive discretionary employer matching contributions. Prior service with the Lutheran Home for the Aged d/b/a The Village at Luther Square, d/b/a LIFE-Northwestern Pennsylvania (VALS), a previously related entity, counted toward initial eligibility for discretionary employer matching contributions upon the formation of the Plan. Effective November 7, 2022, employees of One Senior Care Virginia, LLC dba Cherry Blossom PACE (Cherry Blossom), a related entity, are eligible to participate in the Plan, with all age service requirements waived. The Plan Sponsor and Cherry Blossom are hereafter referred to collectively as the "Company". Prior to November 7, 2022, highly compensated employees, as defined by the Plan, were not eligible for discretionary employer matching contributions. Effective November 7, 2022, highly compensated employees are eligible for discretionary employer matching contributions.

Contributions:

Participants may make voluntary pre-tax contributions to the Plan up to 100% of their eligible compensation, as defined. Participants who are fifty years and older may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan permits the Company to make discretionary employer matching contributions. During the year ended December 31, 2022, the Company made quarterly matching contributions to all eligible participants, which were equal to participant contributions. Subsequent to year-end, effective January 1, 2023, the Plan was amended to limit matching contributions to \$5,000 in a given plan year.

Contributions are subject to certain Internal Revenue Code (the Code) limitations. Participants direct the investment of contributions into various investment options offered by the Plan.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description (Continued)

Participant accounts:

Each participant's account is credited with the participant's contributions, discretionary employer matching contributions, an allocation of Plan earnings, reduced for benefits paid, and charged directly for loan origination and benefit processing fees, if applicable. Plan earnings subject to allocation are allocated based on the investments held by the participant. The benefit to which a participant is entitled is limited to that which can be provided from the participant's vested account balance.

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Discretionary employer matching contributions become 20% vested after one year of credited service, as defined, with vesting increasing at 20% increments each year thereafter, to 100% after five years of credited service.

Forfeitures:

At December 31, 2022, forfeited non-vested accounts amounted to \$312. Forfeitures of non-vested Company contributions are used to pay administrative expenses of the Plan or to reduce the Company's contributions. Forfeitures of \$768 were used to pay administrative expenses in 2022.

Payment of benefits:

Upon termination of employment with the Company, death, disability, or retirement, a participant or a participant's beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Distributions are also permitted in the event of financial hardship, as defined by the Plan, and for participants who have attained age 59½.

Notes receivable from participants:

Effective November 7, 2022, the Plan was amended to allow participants to borrow from certain of their accounts a minimum of \$1,000 up to a maximum loan equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Loans must be repaid in at least quarterly installments over a maximum term of 5 years for personal loans and over a term determined by the Plan Administrator for loans related to the purchase of a participant's primary residence. Principal and interest are paid ratably through payroll deductions. At December 31, 2022, the Plan did not have any notes receivable from participants.

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net depreciation in fair value of investments.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements have been prepared on the accrual basis of accounting.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Excess contribution:

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan recorded \$2,376 as a liability for excess contributions related to the year ended December 31, 2022. The Plan distributed \$2,376 for excess contributions in 2023 related to contributions for the year ended December 31, 2022.

Benefits:

Benefits are recorded when paid.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events:

Subsequent events have been evaluated through October 13, 2023, which is the date the financial statements were available to be issued.

Note 3. Information Certified by Ascensus, LLC

The following is a summary of the Plan's asset information as of December 31, 2022, and for the year then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified by Ascensus, LLC, as agent for Ascensus Trust Company (Ascensus), the trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets at December 31, 2022:

Ascensus also certified to the completeness and accuracy of net depreciation in fair value of investments of \$163,003 and dividend income of \$54,542 related to the aforementioned assets for the year ended December 31, 2022.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 4. Fair Value Measurements (Continued)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is primarily based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Plan has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 6. Tax Status

The Plan adopted a nonstandardized form of a prototype plan sponsored by Walker Benefits LLC. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status dated June 30, 2020. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Party-In-Interest Transactions

A party-in-interest is defined under the Department of Labor's regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, certain participants, and others.

Ascensus Trust Company is the trustee as defined by the Plan, Ascensus, LLC, through a subcontract agreement with the Vanguard Group Inc., is the Plan recordkeeper, HBKS Wealth Advisors is the Plan investment advisor, and Baker Tilly Vantage, LLC is the third-party administrator. Therefore, transactions with these parties qualify as party-in-interest transactions and are reported as administrative expenses. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment from the Plan.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
