Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements

We have performed an audit of the financial statements of The Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 (Liquidation Basis), and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (“2022 Financial Statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan’s 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 8 to the 2022 financial statements, is complete and accurate.

Opinion on the 2022 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the 2022 Financial Statements section:

- The amounts and disclosures in the accompanying 2022 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2022 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the 2022 Financial Statements section of our report. We are required to be independent of The Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2022 financial statements.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the 2022 financial statements, the dealerships under common ownership were sold to an unrelated third party and the Plan has been terminated effective September 13, 2022. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the December 31, 2021 financial statements to the liquidation basis used in presenting the December 31, 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2022 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the 2022 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the 2022 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of The Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2022 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Auditors' Report on the 2021 Financial Statements

The 2021 financial statements of the Plan were audited by Friedman LLP (“Friedman”), whose practice merged with Marcum LLP as of September 1, 2022. Friedman performed an audit of the 2021 financial statements of The Retirement Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the 2021 audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. The report dated October 10, 2022 indicated that (a) the amounts and disclosures in the 2021 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2021 financial statements held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). The report also indicated that the form and content of the 2021 supplemental schedule, other than the information in the 2021 supplemental schedule that agreed to or is derived from the certified information, was presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosures under ERISA; and the information in the 2021 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF PLAN

The following description of The Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more detailed and complete description of the Plan’s provisions.

GENERAL

The Plan was established to provide retirement benefits for employees of DFFLM, LLC and affiliates (the “Employer”, the “Company”). Empower Annuity Insurance Company of America, formerly known as Great West Life & Annuity Insurance Company (“Empower”, “Great West”, “Custodian”), serves as the Custodian of the Plan, which is subject to the requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan Administrator is responsible for governance of the Plan. The Plan’s Financial Advisor determines the appropriateness of the Plan’s investment offerings and monitors investment performance. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Trustee. Empower Retirement LLC serves as the recordkeeper and administrator of the Plan.

PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. On August 8, 2022, the dealerships under common ownership were sold to an unrelated third party. The Plan has been terminated as of September 13, 2022 (“termination date”). All participant balances have been rolled into IRA accounts or transferred to the buyer’s 401(k) plan. As of December 31, 2022, all participant accounts were liquidated.

ELIGIBILITY

Employees become eligible to participate in the Plan following 12 months of service with a minimum of 1,000 hours of service and attainment of age 21, as defined in the Summary Plan Description.

CONTRIBUTIONS

Eligible employees may make elective contributions and Roth contributions determined by the participant, as defined by the Plan, and subject to Internal Revenue Code (“IRC”) limitations. Participants 50 years of age or older can contribute an additional elective contribution or Roth 401(k) contribution known as a catch-up contribution.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

CONTRIBUTIONS (CONTINUED)

Eligible employees may also elect to roll over distributions from a qualified retirement plan to the Plan.

The Employer makes a matching contribution equal to 100% of the first 2% of compensation that the participant contributes. As of December 31, 2022, Employer matching contribution was \$362,778, of which \$4,221 was funded by forfeitures. The Employer may make discretionary non-matching contributions to the Plan each year, whether or not an employee makes an elective contribution to the Plan. Employees can share in discretionary contributions if employed on the last day of the Plan year. There were no discretionary non-matching contributions during 2022.

PARTICIPANT ACCOUNTS

Individual accounts are maintained for each participant. Each participant's account is credited with the participants' contributions, the Employer's contributions and an allocation of the Plan's earnings and charged with withdrawals and Plan losses and an allocation of administrative expenses. The Plan's earnings and investment expenses are allocated according to the participants' relative account balances in the investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES RECEIVABLE FROM PARTICIPANTS

The Plan does not provide for any loans to be extended to participants.

INVESTMENT OPTIONS

Participants may direct the investment of their contributions to the Plan into various investments offered by the Plan. Investment options include mutual funds and a guaranteed investment contract.

The Pension Protection Act created the Qualified Default Investment Alternative (the "QDIA") which provides employers a safe harbor from fiduciary risk when selecting an investment for a participant or beneficiary who fails to elect his or her own investment and for automatic enrollment. Under the Plan's QDIA, automatic deferral amounts of 3% are invested for non-electing employees. The Plan has selected the T. Rowe Price Retirement Funds with the target date closest to the participants estimated retirement date.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in Company matching contributions, if any, plus earnings thereon is based on years of continuous service. A participant will vest 20% per year on a five year graded vesting schedule. Upon Plan termination date, participants became fully vested in all contributions and earnings thereon.

FORFEITURES

The portion of a participant's account balance attributed to the Company's matching contributions that is not vested upon termination of employment will be forfeited and may be used in future periods to first pay Plan expenses and then reduce the Company's matching contribution. At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$-0- and \$4,046, respectively. At December 31, 2022, the amount of forfeitures used to reduce the Employer contributions totaled \$4,221.

PAYMENT OF BENEFITS

Benefits are recorded when paid. At the termination of employment, a participant will receive their account balance as a lump sum or as a direct rollover to a Code Section 403(b) annuity contract, an IRA (if participant is non-spouse beneficiary), or to a Roth IRA. If one of these options is not selected, then the Employer may issue a lump sum payment or issue a direct rollover to an IRA chosen by the Plan Administrator if the vested participant account balance is less than \$1,000. If the vested interest in the value of the termination benefit is greater than \$1,000 but not greater than \$5,000, then the vested interest (including any Rollover Contributions) will be paid in a direct rollover to an IRA chosen by the Plan Administrator.

If the vested participant account balance is greater than \$5,000, the participant may elect to receive a single lump sum payment or installments any time after the termination date.

Unless elected otherwise, benefit payments must commence no later than the 60th day after the close of the Plan year in which occurs the latest of the following events: (1) the close of the Plan year when the participant reaches age 65 or normal retirement age (if earlier), or (2) the termination of employment.

Participants will receive the full amount of their vested account balances in the event of normal retirement, death or disability. Early withdrawals are permitted at the participant's request after the age of 59½. Certain hardship withdrawals are also permitted.

PAYMENT OF BENEFITS (CONTINUED)

Distributions will be made in lump-sum payments, joint and survivor annuities or pre-retirement survivor annuities. Required minimum distributions must begin at age 72.

HARDSHIP WITHDRAWALS

The Plan provides for hardship withdrawals, as set forth in accordance with applicable sections of the IRC, not to exceed a participant's actual contributions to the Plan, and must result from an immediate and heavy financial need of the participant as determined on a non-discriminatory basis by the Plan Administrator.

ADMINISTRATIVE EXPENSES

All expenses incurred in the administration of the Plan are the responsibility of the Plan. However, the Company may choose to pay certain expenses at its discretion.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompanying financial statements of the Plan as of and for the year ended December 31, 2022 have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Financial statements prepared using the liquidation basis of accounting are required to present relevant information about the Plan's expected resources in liquidation by measuring and presenting assets at the amount of the expected cash proceeds from liquidation and accrue for any costs expended to be incurred as a result of the liquidation. The financial statements as of December 31, 2021 were prepared on the accrual basis of accounting in conjunction with the Plan being ongoing at the time.

USE OF ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INCOME RECOGNITION

Net (depreciation) appreciation in the fair value of investments includes both realized and unrealized gains and losses bought and sold as well as held during the year, based on the value of assets at the beginning of the year or at the time of purchase during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are allocated based upon participant account holdings on the record date and are recorded on the ex-dividend date.

MANAGEMENT FEES AND OPERATING EXPENSES

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees are reflected in the net (depreciation) appreciation in fair value of such investments.

INVESTMENT VALUATION

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

INVESTMENT VALUATION (CONTINUED)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

MUTUAL FUNDS

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

SUBSEQUENT EVENTS

These financial statements were approved by management and available for issuance on October 12, 2023. Management has evaluated subsequent events through this date.

NOTE 3 - GUARANTEED INVESTMENT CONTRACT

As required by GAAP, fully benefit-responsive investment contracts held by defined contribution plans are required to be reported at contract value. Contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

As of December 31, 2021, the Plan held an interest in the Guaranteed Interest Fund ("Fund") as an investment option available to participants. The Fund is managed by Empower Trust Company, LLC.

NOTE 3 - GUARANTEED INVESTMENT CONTRACT (CONTINUED)

The Fund is credited with participant contributions plus earnings and charged for participant withdrawals and administrative expenses. Average yields based on interest rates credited to participants for the Fund was 1.15% for 2021.

Investments of the Funds included Guaranteed Investment Contract (“GIC”), typically issued by insurance companies, which provide for guarantees of interest and repayment of principal. An issuer of a GIC is contractually obligated to repay the principal and a specified interest rate or interest rate index that is guaranteed to the Plan.

There were no reserves against contract value for credit risk of the contract issuer as of December 31, 2021. The crediting interest rate was based on a formula agreed upon with the issuer but was not less than zero. Such interest rates are reviewed and reset on a monthly basis. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2022 and 2021, the Plan held GICs in the amount of \$-0- and \$2,586,022, respectively, at contract value.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the near term, and, that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 6 - TAX STATUS

The Company adopted a pre-approved prototype plan offered by the Plan's Custodian. The Internal Revenue Service ("IRS") has determined that the prototype plan, by letter dated June 30, 2020, is designed in accordance with applicable sections of the Internal Revenue Code.

Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position, that more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain officers and employees of the Employer (who may also be participants in the Plan) perform administrative services related to the operation, record-keeping and financial reporting of the Plan. The Employer pays the salaries of these individuals and also pays other administrative expenses on behalf of the Plan. Certain fees, to the extent not paid by the Employer, are paid by the Plan. Administrative fees for the year ended December 31, 2022 were approximately \$14,000.
