### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Parma Community General Hospital 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 17, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to October 17, 2022 and the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from an agent on behalf of a qualified institution as of October 17, 2022 and December 31, 2021 and for the period from January 1, 2022 to October 17, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **(1) Description of Plan**

The following description of the Parma Community General Hospital 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

##### **(a) General**

The Plan is a defined contribution plan established on January 1, 1998, to provide retirement benefits and a means of capital accumulation to all eligible employees of Parma Community General Hospital (the Hospital or the Plan Administrator) and certain employees of its subsidiaries. Employees became eligible to participate in the Plan on the first day of the month following the date of hire, as defined by the Plan and became eligible for the Hospital matching contribution one year subsequent to their date of hire.

Effective January 1, 2015, the Plan was frozen for further participation and contributions. Eligible employees of the Plan became participants of the University Hospitals Health Systems, Inc. 401(k) Retirement Plan. Participant balances remain within the Plan as of December 31, 2021.

The Compensation Committee under the Board of Directors of University Hospitals, as permitted by the plan document, adopted and approved a resolution of merger to transfer the assets of the Plan into the comparable University Hospitals Health System, Inc. benefit plan. The Plan's assets and participant loan receivables were transferred into the University Hospitals Health System, Inc. 401(k) Retirement Savings Plan on October 17, 2022 in the amount of \$58,125,280. This amount included \$57,913,386 in participant's investment accounts as well as \$192,098 in active loans and \$19,796 in participant forfeitures.

##### **(b) Participant Accounts**

Each participant's account were credited with the participant's contribution and allocations of (a) the Hospital's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations of the plan earnings and administrative expenses were based on compensation or account balances, as defined. The benefit to which a participant is entitled was the benefit that can be provided from the participant's vested account.

##### **(c) Vesting**

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Hospital's contribution portion of a participant's account was based on years of credited service. A participant is 100% vested after two years of credited service.

##### **(d) Participant Investment Account Options**

The Plan offered participants the services of an independent investment advisor to manage investments based on individual participant risk profiles. Participants may opt out of this service and direct the investment of all contributions into various investment options offered by the Plan. The Plan offered a variety of mutual funds and an insurance investment contract as investment options for participants.

#### **(e) Forfeited Accounts**

The forfeited balances of terminated participants' nonvested accounts are used to reduce future plan expenses and employer matching contributions. The cumulative balance of forfeitures by participants of nonvested accounts totaled \$0 and \$35,343 at October 17, 2022 and December 31, 2021, respectively.

#### **(f) Notes Receivable from Participants**

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest on outstanding loans were paid ratably through payments from participants directly to the trustee.

#### **(g) Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. A participant may make in-service withdrawals from rollover contributions at any time.

### **(2) Summary of Significant Accounting Policies**

#### **(a) Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### **(b) Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### **(c) Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 5 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fully benefit-responsive investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements for this investment

are prepared on a contract value basis. See note 4 regarding the valuation of the Plan's fully benefit-responsive investment contract; Metlife Growth Plus Account.

#### **(d) Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 17, 2022 or December 31, 2021. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance may be reduced and a benefit payment recorded based on the terms of the plan document. Interest rates on the loans vary between 4.25% and 6.50% with various maturity dates between 2023 and 2033.

#### **(e) Payment of Benefits**

Benefits were recorded when paid.

#### **(f) Administrative Expenses**

Certain expenses of the Plan are paid by the Hospital and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and investment fees paid by participants to manage their accounts are charged directly to the participant's account and are included in administrative expenses. Other investment related expenses are included in net (depreciation) appreciation of fair value of investments.

#### **(g) Cash and Cash Equivalents**

The Plan considers all highly liquid investments with a maturity of three months or less when purchased to be cash equivalents. There were no cash and cash equivalents as of October 17, 2022.

### **(3) Information Prepared and Certified by the Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Metropolitan Life Insurance Company, the recordkeeper of the Plan as agent for Reliance Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and is complete and accurate with respect to investments and notes receivable from participants:

- Investments, at fair value
- Investments in fully benefit-responsive investment contracts, at contract value
- Interest and dividends
- Interest income from participant loans
- Net (depreciation) appreciation in fair value of investments

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

#### **(4) Investment Contract with Insurance Company**

The Plan had a benefit-responsive guaranteed investment contract with Metropolitan Life Insurance Company (Metlife) through the Metlife Growth Plus program. Metlife maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the financial statements at contract value. Contract value, as reported to the Plan by Metlife, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is determined at the sole discretion of the issuer, but may not be less than 3%. Such interest rates are reviewed for resetting on a quarterly basis. The quarterly crediting interest rates and average yields were approximately 3% for each of the period from January 1, 2022 to October 17, 2022 and the year ending December 31, 2021.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Administrator or other Plan Administrator events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit Metlife to terminate the agreement and requires the Plan to settle at an amount different than contract value.

#### **(5) Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable

inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 17, 2022 and December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(6) Related Party and Party-in-Interest Transactions**

Certain Plan investments, including the insurance investment contract, are managed by MetLife, the Plan Administrator, and Reliance Trust Company, the trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments.

Fees paid directly to Metlife, to provide investment advisory services totaling \$143,620 and \$151,334 are included in administrative expenses for the period from January 1, 2022 to October 17, 2022 and the year ended December 31, 2021, respectively. The Plan Administrator pays directly any other fees related to the Plan's operations.

**(7) Plan Termination**

The Plan Administrator has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**(8) Tax Status**

The Plan is a prototype plan sponsored by Metlife. The Internal Revenue Service has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the IRC and informed Metlife of such in a letter dated March 31, 2014. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements under of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 17, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

#### (9) Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
