### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of HOSPITALITY STAFFING 401(K) PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HOSPITALITY STAFFING 401(K) PLAN's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

**PLAN DESCRIPTION**

The following description of the Hospitality Staffing 401(k) Plan (“Plan”) is provided for general information purposes only. Readers of the financial statements should refer to the Plan agreement for more complete information.

1. General - The Plan covers employees of Hospitality Staffing, Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
2. Contributions - In compliance with the Plan agreement, the Company contributes \$0.50 for each dollar contributed by the participant on the first 4% of eligible wages. Employee and employer contributions are accrued and funded with each pay period.
3. Participant Accounts - Each participant’s account is credited with the participant’s contribution and the allocations of (a) the Company’s contributions and (b) individual account earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account. A participant’s beneficiary receives the remainder of the account, if any, upon the death of the participant.
4. Vesting - A participant is 100% vested immediately in all employee contributions. The vesting schedule for the discretionary employer matching contributions is as follows:

<u>Participant’s Years of Vesting Service</u>	<u>Vested Percentage</u>
Less than 2 years .....	0%
2 years but less than 3.....	25%
3 years but less than 4.....	50%
4 years but less than 5.....	75%
5 years or more.....	100%

5. Forfeitures - The portion of the participant’s balance related to the employer matching contribution which is not vested prior to a break in service is available to reduce the funds needed for the employer matching contribution. Forfeited non-vested accounts were used to reduce employer contributions by \$167,358 for 2022 and \$100,652 for 2021. Nonvested funds available to reduce matching contributions and plan expenses were \$1,305 as of December 31, 2022 and \$1,267 as of December 31, 2021.
6. Payment of Benefits - On termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account.
7. Plan Termination - The employer anticipates and believes that the Plan will continue without interruption, but reserves the right to discontinue the Plan at any time. In the event the Plan terminates, each participant shall be fully vested as to the value of his/her separate account.

**NOTE 1—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The accompanying financial statements have been prepared using the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from Plan assets during the reporting period. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

The mutual fund investments are valued at fair value based on their quoted market prices as of December 31, 2022 and 2021. The AUL Fixed Income Fund holds investments in a group annuity contract. The group annuity contract is a fully benefit-responsive investment contract. The group annuity contract is not a stable value fund invested in guaranteed investment contracts. It is backed by AUL's general account that is invested in conservatively managed, well-diversified portfolio consisting predominately of fixed-income investments (bonds, mortgages, and private placement) where the objective is to maximize long-term risk-adjusted returns.

The AUL Fixed Income Fund is valued at contract value. Contract value represents contributions made, plus interest at the contract rate, less withdrawals and administrative expenses. The average yield and crediting interest rates were approximately 3.00% for 2022 and 2021. The crediting interest rate is based on an agreed-upon formula with the issuer, but cannot be less than 3.00% through December 31, 2022.

Market value events may limit the ability of the Plan to invest in the AUL Fixed Fund. Market value events are events or conditions that occur which are outside of the normal operation of the Fund and lead to any Fund disbursements which have or will have a material adverse effect on the operations of the Fund and a financial effect on the investment contract resulting in benefits being paid out at less than contract value.

Such events may include but are not limited to: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

In the normal course of business, such events or conditions would not limit the ability of the Fund to transact at contract value with the participants in the Fund. The Fund is managed to maintain a certain amount of liquidity to provide for the day-to-day liquidity needs of participants as well as the occasional market value event. The Plan Administrator does not believe that the occurrence of any such market value events is probable.

Interest income is recognized when earned and dividends when received. Net appreciation (depreciation) on investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are valued at unpaid balances which approximates fair value. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

ASSET CUSTODIAN FEES AND ADMINISTRATIVE EXPENSES

Generally, asset custodian fees and administrative expenses of the Plan are paid by the Company.

BENEFIT PAYMENTS

Benefit payments to participants are recorded when paid.

**NOTE 2—INVESTMENT PROGRAMS**

The Plan has a custodial agreement with American United Life Insurance Company (AUL) and the assets of the Plan are in funds held by AUL. Participants specify the percentage (in multiples of 5%) of contributions that are to be directed to each available investment fund.

**NOTE 3—FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board Accounting Standards Codification No. 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

*Level 2 Fair Value Measurements*

Level 2 Fair Value Measurements are not applicable to the Plan for 2022 and 2021.

*Level 3 Fair Value Measurements*

Level 3 Fair Value Measurements are not applicable to the Plan for 2022 and 2021.

**NOTE 3—FAIR VALUE MEASUREMENTS (Continued)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4—INFORMATION CERTIFIED BY THE TRUSTEES**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan’s asset custodian, AUL, has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of assets available for benefits as of December 31, 2022 and 2021.
- b. Investment income as shown in the accompanying statements of changes in assets available for benefits for the years ended December 31, 2022 and 2021.
- c. The schedule of assets (held at end of year) as of December 31, 2022, as shown on Schedule H, Line 4(i).

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5—PARTICIPANTS NOTES RECEIVABLE**

Participants may borrow up to the lesser of 50% of their vested equity balance or \$50,000. Repayments of principal and interest are due at least quarterly over the specified loan period (not to exceed five years) through payroll deductions. Loans have a fixed interest rate of 5.00% to 5.50%. The participant loan balance was \$162,458 for 2022 and \$230,225 for 2021.

**NOTE 7—TAX STATUS**

The Plan is a Prototype Standardized 401(k) Plan (“Prototype Plan”) sponsored by American United Life Insurance Company. The Prototype Plan obtained an opinion letter, but not a determination letter, in which the Internal Revenue Service (“IRS”) stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Company has not applied for its own determination letter from the IRS. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement dates.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8—RELATED PARTIES AND PARTIES-IN-INTEREST**

Generally, administrative expenses of the Plan are paid by the Plan sponsor. The Plan’s investments are managed by American United Life Insurance Company (AUL). This Company is considered a party-in-interest. Participant loan issuance fees of \$75 per loan are deducted from proceeds issued to participants.

**NOTE 9—PROHIBITED TRANSACTIONS**

During 2022, the Company failed to transmit participant contributions within the timeframe required by DOL Regulation 2510.3-102 totaling \$103,924. The Company remitted \$103,924 to the Plan in 2022. The Company also remitted participants' lost earnings to the Plan in October 2023.

**NOTE 10—SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 12, 2023, the date which the financial statements were available for issue. Except as disclosed elsewhere, there were no subsequent events which require disclosure.
