Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for 2022 Financial Statements

We have performed an audit of the financial statements of Sovereign Pharmaceuticals, LLC Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion on the 2022 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the 2022 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2022 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Notes to Financial Statements December 31, 2022 and 2021

Note 1: Description of the Plan

The following description of the Sovereign Pharmaceuticals, LLC Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) and profit sharing plan covering substantially all employees of Sovereign Pharmaceuticals, LLC (the Plan Sponsor or the Company), excluding union and leased employees and certain non-resident aliens. Employees are eligible to participate in the Plan immediately after attainment of the age of 18 and once they have completed six months of service. Employees are automatically enrolled in the Plan at a pre-tax deferral rate of 3% of employee compensation on the first day of the month coinciding with or following satisfaction of the eligibility requirements, unless an affirmative election is made to not participate in the Plan. Participants automatic deferrals increases by 1% of employee compensation each year up to a maximum of 10% of total compensation, unless a specific deferral amount is elected by the participant. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was originally adopted as of July 1, 1994 (as restated on January 1, 2020).

On December 28, 2021, the Company adopted a resolution to merge the Plan with the Acella Pharmaceuticals, LLC 401(k) Profit Sharing Plan (Successor Plan), a multiple employer plan, effective December 31, 2022.

Effective December 31, 2021, each participant of the Plan became a participant of the Successor Plan and all participant contributions were directed to the Successor Plan. Certain Plan provisions carried over with the Plan's participants to the Successor Plan, as defined. On January 25, 2022, all assets of the Plan were transferred to the Successor Plan. The Successor Plan and Transamerica Retirement Services assumed all recordkeeping and third party administration duties.

Contributions

Participants may make pre-tax and Roth contributions to the Plan of up to 100% of their annual compensation, as defined in the Plan Document, subject to limitations under the provisions of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also roll over amounts representing distributions from other qualified plans.

The Plan Sponsor is required to make matching contributions equal to 50% of the amount of the participant's elective deferrals that do not exceed 6% of the participant's compensation.

In addition to the matching contributions, the Plan Sponsor may also make a discretionary profit sharing contribution, subject to limitations under the IRC. For the year ended December 31, 2022, the Plan Sponsor did not make a discretionary profit sharing contribution.

Administration

The Plan Sponsor serves as the plan administrator. The plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions which may affect eligibility for benefits.

The Plan Sponsor has engaged Charles Schwab Trust Bank (Custodian) to serve as the Custodian of the Plan. The Custodian receives all contributions made under the Plan, holds plan assets and pays benefits to participants as directed by the plan administrator (see Notes 4 and 6).

Administrative Expenses

Administrative expenses of the Plan are liabilities of the Plan but may be paid by the Company. The expenses include, but are not limited to, legal, accounting, and recordkeeping fees, and investment expenses. For administrative expenses not paid by the Company, the expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense itself.

Participant Accounts

Each participant account is credited with pre-tax, Roth, and rollover contributions made by the participant, the participant's portion of Plan Sponsor matching contributions, discretionary profit sharing contributions, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contribution and rollover balances, and any allocated earnings thereon. Participants become vested in Plan Sponsor matching contributions and discretionary profit sharing contributions in accordance with Plan provisions based upon years of service and become fully vested after four years of service. The vesting percentages are as follows:

Participants also become 100% vested upon termination of the Plan or upon reaching normal retirement age of 65, or early retirement age of 55 with the completion of three years of service with the Company, or upon disability or death while still an employee of the Plan Sponsor.

Investment Options

Participants are required to make participant-directed allocations of their accounts in increments totaling 100% among various investment options selected by the Plan Administrator, including certain options for which the Custodian or their affiliates serve as investment advisor. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Generally, no more than one loan per participant may be outstanding at a time. Notes receivable from participants are secured by participant account balances and bear interest at a rate based on a calculation of prime plus 2% at the time of the note, as determined by the plan administrator. Notes receivable are to be repaid through level payments over a period not to exceed five years unless such loan is for the purchase of a participant's primary residence.

Benefits Paid to Participants

In general, a participant may withdraw up to 100% of the participant's pre-tax and rollover contributions in the event of a participant's heavy and immediate financial hardship, as defined in the Plan Document. Hardship distributions may not exceed the amount of the participant's financial hardship.

In-service withdrawals of all or a portion of a participant's vested account balance, other than participant rollover, employer matching and profit sharing accounts, may be made by a participant after reaching age 59 ½ as defined in the Plan Document.

Participants withdrawing from the Plan due to termination of employment for reasons other than death, disability, or retirement, early retirement, and normal retirement may receive the value of their vested account by transfer to another qualified plan or individual retirement account or through lump sum distribution or partial withdrawal. In general, if a participant's account balance, as defined in the Plan Document, is greater than \$5,000, the account may not be distributed without the participant's consent. Regardless of participant election as to the payment, the Plan may, upon termination of service of a participant for any reason, pay the benefits owed in a lump sum if the account balance is \$5,000 or less.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to Internal Revenue Service (IRS) penalties, unless the distribution is transferred to another qualified plan or individual retirement account.

Forfeitures

Distributions to terminated participants whose accounts are not 100% vested are reduced by forfeiture of the non-vested portion of their accounts. Forfeitures of terminated employees' non-vested accounts may first be used to pay administrative expenses of the Plan. Any remaining forfeitures attributable to amounts other than Plan Sponsor matching contributions will be allocated to participants who are not highly compensated employees in the same proportion that the compensation for each participant who is not a highly compensated employee bears to the total compensation of all participants. Any remaining forfeitures attributable to matching contributions will be used to reduce any Plan Sponsor contributions. There were no forfeitures in 2022. There were no forfeitures available for future use as of December 31, 2022 or 2021.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with the accounting principles generally accepted in the United States of America (US GAAP).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan Document.

Use of Estimates in Financial Statements

The preparation of financial statements in accordance with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payments of Benefits

Benefit payments are recorded when paid by the Plan.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities, including gains and losses, are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant account balances and the amounts reported in the accompanying statements of net assets available for benefits and statement of changes in net assets available for benefits.

Note 3: Fair Value Measurement

The accounting standard for fair value measurements provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in non-active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and maximize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Mutual funds are valued at quoted market prices reported on the active market on which the individual securities are traded. Net appreciation in the fair value of the mutual funds represents the change in fair value during the year, including realized and unrealized gains and losses. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As discussed in Note 1, the Plan was merged into the Successor Plan and all assets of the Plan were transferred to the Successor Plan as of January 25, 2022. The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021:

Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodian, except for comparing such information to information included in the Plan's financial statements and supplemental information:

Note 5: Tax Status

The Plan Sponsor has entered into an adoption agreement under the FIS Business Systems, LLC Volume Submitter Profit Sharing Plan with CODA (the Prototype Plan). The Prototype Plan received a favorable opinion letter from the IRS dated March 31, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note 6: Party-in-Interest Transactions

Charles Schwab Trust Bank and TRI-AD Actuaries, Inc. perform services for, sell products to, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 7: Subsequent Events

The Plan Sponsor has evaluated for subsequent events between December 31, 2022 and the report date, the date the financial statements were available for issuance, and has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.
