## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Management of  
MediQuant-PRO LLC 401(k) Profit Sharing Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of MediQuant-PRO LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of MediQuant-PRO LLC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Merger and Termination***

As discussed in Note 3 to the financial statements, the Company made the decision to terminate the Plan effective December 31, 2022, and merge into a pooled employer plan beginning January 1, 2023, which indicates that the Plan is not a going concern. The accompanying financial statements reflect the transfer of assets and obligations out to the merged plan as of the effective date of termination. Our opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about MediQuant-PRO LLC 401(k) Profit Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of MediQuant-PRO LLC 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about MediQuant-PRO LLC 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2022 AND 2021

#### NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the MediQuant-PRO LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General:*** The Plan was a defined contribution plan covering substantially all full-time employees of MediQuant-PRO LLC (the "Company"). The Plan operated in accordance with Section 401(k) of the Internal Revenue Code. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Eligibility:*** To be eligible to participate in the Plan, an employee must have been 21 years of age or older and have completed 1,000 hours worked in a six-month period. If the service requirement was not met in the first six months, an employee would be eligible once they completed one year of service. Employees whose employment was covered by a collective bargaining agreement or who were leased employees or certain nonresident aliens were not eligible to participate in the Plan. Employees were permitted to enter the Plan on the first day of the quarter coinciding with or following meeting the age and service requirements.

***Contributions:*** Participants were able to make voluntary pre-tax or after-tax (Roth) contributions, by means of a salary deferral agreement, of up to 100% of their compensation, subject to IRS limitations for the Plan year. Plan participants over the age of 50 were also permitted to make additional pre-tax and Roth catch-up contributions up to a maximum of \$6,500 in 2022. The Plan also permitted rollover contributions from other qualified pre-tax retirement plans. Participants directed the investment of contributions into various investment options offered by the Plan.

The Company made nonelective safe-harbor contributions and discretionary profit-sharing contributions. Nonelective safe-harbor contributions were equal to 3% of Plan compensation for all eligible employees, subject to IRS limitations. Nonelective safe-harbor contributions made by the Company totaled \$541,438 for the Plan year ended December 31, 2022. Discretionary profit-sharing contributions, if any, may have been made for each Plan year in an amount determined by the Company and were allocated to each eligible employee who was employed on the last day of the Plan year and had at least 1,000 hours of service during the Plan year. There were no discretionary profit-sharing contributions during 2022.

***Participant accounts:*** Each participant's account was credited with the participant's contribution and an allocation of (a) the Company's contributions, and (b) Plan earnings, and was charged with an allocation of administrative expenses. Allocations were based on participant compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Vesting:** Participants were immediately vested in their voluntary contributions and in the Company’s safe-harbor contributions, plus actual earnings thereon. Vesting in the Company’s discretionary profit-sharing contributions, if any, was based on years of continuous service with the Company. A participant was credited with a year of service when they had completed 1,000 hours of service during the Plan year. As discussed in Note 3, participants became fully vested in all company contributions, effective December 31, 2022, upon termination of the plan.

Participants became fully vested in the Company’s discretionary profit-sharing contributions if they were employed upon reaching the normal retirement age of 65, or upon death or disability while employed.

**Notes receivable from participants:** The Plan allowed participants to obtain loans from the Plan. These loans were subject to the following general provisions: the maximum amount of loans outstanding was equal to the lesser of \$50,000 or 50% of the participant’s account balance with a minimum of \$1,000, the term of any loan may not have exceeded five years unless the purpose of the loan was to purchase the participant’s primary residence, and the loans were secured by the participant’s account and bore interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Interest rates ranged from 3.25% to 6.25%. Principal and interest were paid ratably through payroll deductions.

If a participant did not make loan repayments and the plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

**Payment of benefits:** Upon separation from service, a participant may have elected to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. In the event of death of a participant, the value of the participant’s account was payable to the participant’s beneficiary either in a lump-sum or installments representing required minimum distributions. A terminated participant with an account balance of \$1,000 or less would receive an involuntary cash out distribution. A terminated participant with a vested account balance greater than \$1,000, but less than \$5,000, would be automatically rolled into an IRA in a direct rollover if the participant had not reached the age of 65 and had not made an election to have the vested account paid in a lump sum or rolled into another qualified retirement plan. The Plan permitted in-service withdrawals for participants who had attained age 59½. In the case of hardship, a participant may have applied for a distribution as described in the Plan agreement. A participant may have elected to receive a distribution of their rollover contributions at any time.

**Forfeited accounts:** Forfeitures of discretionary profit-sharing contributions were to be used to reduce employer contributions and pay plan expenses and would be allocated to the participants’ accounts in the same manner as contributions. Forfeited non-vested accounts totaled \$9,820 as of December 31, 2021. There were no forfeited non-vested accounts as of December 31, 2022 and no forfeitures were used to reduce employer contributions during 2022.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of presentation:** The financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Notes receivable from participants:** Notes receivable from participants were recorded at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants were written-off when deemed uncollectible.

**Investment valuation and income recognition:** Plan investments are reported at fair value using methodologies described in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of investments, including gains or losses, are recorded on a trade-date basis. Interest income is recorded when earned, and dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) is included in the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit payments:** Benefit payments to participants are recorded when paid.

**Administrative expenses:** Substantially all administrative expenses were paid by the Plan, unless otherwise paid for by the Company.

**Subsequent events:** In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 11, 2023, the date the financial statements were available to be issued.

## NOTE 3 – PLAN MERGER AND TERMINATION

On September 27, 2022, the Company, as permitted by the Plan document, made the decision to terminate the MediQuant-PRO LLC 401(k) Profit Sharing Plan effective December 31, 2022, and merge into the Aon Pooled Employer Plan beginning January 1, 2023. As a result, the Company initiated a transfer of Plan assets and Plan obligations to participants to the Aon Pooled Employer Plan on December 31, 2022, as reflected in the transfer of plan assets due to merger and termination on the accompanying statement of changes in net assets. The Company discontinued its contributions effective as of the termination date. Under provisions of ERISA, upon termination, all participants became fully vested in their employer contributions. As a result of the merger and termination, the Plan is not a going concern.

#### NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used.

*Mutual funds (Registered Investment Companies):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively-traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

## NOTE 5 – INCOME TAX STATUS

The trust established under the Plan, which held the Plan’s assets, was qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust’s net investment income is exempt from income taxes. The Plan adopted an Internal Revenue Service pre-approved volume submitter plan. The volume submitter plan received a favorable opinion letter from the IRS that it qualifies under IRS Code section 401(a), provided all terms of the Plan are followed. The Plan had been amended since adopting the volume submitter plan. The plan administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code, and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

## NOTE 6 – INFORMATION PREPARED AND CERTIFIED BY THE RECORDKEEPER OF THE PLAN AS AGENT FOR THE TRUSTEE

In accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected to restrict the scope of the auditor’s examination with regard to the statements or information prepared and certified by Ascensus, LLC, the recordkeeper as agent for Ascensus Trust Company, the trustee (“Ascensus”). The following information included in the accompanying financial statements was obtained from data that has been prepared and certified as complete and accurate by Ascensus:

## NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

The Plan issued notes receivable to participants, which were secured by the balances in the participants’ accounts. These transactions qualify as party-in-interest transactions.

## NOTE 8 – RISKS AND UNCERTAINTIES

The participants directed the Plan to invest in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.
