The Board of Directors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Community Health Center, Inc. 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Community Health Center, Inc. 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTE 1 – DESCRIPTION OF PLAN

The following description of Community Health Center, Inc. 403(b) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Community Health Center, Inc. and participating related employers (the Company). All employees of the Company are eligible to make contributions to the Plan on the first day of employment. Employees who have completed one year of eligible service and who normally work at least 20 hours per week are eligible for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan has an auto enroll feature of 6% of participant compensation.

Each year, participants may contribute the maximum amount allowed under the Internal Revenue Code (IRC) of pre-tax and Roth reduction contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from certain other eligible retirement plans as defined in the Plan.

The Company may make discretionary matching and nonelective contributions to participants' accounts. For 2022, the Company elected to make matching contributions to participants' accounts in the amount of 8% of the participants' eligible compensation. There were no nonelective contributions made for 2022. Contributions are limited under current Internal Revenue Code regulations.

Employer contribution receivable

Employer contribution receivable is measured at the amount owed to participants by the Company at December 31, 2022 and 2021.

Participant accounts

Each participant's account is credited with their own salary deferral contributions, their rollover contributions from other plans and the Company's contributions as well as investment earnings (losses) within the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their deferral contributions and their rollover contributions plus actual earnings thereon. Vesting in the Company's contribution portion and net earnings (losses) is based on years of continuous service. Participant vesting is based on a four year graded schedule. A participant is 100% vested after four years of credited service.

Notes received from participants

Participants may receive loans of up to 50% of their vested account balances. Amounts may be borrowed between \$1,000 and \$50,000, utilizing the participant's remaining account balance as security for the loan. The interest rate for any loan shall not be less than the prevailing rate of interest charged on similar commercial loans by persons in the business of lending money and shall be determined by the Plan Administrator. Loans must be repaid within five years unless the loan is used for the purchase of a participant's primary residence, in which case the loan may be repaid under an alternative time frame as determined by the plan administrator. Participants who do not repay their loans under certain circumstances, as defined in the Plan, will be deemed to have received a distribution for federal income tax purposes under the Plan. Payments are made through payroll deductions.

Hardship withdrawals

In the event of financial hardship, as defined under the Plan and under current Internal Revenue Service rules, participants are permitted to receive hardship withdrawals of their own elective deferrals.

Payment of benefits

On separation of service due to death, disability, termination or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In the event of a participant's death or disability before termination of employment and before distribution of benefits has begun, a participant will become 100% vested and the amount of the participant's account balance will be payable in a single lump-sum to the participant's beneficiary(ies).

Participants may withdraw their vested account balances once they reach age 59½. Participants may also rollover their contributions in the Plan at any time and at any age.

Other distribution methods under the Plan are available to beneficiaries depending on vested account balances.

Forfeited accounts

Forfeited non-vested account balances totaling \$382,174 were used to reduce employer contributions during 2022. At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$45,391 and \$210,243, respectively.

Investment options

Participants direct the investment of all contributions within their own accounts into various investment options consisting of mutual funds, multi-funds, a stable value fund and guaranteed interest accounts offered by the Plan through insurance contracts. The following investment options are available for the investment of the participants' elective and employer matching and discretionary contributions: equity funds, foreign, emerging markets and world funds, fixed income funds, multi-funds, a stable value fund and a guaranteed fund.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Plan investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Investment valuation and income recognition, continued

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. The contract value is the relevant measurement since it represents the amount that the participant would receive if they were to initiate permitted withdrawal transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their net unpaid balance as of the Plan's year end. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance will be reserved. Such allowances amounted to \$361,343 and \$297,149 at December 31, 2022 and 2021, respectively. In the event a participant terminates employment while any loan is outstanding, the unpaid balance and any interest due thereon shall become due by the end of the calendar quarter following the quarter in which such payment was due, or the maturity date of the loan, whichever comes first.

Administrative expenses

The plan sponsor pays administrative costs of the Plan which include third party administrator fees and the Plan audit fees. The participants of the Plan are charged fees by the third party administrator for the processing of distributions and loans, quarterly loan maintenance fees and miscellaneous other fees. These fees are deducted from the participants' self-directed accounts.

The Plan incurs general administrative fees for ongoing plan administrative services (e.g., recordkeeping) that range from 0.140% to 0.215% annually of assets held in the Plan investment options. These fees are applied pro rata across some or all investment options held in the plan participants' accounts. However, the administrative fees allocable to an investment option may be paid, in whole or in part, from revenue (e.g., 12b-1 fees, administrative fees) that TransAmerica Retirement Solutions, LLC or its affiliates receive based upon the Plan's investment options.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 or 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Multi-funds: The values of the multi-fund accounts are based on the value of the underlying investments. Net asset value is used as a practical expedient to estimate fair value.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds a portfolio of investment contracts that comprises a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the disaggregation of contract value between types of investment contracts held by the Plan.

For traditional investment contracts, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The following events might limit the ability of the Plan to transact at contract value with the contract issuer:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, the following events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

TransAmerica Retirement Solutions, LLC (TRS) provides investment management, record keeping and other contracted services to the plan sponsor for the Plan. As a provider of services to the Plan, TRS is a party-in-interest as defined under ERISA. TRS receives fees from the sponsor for its services.

Lincoln National Life Insurance Company provides investment management, record keeping and other contracted services to the plan sponsor for census, compliance testing and annual report preparation for the Plan. The plan sponsor pays for its contractual services. Several of the Plan's investments are also managed by Lincoln National Life Insurance Company (see funds indicated with a * on the supplemental schedule of assets (held at end of year)). As a custodian of the Plan, these transactions qualify as party-in-interest transactions.

State Street Bank and Trust Company, the investment custodian of the Plan and a provider of services to the Plan, is a party-in-interest as defined under ERISA. State Street Bank and Trust Company receives fees for its services from the employer.

Notes receivable from participants totaled \$1,430,696 and \$1,054,470 at December 31, 2022 and 2021, respectively and interest income on notes receivable from participants totaled \$62,572 for the year ended December 31, 2022.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 – PLAN TERMINATION AND AMENDMENTS

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their total account balances. There were no Plan amendments during this period.

NOTE 8 – TAX STATUS

Management believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Effective November 1, 2014, management adopted the Volume Submitter 403(b) Plan document of TransAmerica Retirement Solutions, LLC under a restatement of the Plan which was initially effective July 1, 1991. The Volume Submitter 403(b) Plan document was restated January 1, 2010 and the Plan has adopted the restated Plan document on April 2, 2019 as required by IRS regulation. The Volume Submitter 403(b) Plan document has been approved by the Internal Revenue Service under their determination letter dated March 31, 2017.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 – RISKS AND UNCERTAINTIES

Investments and market conditions

The Plan participants invest in various investment options offered by the Plan. Investment options offered in the Plan are subject to various risks, such as interest rate, market value and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics, international conflicts or financial institution collapses. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

Effective January 1, 2023, the Plan was amended to change the Plan name from Community Health Center, Inc. 403(b) Retirement Plan to Moses/Weitzman Health System, Inc. 403(b) Retirement Plan.
