### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Ruby Receptionists 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2022 AND 2021**

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Ruby Receptionists 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution 401(k) plan covering substantially all employees of Ruby Receptionists, Inc. (the Company) who have met certain age requirements and have completed the service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Transfer to Other Plan** - On October 31, 2022, MAP Communications Holdings, Inc., a corporation organized under the laws of the State of Delaware, acquired all of the issued and outstanding stock of the Company. As a result, the Plan was amended effective December 31, 2022 to merge the Plan into the MAP Communications Holdings, Inc. 401(k) Employees' Stock Ownership Plan (the MAP Plan). All assets were transferred into the custodial accounts of the MAP Plan at Principal Life Insurance Company on March 2, 2023.

**Plan Amendments** - Effective January 1, 2022, the Plan was restated through an adoption of a non-standardized defined contribution pre-approved plan document sponsored by Standard Retirement Services Inc. The Plan provisions are substantially unchanged by this restatement.

**Contributions** - Contributions consist of employee elective deferrals, qualified matching contributions, and discretionary employer matching contributions. Participants may voluntarily contribute up to 100% of their eligible compensation, limited to \$20,500 and \$19,500 in 2022 and 2021, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and older may elect to make additional catch-up contributions. The Plan requires qualified matching contributions of 100% of the first 4% contributed by participants. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company can also make discretionary employer contributions. The Company did not make any discretionary employer contributions in 2022 or 2021. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically entered in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Contributions are subject to certain limitations.

**Participant Accounts** - A separate account is maintained for each participant, which is credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings and expenses. Allocation of investment earnings and expenses is based upon participant account balances. Allocation of Company matching contributions is based on elective deferrals and eligible participant compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in all contributions and actual earnings thereon.

**Payment of Benefits** - Upon the earlier of a participant's termination of employment, death or retirement, the participant or beneficiary may elect to receive distributions of vested benefits in a lump-sum or in monthly installments over a period not to exceed the life expectancy of the participant. In the case of financial hardship, contributions may be withdrawn prior to normal retirement. Account balances that are under \$1,000 may be automatically paid out at the discretion of the Company. Balances between \$1,000 and \$5,000 may be transferred to an IRA, also at the discretion of the Company

**Expenses** - Administrative expenses may be paid by the Company. Expenses not paid by the Company are deducted from investment earnings before allocation to participants' accounts. Expenses of Plan administration, including computer services, professional fees, office supplies and payroll expenses of administrative and clerical personnel are provided by the Company without charge to the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment Valuation and Income Recognition** - Investments are stated at fair value except for the benefit-responsive investment contract, which is carried at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year, and management and operating expenses associated with the Plan's investments.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2022 or 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons who have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. There were no amounts payable to participants at December 31, 2022 and 2021.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Subsequent Events** - The Plan's management has performed an evaluation of subsequent events through October 11, 2023, which is the date these financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

#### **Basis of Fair Value Measurement**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Pooled separate accounts (PSA):* The Plan held a group annuity contract issued by Standard Insurance Company. The contract allows the Plan to participate in pooled separate accounts, which hold underlying investments. The PSAs invest in a single mutual fund, or in a portfolio of securities. The PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities). While the majority of the PSAs' underlying asset values are based on quoted prices, the net asset value (NAV) of the PSA is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices and is used as a practical expedient to estimate fair value. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV. The Plan is permitted to redeem investment units at NAV on the measurement date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 4 – GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE COMPANY**

The Plan has entered into a traditional fully benefit-responsive, group annuity contract with Standard Insurance Company (the Insurer). The Insurer maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of a contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Contract value is the relevant measurement attributable for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by the Insurer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The Plan's ability to receive amounts due is dependent on the Insurer's ability to meet its financial obligations. The Insurer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include, but are not limited to layoffs, Plan termination, business closings, re-organizations, liquidations, and the failure of the Plan to qualify under Section 401(a) or Section 401(k) of the IRC. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) unsecured violations of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment of the agreement without the consent of the issuer.

The group annuity contract does not permit the Insurer to terminate the agreement prior to the scheduled maturity date. The average yield earned based on the change in the net asset value between the beginning and the end of the period was 1.85% and 1.63% for the years ended December 31, 2022 and 2021, respectively. The average yield earned with an adjustment to reflect the actual interest rate credited to participants was 1.85% and 1.63% for the years ended December 31, 2022 and 2021, respectively.

#### **NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS**

The Plan makes loans to participants up to the lesser of 50% of their vested account balance or \$50,000 subject to a \$1,000 minimum. Loans are payable within five years through semi-monthly payroll deductions, unless the loan is used to acquire a primary residence. Interest is charged based on a reasonable rate of interest as determined by the Plan administrator. Loans are secured by the vested account balance of the participant.

#### **NOTE 6 – INFORMATION CERTIFIED BY CUSTODIAN OF THE PLAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, interest income on notes receivable from participants and interest and dividends for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the custodian of the Plan, Standard Insurance Company, as of and for the years ended December 31, 2022 and 2021.

#### **NOTE 7 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments were managed by Standard Insurance Company. Standard Insurance Company is the custodian of the Plan; therefore, these transactions are party-in-interest transactions under ERISA. Fees for investment management services charged by the custodian are netted against Plan earnings. Fees for investment management services charged by the custodian ranged from 0.12% to 0.37% annually.

#### **NOTE 8 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Upon termination, the Company may continue the Plan to pay benefits as they mature or liquidate and distribute the relevant portion of the Plan to a successor defined contribution plan, or in the absence of a successor plan, to the participants. Net assets transferred or distributed shall be allocated to the participants in proportion to their interests.

## NOTE 9 – CONCENTRATIONS, RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. There were no investments that individually represented more than 10% of the investments held as of the year ended December 31, 2022. There were three investments that individually represented more than 10% of the investments held as of the year ended December 31, 2021. See the supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

## NOTE 10 – INCOME TAX STATUS

The Plan document, a non-standardized defined contribution pre-approved plan sponsored by Standard Retirement Services, Inc. obtained an opinion letter dated June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress.

These transactions constitute prohibited transactions as defined by ERISA. The Company is in the process of taking the appropriate steps to fully correct these occurrences.


