Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of Summit Behavioral Services 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2022 and 2021

Note 1: Description of the Plan

The following description of Summit Behavioral Services, LLC 401(K) Plan, (the Plan) provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Summit Behavioral Services, LLC, (the Company). Employees are eligible to participate after two months of service. Employees are eligible for non-elective discretionary match after achieving 1,000 hours and must be employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger:

Effective January 1, 2023, the Plan merged into the Securian Pooled Employer Plan and Trust, which is a multiple employer plan. Participant and employer contributions were directed to the Securian plan beginning on this date. The amount of the transfer to the Securian Plan included the following:

Employee Contributions

Participating employees may elect to contribute a percentage of their annual compensation not to exceed IRS limits, as defined in the Plan document, to the Plan on a tax-deferred basis or after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers money market and mutual funds as investment options for participants. The Plan also offers target date fund choices which are pre-determined allocations of the available mutual funds.

The Plan may accept a proper rollover from another qualified plan.

Employer Contributions

The Company may make a discretionary match contribution equal to a uniform percentage of the employee's salary, which percentage is determined annually at the discretion of the Company's Board of Directors. During 2022 and 2021 the Company contributed 4% and 1% for discretionary match contributions, respectively.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution, any employer discretionary profit-sharing contribution and plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The Plan provides vesting in the employer's discretionary contributions of 20% after one year of service, 40% after two years of service, 60% after three years of service, 80% after four years of service, and 100% after five years of service. An employee who becomes disabled, dies, or reaches age 65 will become 100% vested in employer's contributions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, the participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For an account balance greater than \$1,000, the participant must authorize the benefit payment distribution. In-service withdrawals are not permitted. Hardship distributions are permitted from pre-tax or after tax deferral accounts.

Forfeitures

At December 31, 2022 and 2021, forfeited, nonvested accounts totaled \$0 and \$491, respectively. Forfeitures during 2022 and 2021 were \$1,000 and \$520, respectively. These accounts will be used to reduce employer contributions the following year. In 2022 and 2021, employer contributions were reduced by \$0 and \$0, respectively, from forfeited, nonvested accounts.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Other expenses are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

Participant Loans

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest at a rate determined by the Plan Administrator. Loan repayments are made ratably through payroll deductions. Generally, the loan term may not exceed five years. . For the year ending December 31, 2022 interest rates on outstanding loans were 8.25%.

At the end of each year there were no loans in default.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2022 and 2021, the Plan had no pending distributions of participants requesting distribution but not receiving it until the subsequent year.

Investment Valuation and Income Recognition

The Plan's investments are presented as determined and certified by Nationwide Trust Company, FSB and Nationwide Life Insurance Company (the Custodians) as of the Plan year end. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Investments in common stocks, corporate bonds, and publicly traded limited partnerships are valued at the closing price reported on the active market on which the individual securities are traded. Investments in unit investment trusts are valued at the closing price of the underlying assets. Net appreciation consists of both realized and unrealized appreciation (depreciation) on investments bought and sold as well as held by the Plan during the year.

Investment contracts are reported at contract market value. Contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined-contributions plan attributable to fully benefit-responsive investment contracts.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

See Note 3 for further documentation on fair value.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2022. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds, Real Estate Mutual Funds, Money Market Funds

Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Related Parties and Parties in Interest

The Company absorbs some administrative expenses of the Plan, the cost of audit fees related to the Plan, and the cost of fidelity bonds. The Company provides administrative services on behalf of the Plan. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements. Also, certain Plan investments are shares of proprietary funds managed by the Custodians (or its affiliates). These transactions qualify as exempt party-in-interest transactions.

Administrative functions are performed by officers or employees of the Company. Additional party-in interest transactions include audit fees paid to Varney & Associates, CPAs, LLC, and investment fees paid to the Custodians. These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

The Company may elect to terminate the Plan subject to the provisions of ERISA. In the event of termination, each participant will have non-forfeitable interest in his/her entire individual account. As discussed in Note 1 - Plan Merger, the Company has merged this Plan into another Plan as of January 1, 2023.

Note 6: Tax Status

The Company adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated March 31, 2014, on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2019.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

As a result of worldwide incidents, there has been heightened market risk and volatility associated with the pandemic and this could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits. Because of the uncertainty of the markets during this time, Plan management is unable to estimate the total impact these events may have.

Plan investments were in the custody of Nationwide Trust Company (the Custodian).

Note 10: Investment Contracts

Participants in the Plan have the option to invest in the Nationwide Fixed Select Fund, a guaranteed investment contract. The account earns a declared interest rate for new deposits in each calendar quarter. Interest rate guarantees of the account are backed by assets held by the Nationwide Life Insurance Company's general account. Credited rates are set based on yields earned for the general account for new deposits each quarter. The contract value of these funds reflects the relationship between credited rates earned by funds held in the account and current market rates.

This guaranteed investment contract is fully benefit responsive insofar as the contract does not restrict participant-directed exchanges.

Note 11: Subsequent Events

The Plan Administrator has evaluated subsequent events through October 10, 2023, the date on which the financial statements were available to be issued.
