### (1) Description of plan

The following description of the AllyAlign Health, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan was a defined contribution plan which was adopted on January 1, 2017, to provide retirement benefits for employees of AllyAlign Health, Inc. and related entities as defined in the plan document (the "Plan Sponsor" or "Company"). The Plan covered substantially all employees who were age 18 or older ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In May of 2022, the Plan Sponsor merged into Curana Health, LLC. As part of the merger, the Plan Sponsor approved the transfer of assets from the Plan to the Curana Health, LLC 401(k) Plan (the "Curana Plan"). On July 29, 2022 the net assets transferred were recognized in the participants' accounts of the Curana Plan as previously carried in the accounts of the Plan.

#### (b) Contributions

Participants could voluntarily make qualified retirement contributions to the Plan which were deductible for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or could be made after-tax in the form of a Roth contribution. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The Plan Sponsor could make a matching contribution based on each participant's contribution percentage. Matching contributions were discretionary as determined by the Company's board of directors. No matching contribution was made by the Plan Sponsor during 2022 or 2021.

The Plan also provided that the Plan Sponsor could have contributed each year a discretionary amount authorized by the Company's board of directors; however, an annual contribution by the Plan Sponsor was not required. No annual contribution was made by the Plan Sponsor during 2022 or 2021.

Plan Sponsor and participant contributions could not have exceeded the maximum amount allowable for federal income tax purposes.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's and Plan Sponsor contributions, if applicable, and allocations of investment earnings (losses), and administrative expenses. Allocations were based on participant's compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their elective salary deferral plus actual earnings (losses) thereon and Plan Sponsor contributions.

(e) Payment of benefits

On termination of service due to permanent disability, retirement, or reasons other than death a participant could receive a lump-sum payment equal to his or her entire account. For termination of service due to death, a participant's beneficiary could elect to receive a lump-sum payment or annual installments to be completed within five years of the deceased participant's account balance.

(f) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(g) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of participant benefit payments were charged directly to the participants' accounts and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments were stated at fair value (except for the fully benefit-responsive investment contract, which was reported at contract value, see Note 5) as reported by Voya Retirement Insurance and Annuity Company ("Voya"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits were recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between Saturday, December 31, 2022 and October 11, 2023, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments reported and disclosed in the accompanying financial statements, including the fair value and contract value of investments held at July 29, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments and interest and dividend income for the period ended July 29, 2022, and for the year ended December 31, 2021 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya.

(4) Investments measured at net asset value using the practical expedient

The Plan's pooled separate accounts were measured at net asset value ("NAV") as a practical expedient to estimate fair value, and therefore, were not classified in the fair value hierarchy. The NAV was based on the market value of the underlying investments held by the pooled separate account at year end. This practical expedient would not be used if it was determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiated a full redemption of the pooled separate accounts, the issuer reserved the right to temporarily delay withdrawal from the pool in order to ensure that securities liquidations would be carried out in an orderly business manner.

The following table summarizes investments for which fair value was measured using NAV practical expedient as of Friday, July 29, 2022 and December 31, 2021. There were no participant redemption restrictions for these investments.

The Plan held various pooled separate accounts that were not direct filing entities. These pooled separate accounts had investment strategies that included: various target date and lifestyle funds, international and sector funds, equity and income funds.

(5) Investment contract with insurance company

During 2022 and 2021, the Plan maintained a Guaranteed Investment Contract ("GIC") related investment option with Voya, the Voya Fixed Account. The contract underlying this investment option was considered to be fully benefit-responsive. As of December 31, 2021, the contract value of the investment in the Voya Fixed Account was \$162,194.

Voya determined that credited interest rates reflected a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of the invested assets. A market value adjustment could have been applied to amounts withdrawn at the request of the contract holder.

The underlying contract had no restrictions on the use of Plan assets and there were no valuation reserves recorded to adjust contract amounts. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that caused a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator did not believe that any events which would limit the Plan's ability to transact at contract value with participants were probable of occurring.

### (6) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan itself had not received a determination letter. The pre-approved plan had been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan was designed and had been operating in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan had taken an uncertain position that more likely than not would not have been sustained upon examination by the IRS. The plan administrator had analyzed the tax positions taken by the Plan, and had concluded that as of July 29, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would have required recognition of a liability or asset or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

### (7) Related party and party-in-interest transactions

The Plan's investments were managed by Voya and, therefore, those transactions qualified as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers which also qualify as party-in-interest transactions.
