Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Athlon Sports Communications, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 (in liquidation) and 2021 (ongoing), and the related statement of changes in net assets available for benefits for the year ended December 31, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ABC Company Employee Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 (in liquidation) and 2021 (ongoing), and for the year ended December 31, 2022 (in liquidation), stating that the certified investment information, as described in Note B to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America applied on the basis described in the Emphasis of Matter paragraph.



- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note C to the financial statements, the governing body of the Plan approved a plan of liquidation on December 16, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

DECEMBER 31, 2022 AND 2021

A. DESCRIPTION OF PLAN AND SUMMARY OF ACCOUNTING POLICIES

The following description of the Athlon Sports Communications, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan and Trust Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan maintained under Section 401(k) of the Internal Revenue Code and covers all eligible employees of Athlon Sports Communications (the “Company”) who have reached the age of 21 and have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting and are presented in accordance with the reporting guidelines recommended in *Audits of Employee Benefit Plans*, an industry audit guide of the American Institute of Certified Public Accountants.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation (maximum of \$20,500 for 2022; for individuals aged 50 or over an additional catch-up contribution up to \$6,500 for 2022 is permitted), as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Athlon Sports Communications, Inc., at its discretion, may make a matching contribution equal to a percentage of each participant’s elective deferral contributions. For 2022, a matching contribution of 50% of a participant’s contribution, up to 6% of total salary, with an annual maximum of \$2,000 was made by the Company.

The Company may, in its sole discretion, make a profit-sharing contribution to the Plan on an eligible participants behalf. Participants will be eligible to receive an allocation if you have completed at least 1,000 hours of service during the Plan year and are employed by the Company on the last day of the Plan year.

Profit-sharing contributions will be allocated to the profit-sharing contribution accounts of each participant eligible to share in such allocations after the end of the Plan year. Such contributions will be allocated to the profit-sharing contribution account of each participant eligible in pro rata shares.

Participant Accounts

Each participant's account is credited with the participant's contributions, any employer matching contributions, and an allocation of (a) the Company's discretionary profit sharing contributions, (b) Plan earnings and (c) administrative expenses. Plan earnings are allocated on a pro rata basis for each participant.

Vesting

Participants are immediately vested in their accounts to the extent of deferrals, catch-up contributions, rollover contributions, plus actual earnings thereon. Vesting in employer contributions is based on years of continuous service as follows:

Years of Service	Percentage
Less than two years	0%
Two years, but less than three	20%
Three years, but less than four	40%
Four years, but less than five	60%
Five years, but less than six	80%
Six or more years	100%

Participants become 100% vested if termination occurs as a result of death, disability, retirement or plan termination.

Payment of Benefits

On retirement, death, disability, or termination of service, participants receive payment of their individual vested account balances based on options as defined in the Plan and Trust Agreement.

In-service Withdrawals

Participants who are still employed may receive distributions from all or any portion of their vested account balances upon attainment of age 65. Transfer contributions and rollover contributions may be withdrawn at any time.

Hardship Withdrawals

The Plan permits distributions in the event of a hardship, as defined in the Plan document. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½, unless certain exceptions apply. Hardship withdrawals are limited to the participant's vested account balance.

Notes Receivable from Participants

Participants who have exceeded 5 years of participation in the Plan may borrow funds under the Plan in accordance with their contracts with the investment vendors. Such loans are directly with the investment vendors and not from Plan assets. Generally, a participant may borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the investment vendors. Defaults on loans will reduce a participant's nonforfeitable accrued benefit by the amount in default (plus accrued interest). The participant pays principal and interest through payroll deduction over a period not to exceed five (5) years.

Investment Valuation and Income Recognition

Investments are reported at fair value as reported and certified by the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

Assets and liabilities recorded at fair value in the statements of net assets available for benefits are categorized based on the level of judgment associated with the inputs used to measure their fair value. Level inputs, as defined by ASC 820, *Fair Value Measurements and Disclosures*, are as follows:

Level 1 - Values are unadjusted quoted prices for identical assets or liabilities in active markets accessible at the measurement date.

Level 2 - Inputs include quoted prices for similar assets or liabilities in active markets, quoted prices from those willing to trade in markets that are not active, or other inputs that are observable or can be corroborated by market data for the term of the instrument. Such inputs include market interest rates and volatilities, spreads and yield curves.

Level 3 - Certain inputs are unobservable (supported by little or no market activity) and significant to the fair value measurement. Unobservable inputs reflect the best estimate of what hypothetical market participants would use to determine a transaction price for the asset or liability at the reporting date.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Administrative Expenses

Certain Plan administrative expenses are paid from the assets of the Plan and may be allocated equally to the participants' accounts. The Company pays the third-party administrative fees and any fees related to amendments or Plan changes.

C. PLAN TERMINATION

On December 16, 2022, Athlon Sports Communications, Inc., entered into a merger agreement under which the Athena Group Holdings, Inc., acquired the Company effective March 1, 2023. As a result, the Athlon Sports Communications, Inc. 401(k) Plan was terminated on February 28, 2023, the day prior to the closing of the transaction. In conjunction with the termination of the Plan. Participants were given notice of the plan termination and were notified their assets would be transfer into a qualified 401k plan.

D. TAX STATUS

The Plan is a prototype plan on which the Internal Revenue Service (“IRS”) issued a determination letter dated June 30, 2020. As an adopter of a standardized prototype plan, no individual determination letter is available. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

E. FORFEITURES

Forfeited non-vested accounts in a plan year are used to pay plan expenses and then to reduce future employer matching contributions to the Plan.

F. RELATED PARTY TRANSACTIONS

Plan investments are managed by Ascensus Trust Company at December 31, 2022 and 2021. Ascensus Trust Company is the custodian of the Plan at December 31, 2022 and 2021, and therefore, these transactions qualify as party-in-interest under ERISA.
