## **Independent Auditor's Report**

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Turner Medical, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Turner Medical, Inc. 401(k) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General* – The Plan Sponsor, Turner Medical, Inc. (Company), established the Plan effective as of August 1, 1991. The Plan, as amended, is a defined contribution plan covering all non-leased and non-union employees of the Company who are age eighteen or older and who have six months of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Plan Merger* – Effective November 17, 2022, Plan Turner Medical, Inc. 401(k) Retirement Plan (“Plan”) approved the merger of this Plan into the Mercer Wise Pooled Employer Plan with Mercer Investments LLC. As a result, all assets were transferred from the Plan into a new plan in January 2023.

*Contributions* – Participants may make salary – deferred contributions to the Plan up to 100% of their annual compensation, not to exceed the annual limits imposed by the Internal Revenue Service (IRS). Participants may elect to make all pre-tax deferrals, all Roth deferrals, or a combination of deferrals each pay period. Contributions from employees are recorded and remitted in the period in which the Company makes the deductions from the participants’ payroll. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds as investment options for participants. The Company may make matching contributions to the Plan equal to a discretionary percentage, to be determined by the Company, of the participant’s elective deferrals. During the year ended December 31, 2022, the Company contributed a discretionary matching contribution of 100% of the first 4% of eligible compensation that a participant contributes to the Plan. For the year ended December 31, 2022, \$444,202 in discretionary matching contributions were made by the Company. The Company may also make discretionary profit sharing contributions to the Plan, to be determined by the Company. For the year ended December 31, 2022, there were no discretionary profit sharing contributions.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions and Company matching & profit sharing contributions (if any), as well as allocations of Plan earnings, and is charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching and profit sharing contribution portion of participant accounts is based on years of service, as defined. For discretionary matching contributions, a participant is 100% vested after three years of credited service. For discretionary profit sharing contributions, a participant is 100% vested after five years of credited service.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or one-half of their vested account balance. The notes receivable from participants are secured by the balance in the participant’s account and bear interest at a rate of prime plus 1%. The maximum number of Plan loans that a participant may have outstanding at any one time is one. Note terms may generally not exceed 5 years unless the loan is for purchase of a principal residence.

*Payment of Benefits* – On termination of service due to death, disability, retirement or other reasons, a participant with a vested balance equal to or less than \$5,000 may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. A participant with a vested balance exceeding \$5,000 may elect to receive a lump-sum distribution, direct rollover, or partial withdrawals or installments but only with respect to minimum required distributions over a period of not more than the participants assumed life expectancy. In addition, distributions to participants on account of financial hardship may be made in certain circumstances limited under the terms of the Plan.

*Forfeitures* – The nonvested portion of a terminated employee’s account balance shall be forfeited. Forfeitures may be used to pay plan expense or to reduce amounts otherwise required to be contributed to the Plan. At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$5,291 and \$726, respectively. Also, during the year ended December 31, 2022, \$5,503 of forfeitures were used to pay recordkeeping expenses of the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual method of accounting.

*Use of Estimates* – The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2022 or 2021.

*Payments of Benefits* – Benefits are recorded when paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

*Subsequent Events* – In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through the date of the auditor's report, which was the date the financial statements were available to be issued.

**NOTE 3 – INFORMATION CERTIFIED AND PROVIDED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Newport Trust Company, the trustee and custodian, except for comparing such information certified by the trustee and custodian to information included in the Plan's financial statements and supplemental schedule. All of the investments, net depreciation in fair value of investments, dividend and interest income, schedule of assets (held at year end) and notes receivable from participants and related income in this Plan were certified by Newport Trust Company as of December 31, 2022 and 2021. During 2022, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) depreciated in value by \$829,760. During 2022, the Plan's notes receivable earned interest of \$13,114.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurement and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices

in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2022 and 2021.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan, other than the GLSA mutual funds, are deemed to be actively traded. The GLSA mutual funds are funds that invest in actively traded underlying investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

During 2022, certain Plan investments were shares of mutual funds held by G.L. Smith & Associates, Inc. As defined by the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment advisory and management fees to G.L.S & Associates, Inc. totaled \$39,157 for the year ending December 31, 2022. Certain Plan investments are managed by Newport Group, Inc. Newport Group, Inc. is the recordkeeper and Newport Trust Company is the trustee for the Plan. Therefore, these transactions qualify as party in interest transactions. Fees paid for administrative services to Newport Group, Inc. totaled \$32,475 for the year ending December 31, 2022.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and the Employer will direct the distribution of accounts in a manner permitted by the Plan as soon as practicable.

**NOTE 7 – TAX STATUS**

The Plan has adopted a volume submitter plan sponsored by Newport Trust Company. The volume submitter plan provider has received an advisory letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter

plan received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal, state or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 – DISTRIBUTIONS PAYABLE**

At December 31, 2022 and 2021, net assets available for benefits included \$-0- and \$-0-, respectively, for distributions to participants who have withdrawn from the Plan prior to the end of the Plan year.
