INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Those Charged with Governance
Munro & Company, Inc. Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Munro & Company, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 17, 2023 (in liquidation), December 31, 2022 (in liquidation) and 2021 (going concern basis), the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2022 through March 17, 2023, and the year ended December 31, 2022, and the related notes to the financial statements (2023 and 2022 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, as of March 17, 2023, December 31, 2022 and 2021, and for the period from January 1, 2023 through March 17, 2023, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter – Plan Termination and Liquidation Basis

As discussed in Note 1 to the financial statements, the Board of Directors of Munro & Company, Inc., the Plan's sponsor, voted in March 2022 to terminate the Plan effective December 31, 2022, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 and 2023 financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Information Required by ERISA

The supplemental information, schedule of assets (held at end of year) as of December 31, 2022, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The supplemental information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

NOTES TO FINANCIAL STATEMENTS

March 17, 2023, December 31, 2022 and 2021

Note 1 – Description of the Plan

Munro & Company, Inc. (the Employer) sponsored the Munro & Company, Inc. Retirement Savings Plan (the Plan). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established for the benefit of the Employer's employees, except for collectively bargained employees and nonresident aliens. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

A member of the Employer's management served as the Plan's limited trustee and was responsible for the oversight of the Plan. Ascensus Trust Company (the Trustee) served as the trustee of the Plan and held the Plan assets. The Vanguard Group, Inc., with Ascensus, LLC retained as a subcontractor to provide services, processed and maintained the records of the participant data.

Effective December 31, 2022, the Plan was terminated and liquidation was deemed imminent. All Plan assets were liquidated and benefits were paid to participants prior to March 17, 2023.

Eligibility

Nonexcluded employees who had reached 18 years of age and had completed two consecutive months of service were eligible to participate in the Plan. Participants were automatically enrolled in the Plan on the first day of the month after satisfying eligibility requirements. Participants were eligible for Employer matching contributions after one year of service, as defined in the Plan document.

Contributions

Participants could contribute up to 50% of their compensation, as defined in the Plan document, as either pretax or Roth deferrals. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans.

Eligible employees were automatically enrolled in the Plan with a 2% deferral rate. Eligible employees who did not wish to participate in the Plan could affirmatively elect to opt out, or they could elect a different deferral percentage.

The Plan also provided for discretionary Employer matching contributions. Employer matching contributions were based on deferrals made each payroll period. No discretionary Employer matching contributions were made for the year ended December 31, 2022, or for the period from January 1, 2023 through March 17, 2023.

Participants could direct the investment of their contributions into various investment options offered by the Plan. Contributions were subject to certain limitations of the Internal Revenue Code (the Code).

Participant accounts

Each participant's account was credited with participant contributions, Employer matching contributions, and allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

As a result of the decision to terminate the Plan during 2022, all participants became fully vested in their account balances.

Notes receivable from participants

Participants could borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the preceding 12-month period, or 50% of their vested account balance, reduced by the current outstanding loan balance, if any. The loans were secured by the balance in the participant's account, which interest rates were based on prime rate plus 1% on the date of origination. Participants could only have one loan outstanding at any given time. Terms ranged from one to five years or up to a reasonable time for the purchase of a primary residence. Principal and interest was paid ratably through payroll deductions.

Payment of benefits

Upon retirement, termination, disability, or death, a participant, or his or her beneficiary in the event of death, could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants could take in-service distributions upon reaching age 59½. Upon termination, automatic distributions were required for balances of less than \$5,000. Automatic distributions above \$1,000 made without the participant's consent were rolled into an individual retirement account designated by the Trustee.

Forfeitures

Forfeitures were first used to restore participant balances previously forfeited, then could be used to pay Plan administrative expenses, or to reduce Employer contributions. The Plan had \$0 in unallocated forfeitures as of March 17, 2023, and December 31, 2022, and \$11,019 in unallocated forfeitures as of December 31, 2021. For the period from January 1, 2023 through March 17, 2023, there were no forfeitures used to pay Plan administrative expenses. For the year ended December 31, 2022, forfeitures in the amount of \$17,403 were used to pay Plan administrative expenses.

Administrative expenses

The Plan allowed certain administrative expenses to be paid from Plan assets. Investment expenses netted against investment income represent amounts associated with the net expense ratios of the investments in the Plan's fund lineup. The Plan participated in an agreement with the Trustee, where excess revenue may be returned and deposited into an unallocated administrative fee credit account. The amounts in the unallocated administrative fee credit account could be used to pay reasonable and necessary Plan expenses or could be allocated to participants. As of March 17, 2023, and December 31, 2022, there were no unallocated funds in the administrative fee credit account. During the period from January 1, 2023 through March 17, 2023, there were no administrative fee credits used. As of December 31, 2021, there were \$83 of unallocated funds in the administrative fee credit account. During the year ended December 31, 2022, the Plan used \$801 from the administrative fee credit account to pay certain Plan expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

Due to the decision to terminate the Plan effective December 31, 2022, the financial statements for the period from January 1, 2022 through December 31, 2022, and January 1, 2023 through March 17, 2023, were prepared using the liquidation basis of accounting. The 2021 financial statements were prepared as a going concern on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements and Note 6 for contract value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the liquidation basis for the period from January 1, 2023 through March 17, 2023, and the year ended December 31, 2022. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold during the period from January 1, 2023 through March 17, 2023, and the year ended December 31, 2022.

Notes receivable from participants

Notes receivable from participants as of December 31, 2022 and 2021, were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. No allowance for credit losses was recorded as of March 17, 2023, December 31, 2022 and 2021. During the period from January 1, 2023 through March 17, 2023, and the year ended December 31, 2022, delinquent notes receivable from participants were recorded as a distribution based upon the terms of the Plan document.

Payment of benefits

Benefit payments were recorded when paid. There were no benefits requested before year-end that were not paid.

Subsequent events

The Plan administrator has evaluated subsequent events through October 12, 2023, the date the financial statements were available to be issued.

Note 3 – Information Certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under

ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental information is complete and accurate:

- Investments, fully benefit responsive investment contract, and notes receivable from participants as shown on the statements of net assets available for benefits as of March 17, 2023, December 31, 2022 and 2021;
- Net investment activity and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period from January 1, 2023 through March 17, 2023, and for the year ended December 31, 2022;
- Investment information included in the footnotes as of March 17, 2023, and December 31, 2022 and 2021, and on the supplemental schedule of assets (held at end of year) as of December 31, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental information.

Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of March 17, 2023, December 31, 2022 and 2021. During the period from January 1, 2023 through March 17, 2023, and year ended December 31, 2022, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodologies used for assets measured at fair value:

Collective investment trusts – Stated at fair value as determined by the issuer of the collective investment trusts based on the fair market value of the underlying investments, which is valued at the net asset value (NAV) of units of the collective investment trusts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Mutual funds – Valued at quoted market prices, which represent the NAV of shares held by the Plan at year-end.

Guaranteed Investment Contract – The guaranteed investment contract provides for a fixed return on principal. The guaranteed investment contract is stated at fair value as determined by the issues by discounting the related cashflows based on current yields of similar instruments. The crediting interest note is based on a formula agreed upon with the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of March 17, 2023, there were no assets held by the Plan. Investments measured at fair value on a recurring basis consisted of the following types of instruments as of December 31:

The Plan held a traditional guaranteed investment contract issued by Metropolitan Life Insurance Company (MetLife). This contract met the fully benefit responsive investment contract criteria, and therefore, is reported at contract value as of December 31, 2021. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

MetLife was contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate was based on a formula established by MetLife but may not be less than 0%. The crediting rate was reviewed on a quarterly basis for resetting. The contract could not be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit responsive investment contract was dependent on MetLife's ability to meet its financial obligations. MetLife's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with MetLife. Examples of such events include, but are not limited to the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of the contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the Plan sponsor or other Plan sponsor events (for example divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

As of December 31, 2021, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with MetLife and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allowed MetLife to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of MetLife

Note 7 – Related Party and Party-in-Interest Transactions

Certain administrative expenses, totaling approximately \$1,400 and \$44,800, were paid by the Employer on behalf of the Plan for the period from January 1, 2023 through March 17, 2023, and for the year ended December 31, 2022, respectively. The Employer does not expect reimbursement from the Plan for these expenses. Certain administrative functions are performed by officers and employees of the Employer. No officer or employee receives compensation from the Plan for these services.

Certain investments were managed by The Vanguard Group, Inc. The Plan also held notes receivable from participants. These transactions qualify as party-in-interest transactions.

Certain fees incurred by the Plan were included in net appreciation (depreciation) in fair value of investments, as they were paid through revenue sharing, rather than a direct payment. The Plan also made direct payments to service providers which were not covered by revenue sharing.

Note 8 – Tax Status

The Employer adopted a Nonstandardized Preapproved Profit Sharing Plan with CODA (the Preapproved Plan) sponsored by Ascensus, LLC. The Internal Revenue Service has determined and informed the Preapproved Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Preapproved Plan is designed in accordance with the applicable sections of the Code. The Preapproved Plan's opinion letter is being relied on by the Plan. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.


