## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Carrier Clinic 403(b) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Carrier Clinic 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements of the Carrier Clinic 403(b) Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

### Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **1. Description of Plan**

The following description of the Carrier Clinic 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan was established effective September 1, 1991 and is a defined contribution pension plan for employees of Carrier Clinic (“Carrier”) and sponsored by Carrier (the “Plan Sponsor”). The Plan is intended to qualify under Internal Revenue Code (“IRC”) Section 403(b). The Plan is subject to the provisions of ERISA, as amended.

During the year ended December 31, 2022, Metropolitan Life Insurance Company, as agent for Reliance Trust Company, is the only custodian accepting participant contributions of the Plan.

On January 1, 2019, Hackensack Meridian Health, Inc. (“HMH” or the “Network”) became the sole corporate member of the Plan Sponsor. Carrier is a non-profit, tax-exempt, behavioral healthcare system treating patients with psychiatric, emotional, and addictive illnesses.

Effective June 11, 2022 (the “Freeze Date”), the date on which Carrier payroll system became fully integrated with the HMH payroll system, the Plan was amended to freeze all contributions.

Effective December 31, 2022, HMH adopted resolutions to, among other matters, merge the assets of the Plan with and into the Consolidated 403(b) Plan of Hackensack Meridian Health (“Consolidated 403(b) Plan”).

As a result, net plan assets of \$22,225,011 were transferred from the Plan to the Consolidated 403(b) Plan. Due to the nature and timing of the transfer, the assets were still held at December 31, 2022 by Metropolitan Life Insurance Company (“Metlife”), as agent for Reliance Trust Company (“Reliance”), Brighthouse Life Insurance Company (“Brighthouse”), and Empower Annuity Insurance Company (“Empower”), which acquired Prudential Insurance Company of America (“Prudential”) and were physically transferred subsequent to December 31, 2022. However, due to the merger of the Plan, all assets, liabilities and participants ceased to be part of the Plan; were considered to be due to the Consolidated 403(b) Plan on December 31, 2022; and are reflected in the accompanying financial statements as “Due to affiliated plan” as of December 31, 2022.

For Form 5500 purposes, all assets, liabilities and participants also ceased to be part of the Plan as of December 31, 2022 and such amounts are reported as zero on the December 31, 2022 Form 5500.

**Eligibility**

All employees of the Plan Sponsor are eligible to participate in the Plan.

**Contributions**

Prior to the Freeze Date, participants may make tax-deferred elective contributions to the Plan as soon as administratively feasible after their hire date, effectively the first day of the next payroll, subject to the limitations of the IRC. Participants age 50 or older or who attain 50 during the Plan year may make “catch-up” contributions as defined by the IRC.

Participants may also elect to transfer, or rollover, balances from other qualified plans.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and rollover contribution and an allocation of the Plan’s earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately and fully vested in their contributions and earnings thereon.

**Payment of Benefits**

A participant who ceases to be an employee of Carrier or becomes totally disabled while actively employed by Carrier before his or her normal retirement age shall be entitled to receive his/her vested account balance. All vested accounts can be distributed in-service after attainment of age 59½. A participant or his/her beneficiary can elect to:

- receive a lump sum cash payment of the vested portion of the participant's account;
- receive equal monthly, quarterly, or annual installments (not to exceed the participant's life expectancy or joint life expectancy of the participant and his or her beneficiary); or
- receive payment through an annuity option in accordance with the annuity product.

**Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 up to the lesser of: 1) a maximum of \$50,000 or 2) 50% of the value of the vested interest in their account in the Plan. Loans used to purchase a primary residence may have a repayment period of no more than fifteen years. Loans for all other purposes must be repaid within five years. A participant may only have two loans outstanding at any time. The interest rate on participant loans is determined based on rates for comparable commercial loans, and is defined as the prime rate as stated in The Wall Street Journal plus 2%. The interest rate on outstanding loans ranges from 5.25% to 9.00% as of December 31, 2022 with maturities through 2033.

**Investment Options**

Participants may direct employee contributions into selected registered investment companies (mutual funds), pooled separate accounts and/or group annuity contracts.

**2. Summary of Significant Accounting Policies**

The following are the significant accounting principles followed by the Plan:

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contracts and their related activity on a contract value basis (see Note 5).

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Plan administrator determines the Plan's investment policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are recorded and measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the unpaid loan to be in default, the participants vested account balance is reduced by the unpaid amount.

**Administrative Expenses**

All reasonable administrative expenses and custodian fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by Carrier. Expenses of maintaining the Plan that are paid directly by Carrier are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, as well as recordkeeping fees that Metlife individually charges to Plan participants and are included in administrative expenses. Certain investment-related expenses are included in the net depreciation in fair value of investments.

**3. Information Certified by Qualified Institutions**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Metropolitan Life Insurance Company, as agent for Reliance Trust Company, Brighthouse Life Insurance Company and Empower Annuity Insurance Company, which acquired Prudential Insurance Company of America, qualified institutions, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, fully benefit-responsive investment contracts, at contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2022 and 2021.
- Investment activity, including net depreciation in fair value of investments, dividend and interest income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2022.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2022 and 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Individual brokerage balances:* Securities are valued at the closing price per share for the period ending date. These accounts are classified within Level 1 of the fair value hierarchy because they are publicly traded and the NAV quoted in active markets.

*Pooled separate accounts:* Pooled separate accounts are valued at the NAV or equivalent based on units of the pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan’s pooled separate accounts are invested in a variety of funds designed to mirror the investment strategies of similar registered investment companies (mutual funds), including equity-style funds and fixed income style funds. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a pooled separate account, the custodian reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

**5. Fully Benefit-Responsive Investment Contracts**

The Plan holds traditional investment contracts, including the Strategic Value Annuity Liquid Fixed Fund (the “Fixed Fund”) through Metlife, the guaranteed interest account through Empower (formerly Prudential) and fixed interest accounts through Metlife and Brighthouse. These funds meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

These funds are guaranteed investment contracts. The contract issuers are contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rates are based on formulas established by the contract issuers but may not be less than 1%. The crediting rates are reviewed on a semi-annual basis for resetting. The contracts cannot be terminated before the scheduled maturity date.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Due to the plan merger detailed in Note 1, the Fixed Fund was subject to a redemption notice period. Participants invested in the Fixed Fund continued to be able to direct the withdrawal or transfer of all or a portion of their investment at contract value. Under the terms of the contract with Metlife, balances in the Fixed Fund have a partial withdrawal and transfer limit of 20%, which limits the amount that may be transferred out of the Fixed Fund to other contract investments. Balances in the Fixed Fund are to be transferred over a five-year annual installment transfer period. At each annual installment, funds in the Fixed Fund are to be allocated to the TIAA Stable Value Fund. Similar restrictions apply to the guaranteed interest account through Empower (formerly Prudential), the fixed interest accounts through Metlife and Brighthouse. No other events are probable of occurring with the Fixed Fund or the guaranteed interest account that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuers’ ability to meet their financial obligations. The issuers’ ability to meet their contractual obligations may be affected by future economic and regulatory developments. As of December 31, 2022 and 2021, the Plan believes that the high credit ratings of the issuers uphold their ability to meet obligations set forth in the contracts.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**7. Related Party and Party-In-Interest Transactions**

Certain Plan investments are shares of registered investment companies (mutual funds) and group annuity contracts managed by Metlife or affiliates. Metlife is the agent for Reliance, a custodian of the Plan. Metlife utilizes Empower Institutional as recordkeeper. Certain Plan investments are shares of registered investment companies (mutual funds), pooled separate accounts and group annuity contracts managed by Brighthouse and Empower, which acquired Prudential. The Plan also issues participant loans to its participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for investment management services are included in the net depreciation in fair value of investments. Fees paid directly from participant accounts are included in administrative expenses.

**8. Plan Termination**

Although it has not expressed any intent to do so, Carrier has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in any contributions that they were not previously vested.

**9. Tax Status**

The Plan has been designed to qualify under Section 403(b) of the IRC. The plan administrator believes the Plan is operating in accordance with the applicable requirements of Section 403(b) of the IRC and therefore believes the Plan is qualified and the related custodial accounts are tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

**10. Subsequent Events**

Management evaluated subsequent events for the Plan through October 11, 2023, the date the financial statements were available to be issued.
