## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Carrier Clinic Defined Contribution Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Carrier Clinic Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements of the Carrier Clinic Defined Contribution Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

**1. Description of Plan**

The following description of the Carrier Clinic Defined Contribution Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan was established effective April 1, 2005 and is a noncontributory defined contribution pension plan for employees of Carrier Clinic (“Carrier”) and sponsored by Carrier (the “Plan Sponsor”). The Plan is intended to qualify under Internal Revenue Code (“IRC”) Section 401(a). The Plan is subject to the provisions of ERISA, as amended.

On January 1, 2019, Hackensack Meridian Health, Inc. (“HMH” or the “Network”) became the sole corporate member of the Plan Sponsor. Carrier is a non-profit, tax-exempt, behavioral healthcare system treating patients with psychiatric, emotional, and addictive illnesses.

Effective June 11, 2022 (the “Freeze Date”), the date on which Carrier payroll system became fully integrated with the HMH payroll system, the Plan was amended to freeze all contributions. A prorated contribution was made for the Plan Year ending on December 31, 2022. Effective June 11, 2022, participants became 100% vested in their Plan accounts. Additionally, no new contributions will be made for any participant for any Plan year beginning after December 31, 2022.

Effective December 31, 2022, HMH adopted resolutions to, among other matters, merge the assets of the Plan with and into the Consolidated Defined Contribution Plan of Hackensack Meridian Health (“Consolidated DC Plan”).

As a result, net plan assets of \$15,720,092 were transferred from the Plan to the Consolidated DC Plan. Due to the nature and timing of the transfer, the assets were still held at December 31, 2022 by Reliance Trust Company and were physically transferred subsequent to December 31, 2022. However, due to the merger of the Plan, all assets, liabilities and participants ceased to be part of the Plan; were considered to be due to the Consolidated DC Plan on December 31, 2022; and are reflected in the accompanying financial statements as “Due to affiliated plan” as of December 31, 2022.

For Form 5500 purposes, all assets, liabilities and participants also ceased to be part of the Plan as of December 31, 2022 and such amounts are reported as zero on the December 31, 2022 Form 5500.

**Eligibility**

Employees who attained age 21 and were participating under the Carrier Clinic Pension Plan as of March 31, 2005 are automatically participants in the Plan. Other employees shall become a participant upon employment and attaining age 21. Participation in the Plan automatically begins on the first day of the month coincident with or next following the date the employee meets all of these conditions. Eligible employee, as defined in the Plan document, means any employee of Carrier who is receiving remuneration for personal services rendered to Carrier or would be receiving such remuneration except for an authorized leave of absence, but shall not include an employee who is represented by any collective bargaining agreement, unless the collective bargaining agreement provides for participation in the Plan. Effective January 1, 2018, the Plan was amended to permit employees who are included in a collective bargaining unit and are a participant in the Carrier Clinic Pension Plan to participate in the Plan from such date that his or her benefit accruals under the Carrier Clinic Pension Plan ceased. Service for employees who are included in a collective bargaining unit and are a participant in the Carrier Clinic Pension Plan begins on the date on which the collective bargaining agreement makes the Plan available to such employees.

**Contributions**

Carrier shall contribute each Plan year an amount equal to the sum of the required contributions to fund the targeted benefit for each participant, as defined in the Plan document. A participant's targeted benefit is the benefit that the participant is projected to have under the target benefit formula as of the close of the Plan year in which the participant attains normal retirement age or, if the participant has attained normal retirement age, the participant's benefit under the formula as of the current Plan year. The required contribution for each participant shall be rounded up to the nearest \$100 but shall not be less than \$500 for each Plan year. Participants must be employed on the last day of the Plan year and complete the 1,000 hours of service requirement during the Plan year to be allocated the employer contribution. The employer contribution will also be allocated to any participant who dies during the Plan year. Participants may not make contributions to the Plan.

**Vesting**

Effective June 11, 2022, participants became 100% vested in their Plan accounts. Prior to the Freeze Date and subject to the one-year break in service provisions of the Plan, a participant shall accrue a year of vesting service for each calendar year in which he or she has 1,000 or more hours of service. Upon termination of employment on or after the participant's normal retirement age, the participant's account shall be 100% vested and the Plan administrator shall direct Metropolitan Life Insurance Company, an agent for Reliance Trust Company (the "Trustee"), to distribute the full value of the participant's account in accordance with the provisions of the Plan. Otherwise, a participant shall be 100% vested in the value of his or her account according to the following schedule:

**Forfeited Amounts**

The participant's nonvested portion of his/her account shall be forfeited upon termination of employment. Forfeitures shall be used to reduce subsequent employer contributions, to pay Plan expenses or to restore the nonvested accounts of a participant in accordance with the re-employment provisions of the Plan. Forfeitures of \$26,251 were used to reduce the annual contributions for 2022. As of December 31, 2022 and 2021, forfeited nonvested accounts totaled \$2,168 and \$19,695, respectively.

**Participant Accounts**

A separate account is maintained in the name of each participant (by fund) to record Carrier's contributions and plan earnings. All contributions made by Carrier shall be paid to the Trustee and deposited under the individual accounts of the participants. All assets of the fund, including investment income, shall be retained for the exclusive benefit of participants and their beneficiaries.

**Payment of Benefits**

A participant who ceases to be an employee of Carrier or becomes totally disabled while actively employed by Carrier before his or her normal retirement age shall be entitled to receive his/her vested account balance. A participant or his/her beneficiary can elect to:

- receive a lump sum cash payment of the vested portion of the participant's account;
- receive equal monthly, quarterly, or annual installments (not to exceed the participant's life expectancy or joint life expectancy of the participant and his or her beneficiary); or
- roll the vested portion of the participant's account balance into another eligible retirement plan specified by the distributee.

Upon termination of service for any reason, a participant is eligible to receive a distribution of their vested account balance.

**Investment Options**

The Trustee, as directed by Carrier, shall establish multiple investment funds, which shall include an equity fund, a fixed income fund, a short-term fixed income fund and other investment funds as may be established by the Trustee, Reliance Trust Company, and in which Carrier elects to participate. The Plan currently has an investment platform offering numerous funds and asset classes, including individual brokerage accounts. There is complete transferability between funds with no minimum to open or to transfer, no loads, daily priced at net asset value (NAV), and an administrative fee.

Participants direct the investment of their account balances. There is no limit to how often participants may change their investment options.

**2. Summary of Significant Accounting Policies**

The following are the significant accounting principles followed by the Plan:

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contracts and their related activity on a contract value basis (see Note 5).

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Plan administrator determines the Plan's investment policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

All reasonable administrative expenses, including trustee, custodial and third-party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by Carrier. Expenses of maintaining the Plan that are paid directly by Carrier are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature and are included in administrative expenses. Certain investment-related expenses are included in the net depreciation in fair value of investments.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Metropolitan Life Insurance Company, as agent for Reliance Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value and fully benefit-responsive investment contracts, at contract value as shown in the statements of net assets available for benefits of December 31, 2022 and 2021.
- Investment activity, including net depreciation in fair value of investments and dividend and interest income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2022.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2022 and 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Individual brokerage balances:* Self-directed brokerage accounts generally are limited to certain mutual funds, including money market funds, and exchange-traded funds. Mutual funds are value at the daily closing price (NAV) as noted above. Shares of exchange-traded funds on securities exchanges are valued at the last reported sales price on the last business day of the plan year.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. Fully Benefit-Responsive Investment Contracts**

The Plan holds an investment contract, specifically, the Strategic Value Annuity Liquid Fixed Fund (the "Fixed Fund"), a traditional investment contract. This fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

This fund is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The contract cannot be terminated before the scheduled maturity date.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Due to the plan merger detailed in Note 1, the Fixed Fund was subject to a redemption notice period. Participants invested in the Fixed Fund continued to be able to direct the withdrawal or transfer of all or a portion of their investment at contract value. Under the terms of the contract with Metropolitan Life Insurance Company, balances in the Fixed Fund have a partial withdrawal and transfer limit of 20%, which limits the amount that may be transferred out of the Fixed Fund to other contract investments. Balances in the Fixed Fund are to be transferred over a five-year annual installment transfer period. At each annual installment, funds in the Fixed Fund are to be allocated to the TIAA Stable Value Fund. No other events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. As of December 31, 2022 and 2021, the Plan believes that the high credit ratings of the issuer uphold its ability to meet obligations set forth in the contracts.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**7. Related Party and Party-In-Interest Transactions**

Certain Plan investments are managed by Metropolitan Life Insurance Company or its affiliates. Metropolitan Life Insurance Company is the agent for Reliance Trust Company, the trustee of the Plan. Metropolitan Life Insurance Company utilizes Empower Institutional as recordkeeper. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for investment management services are included in the net depreciation in fair value of investments. Fees paid directly from participant accounts are included in administrative expenses.

**8. Plan Termination**

Although it has not expressed any intent to do so, Carrier has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in Carrier base contributions (see Note 1).

**9. Tax Status**

The Internal Revenue Service ("IRS") has determined and informed Carrier by a letter dated May 24, 2018, that the Plan is designed in accordance with applicable regulations of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and is operating in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

**10. Subsequent Events**

Management evaluated subsequent events for the Plan through October 11, 2023, the date the financial statements were available to be issued.
