Note 1: Description of the Plan

The following description of Classic Aviation Holding, LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1999 and is a defined contribution plan sponsored by Classic Aviation Holding, LLC (the Company) for the benefit of its eligible employees who have completed three months of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Certain members of management are the trustees of the Plan. Jackson National Life Insurance Company and Transamerica Life Insurance Company (collectively, the insurance companies) are the issuers of certain variable and fixed annuity investment contracts.

Effective December 31, 2012, the following entities elected to become participating employers in the Plan: Classic Aviation Holding, LLC, Classic Helicopter Group, LLC, Classic Air Care, LLC, Classic Charter, LLC, and Classic Service Center, LLC.

Effective June 30, 2022, the Plan's sponsor was acquired and therefore, the Plan was terminated and all assets were transferred out of the Plan.

Contributions

Participants authorize the Company to deduct a percent thereof of their annual compensation for deposit into the Plan. However, the law limits the amount that can be contributed in any tax year (\$20,500 in 2022). Pursuant to the *Economic Growth Tax Relief Reconciliation Act* (EGTRRA) amendments, participants who have attained age 50 during the plan year may make additional elective contributions (\$6,500 in 2022). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Employer contributions include both discretionary matching and discretionary profit-sharing contributions. For each participant who is eligible to share in matching contributions for the plan year, a discretionary matching contribution equal to a uniform percentage of each such participant's elective contribution, the exact percentage, if any, to be determined each year by the Company. In order to share in an allocation of any discretionary profit-sharing contributions, a participant must be employed on the last day of the plan year and must have completed at least 1,000 hours of service during the plan year. For 2022 and 2021, the Company matched 100% of the first 2% of participant contributions made and satisfied the safe harbor rules during the periods. The Plan did not have any employer profit sharing contributions during the six months ended June 30, 2022 or the year ended December 31, 2021.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings or losses and is charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all employee's contributions, including rollover contributions, plus earnings thereon. Prior to termination of the Plan, participants vested in the total value of their employer's matching contributions and profit-sharing contributions according to the following schedule:

Years of Service	Vesting Percentage
1	33%
2	66%
3	100%

Participants must be credited with at least 1,000 hours of service during a plan year in order to earn a year of service. With the termination of the Plan, all amounts became 100% vested.

Payment of Benefits

Upon termination of service due to retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or choose to receive partial withdrawals. If a participant dies, the participant's vested account will be paid to the participant's beneficiary. The beneficiary may elect to receive the value of the vested account in either a single lump-sum or partial withdrawals.

For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants are able to make withdrawals for financial hardships described by federal guidelines. Requests for hardship withdrawals must be in writing on a form provided by the plan administrator.

Forfeitures

Forfeited accounts include the nonvested portion of the Company's contributions, including any realized earnings thereon, previously allocated to former participants in the Plan. For the six months ended June 30, 2022 and the year ended December 31, 2021, forfeited nonvested accounts totaled \$1,939 and \$10,548, respectively. Forfeitures may be first used to pay any administrative expenses. The remaining forfeitures may then be used to reduce employer contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Pooled separate accounts are valued at estimated fair value as provided by John Hancock. Estimated fair value is based on the change in net asset values of the underlying mutual fund investments, dividends, capital gain or loss distributions, and expense charges.

Other investments are reported at fair value. Quoted market prices, if available, are used to value these investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Variable annuity contracts are valued at estimated fair value as provided by the insurance companies.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

All administrative expenses of the Plan are paid out of the trust fund unless paid by the Company. These generally include maintenance fees, withdrawal fees, recordkeeping fees, and managed account fees charged directly to the participant's account.

Note 3: Certification of Plan Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, the custodian of the Plan, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate to the best of their knowledge and belief:

- Pooled separate accounts as shown in the statements of net assets available for benefits as of June 30, 2022 and December 31, 2021
- Investment income (loss) on pooled separate accounts and mutual fund investments of \$(1,452,024) for the six months ended June 30, 2022 and \$765,951 for the year ended December 31, 2021 as included in net appreciation (depreciation) in fair value of investments in the statements of changes in net assets available for benefits for the six months ended June 30, 2022 and the year ended December 31, 2021
- Investment information (excluding variable annuity contracts) included in the accompanying schedule of assets (held at year-end) as of June 30, 2022

Note 4: Related-party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee company whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are units of pooled separate accounts managed by affiliates of John Hancock, a plan custodian. In addition, certain plan investments are variable and fixed investment contracts managed by affiliates of the insurance companies and other plan investments are shares of mutual funds managed by the Plan's investment advisor. Therefore, all of these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are either included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment, recorded as administrative expenses, or paid directly by the Company and therefore not reflected in the accompanying financial statements. These fees were \$23,981 and \$24,898 during the six months ended June 30, 2022 and year ended December 31, 2021, respectively. The Company also provides certain other administrative services at no cost to the Plan.

Note 5: Disclosures About Fair Value of Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets

Investments

In accordance with Subtopic 820-10, the Plan's investments in pooled separate accounts were measured at net asset value per share (or its equivalent) totaling \$0 and \$6,471,712 at the six months ended June 30, 2022 and year ended December 31, 2021, respectively, and have not been classified in the fair value hierarchy. This category of investments seek investment returns consistent with the underlying investment accounts, there are no unfunded commitments, there are no participant redemption restrictions, and the redemption notice period is applicable only to the Plan.

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6: Plan Tax Status

The Plan operates under a standardized adoption agreement in connection with a volume submitter plan sponsored by John Hancock. This volume submitter plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and that the related trust was tax-exempt as of the financial statements date.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
