INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the
Draper Aden Associates, Inc. Savings and Retirement Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Draper Aden Associates, Inc. Savings and Retirement Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of November 7, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to November 7, 2022, and for the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of November 7, 2022 and December 31, 2021, and for the period from January 1, 2022 to November 7, 2022, and the year ended December 31, 2021, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

1. Description of Plan:

The following description of the Draper Aden Associates, Inc. Savings and Retirement Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

In May 2022, Draper Aden Associate, Inc. (the "Company") was acquired by TRC Companies, Inc. ("TRC"). Effective November 7, 2022, the Draper Aden Associates, Inc. Savings and Retirement Plan and Trust merged into the TRC 401(k) Retirement and Savings Plan. As a result, all investments were transferred from the Plan into the TRC 401(k) Retirement and Savings Plan.

General: The Plan is a defined contribution plan covering all eligible employees of Draper Aden Associates, Inc. Full-time employees become eligible to participate upon reaching age 21. Part time, temporary, or seasonal employees become eligible after completing 1,000 service hours within a one-year period and upon reaching age 21. Employees are eligible for entry to the plan on the first day of each plan quarter, coinciding with or next following the date that eligibility requirements are met. The Plan is subject to the provisions of ERISA.

Contributions: The Plan provides for participant contributions of pre-tax annual compensation and Roth deferrals, as defined in the Plan. Participants of qualifying age may make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may provide a per payroll period matching contribution equal to a discretionary percentage of participant contributions. The Plan includes automatic deferrals of 3% of participant compensation and automatic escalation of deferral percentages of 1% per year to a maximum of 5% of participant compensation. The auto enrollment occurs once a year on January 1st of each year.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct Principal Trust Company as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

1. Description of Plan, Continued:

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms cannot exceed 5 years, unless the proceeds are used to acquire a principal residence (10 years). The loans are secured by the vested balance in the participant's account and bear interest equal to the current prime lending rate. Principal and interest are paid ratably through bi-monthly payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants deemed to be in default by the plan administrator are reclassified as distributions based upon the terms of the Plan document.

Vesting: Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. Participants are fully vested in Company contributions after attaining five years of credited service.

Plan Administration: Overall responsibility for administering the Plan rests with the Company. Participant accounts were administered by Wells Fargo Bank, N.A. Institutional Retirement and Trust, the third-party administrator, an affiliate of Wells Fargo Bank, N.A. for the period from January 1, 2021 through April 15, 2021. Participant accounts were administered by Principal Trust Company, the custodian and third-party administrator, for the period from April 15, 2021 through November 7, 2022. Certain administrative functions are performed by Company employees. No such employee receives compensation from the Plan.

Payment of Benefits: On termination of service due to death, disability, retirement, or other, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeitures: Non-vested portions of terminated employees are forfeited and used to reduce Plan administrative expenses, employer non-elective contributions, and employer match contributions. Additions to forfeitures were \$60,744 for the period January 1, 2022 to November 7, 2022, and \$87,272 for the year ended December 31, 2021. There were no forfeitures available at November 7, 2022. Forfeited balances available were \$51,615 at December 31, 2021. Forfeitures applied to pay administrative expenses were \$35,208 for the period January 1, 2022 to November 7, 2022, and \$35,578 for the year ended December 31, 2021. Forfeitures applied to reduce employer contributions were \$31,919 for the period January 1, 2022 to November 7, 2022, and \$9,267 for the year ended December 31, 2021. The forfeiture balance transferred out of the plan due to the plan merger was \$45,233 at November 7, 2022.

2. Summary of Significant Accounting Policies:

Basis of Accounting: The financial statements of the Plan are prepared on the accrual method of accounting. Employee contributions are recognized in the period in which the contributions are due. Employer contributions are recognized when due and the employer has made a formal commitment to provide the contributions.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent Events: Management has evaluated subsequent events through October 10, 2023, the date the financial statements were available to be issued, and has determined there are no subsequent events to be reported in the accompanying financial statements.

3. Fair Value Measurements:

The Financial Accounting Standards Board (“FASB”) has issued guidance for measurement and disclosure of fair value and establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable markets. There were no assets or liabilities whose fair value was determined using primarily Level 2 inputs at November 7, 2022 and December 31, 2021.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no assets or liabilities whose fair value was determined using primarily Level 3 inputs at November 7, 2022 and December 31, 2021.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust: A fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Administrative Fees:

Although not required by the Plan, some of the costs of Plan administration are absorbed by the Company. The Plan paid \$77,202 in administration fees during 2022 and paid \$97,700 during 2021.

5. Related-Party Transactions:

Certain Plan investments consisted of shares of a common/collective trust managed by the trustee, which qualified as party-in-interest transactions. Fees paid by the plan for investment management services amounted to \$35,147 for the period January 1, 2022 to November 7, 2022, and \$35,848 for the year ended December 31, 2021. Fees paid by the plan for trustee services amounted to \$42,055 for the period January 1, 2022 to November 7, 2022, and \$62,151 for the year ended December 31, 2021.

6. Tax Status:

The Internal Revenue Service has determined and informed Principal Life Insurance Company, an affiliate of Principal Trust Company, by letter dated June 30, 2020 that the adopted prototype plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at November 7, 2022 and December 31, 2021. The Plan is not currently under audit by any tax authority.

7. Risks and Uncertainties:

The Plan provides for various investments in mutual funds and a common/collective trust. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

8. Financial Information Certified by a Qualified Institution:

Wells Fargo, N.A., the trustee for the Plan for the period from January 1, 2021 through April 15, 2021, and Principal Trust Company, the custodian of the Plan for the period from April 15, 2021 through November 7, 2022, have certified that the following information regarding investments held in their custody is complete and accurate:

- Investments, at fair value
- Investment income (loss)
- Notes receivable from participants
- Interest income on notes receivable from participants

9. Prohibited Transactions

During the Plan period from January 1, 2022 to November 7, 2022, the Company failed to remit employee contributions and participant loan payments to the Plan timely on several occasions, as reflected in the accompanying schedule of delinquent participant contributions. The Company remitted the employee contributions and participant loan payments during the period from January 1, 2022 to November 7, 2022, and is assessing the appropriate payments of any lost earnings related to these events. Management determined the amounts allocated for lost earnings on investments, are immaterial, both individually and in the aggregate, to the financial statements as a whole, and therefore not included on the accompanying statements of net assets available for benefits as of November 7, 2022.
