Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Andrie LLC 401(k) Profit-Sharing Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 27, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period ended December 27, 2022 and year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 27, 2022 and December 31, 2022, and for the period ended December 27, 2022 and year ended December 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

Emphasis of Matter - Plan Merger

As discussed in Note 3 to the financial statements, the Plan merged into the Auxo Investment Partners, LLC 401(k) Retirement Plan effective December 27, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to Financial Statements

1. Description of the Plan

The following description of the Andrie LLC 401(k) Profit-Sharing Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Andrie LLC (the Plan Sponsor), who have 90 days of service and have attained the age of 21. Leased employees who are covered under a collective bargaining agreement or non-resident aliens are not eligible for the Plan. An eligible employee becomes a participant on the first administratively feasible payroll date following the date the employee satisfies the eligibility requirements. The Plan was originally adopted effective April 1988. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA). During 2022, the Plan Sponsor approved the merger of the Plan into a qualified Multiple Employer Plan (see Note 3).

Contributions

Participants may contribute up to the maximum amount allowed by law of their eligible annual compensation, subject to Internal Revenue Service (IRS) limitations. Contributions and earnings thereon, are non-taxable until withdrawn from the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision for all newly eligible employees unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The feature also allows for annual auto-escalation of 1%, up to a maximum of 8%.

The Plan Sponsor may make discretionary matching and profit-sharing contributions to the Plan as determined by its management. Participants are eligible for the match and profit-sharing contributions if they have worked at least 1,000 hours, have one year of service and have attained the age of 21. There were no matching contributions made during 2022 and 2021. The Company elected to contribute \$425,000 and \$240,000 in profit-sharing contributions for the period ended December 27, 2022 and the year ended December 31, 2021, respectively, paid subsequent to the period end. The profit-sharing contributions related to 2022 were paid subsequent to the Plan merger.

Participant Accounts

Each participant's account is credited with the participant's contribution and Plan's matching and profit-sharing contributions and an allocation of Plan earnings or losses, investment management fees and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. Participant accounts are also charged directly for loan fees and fees related to distributions, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their elective deferral contributions plus actual earnings and losses thereon. Vesting in the Plan's discretionary matching and profit-sharing contributions are based on years of continuous service. Participants begin to vest at 20% after two years of service and are fully vested after six years of service. Participant accounts are distributed without regard to the vesting provisions in the event of death or permanent physical or mental disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note receivable terms generally range from one to five years unless the loan is for the purchase of a primary residence, in which case the note receivable may extend to a maximum of 30 years. Such loans are made and repayment terms are established in accordance with regulatory provisions. The notes receivable are secured by the balance in the participant's account and bear interest at a rate of 4.25% to 6.00% at the date of the merger (see Note 3). The interest rate charged on loans made in any calendar month is determined by adding one percentage point to the prime interest rate published in *The Wall Street Journal* on the first business day of the month in which the loan is processed. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account, as defined by the Plan agreement. For termination of service or for other reasons, a participant may elect to receive the value of the vested interest in their account as a lump-sum distribution or transfer the amount to another qualified plan or Individual Retirement Account, as defined by the Plan agreement. In-service withdrawals of vested balances may be elected by participants who have reached 59½ years of age. The Plan also permits withdrawals of active participants' elective contributions and rollover contributions only in amounts necessary to satisfy financial hardship as defined by the Plan agreement.

Forfeited Accounts

Forfeited non-vested accounts are allocated first to restore any forfeited amounts that are required to be restored per the Plan. Any remaining forfeitures shall be applied to reduce the employer contributions. If the amount of the forfeitures exceeds the amount of employer contributions, the remaining forfeitures are allocated as additional employer contributions. No additional employer contributions were made from the forfeited non-vested accounts during 2022. Additional employer contributions of approximately \$57,800 were made from forfeited non-vested accounts during 2021. The balance of the forfeited non-vested accounts totaled \$31,748 as of December 31, 2021.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the group annuity contract which is stated at contract value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. Fully benefit-responsive investment contracts are presented at contract value, which is the amount participants would receive in a transaction (see Note 5).

Purchases and sales of securities are recorded on a trade date basis. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Fees for custodial and certain recordkeeping services are paid by the Plan and are allocated to Plan participants based on the provisions of the Plan. Participants are charged directly for loan fees and fees related to distributions. The distribution fees are deducted from the amount of benefits paid to participants. In addition, fees for investment advisor services are offset by revenue sharing income. During 2022 and 2021, the Plan received revenue sharing credits of approximately \$42,000 and \$49,000, respectively, which were used to pay expenses. Administrative expenses are presented net of revenue credits in the statements of changes in net assets available for benefits.

Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in their values could occur in the near

term and such changes could materially affect participant's account balances and the amounts reported in the financial statements.

Subsequent Events

Subsequent events have been evaluated by management through October 13, 2023, the date these financial statements were available to be issued.

3. Plan Merger

Effective November 1, 2022, the Plan Sponsor elected to adopt the Auxo Investment Partners, LLC 401(k) Retirement Plan (Auxo Plan), a qualified Multiple Employer Plan. On December 27, 2022, the Plan merged into the Auxo Plan, and all assets of the Plan were transferred. The Plan no longer exists as a separate plan. The net assets of the Plan totaling \$12,367,502 were transferred, which included \$62,793 of outstanding loans. In addition, to the funds held by the Plan as of December 27, 2022, amounts transferred included \$23,784 in employee contributions and \$425,000 in profit-sharing contributions for the period ended December 27, 2022 were payable to the Plan's participants but were not funded to the Plan prior to December 27, 2022. These amounts were included in the transfer to other qualified plan presented in the statements of changes in net assets available for benefits and were contributed directly to the Auxo Plan by the Plan sponsor. As part of the Plan merger, the Plan Sponsor elected to select the market value adjustment cessation option for the group annuity contract to liquidate the investment. As such, a lump sum payment of the group annuity contract's value with a market value adjustment was transferred to the Auxo Plan. The market value adjustment totaled an investment loss of approximately \$136,000, which is included the net appreciation (depreciation) in fair value of investments on the accompanying statements of changes in net assets available for benefits.

4. Fair Value Measurements

Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset. The Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, other inputs that are observable, or can be corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The following valuation methodologies were used to measure the fair value of the Plan's investments. There have been no changes in the methodologies used.

Mutual Funds - These funds are valued at daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - These funds are valued at the NAV of the units held by the Plan at year-end, which is provided by the trustee and is determined based on the fair value of the underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The fund provides for daily redemptions by the Plan at reported NAV with no advance notice requirement, with the exception of plan sponsor directed withdrawals in excess of \$1,000,000. There is no restriction in place with respect to the daily redemption of the funds and there are no unfunded commitments.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan's management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Group Annuity Contract

The Plan entered into a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America (formerly Great-West Life & Annuity Insurance Company). The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is a fully benefit-responsive, contract value is the relevant measure attributable for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC (formerly Great-West Trust Company, LLC) and Empower Annuity Insurance Company of America (formerly, Great-West Life & Annuity Insurance Company) (collectively, Empower), qualified institutions, have certified that the following investment information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 27, 2022 and December 31, 2021.
- Investment income (loss) and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period ended December 27, 2022 and the year ended December 31, 2021.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

7. Related Party and Party-in-Interest Transactions

The Plan's investment in a group annuity contract was managed by Empower Annuity Insurance Company of America, an affiliate of the custodian, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Empower totaled approximately \$57,000 and \$55,000 during 2022 and 2021, respectively. Fees paid for investment management services were offset by revenue-sharing income as disclosed in Note 2. Notes receivable from participants also qualify as party-in-interest transactions.

8. Plan Termination

Although it has not expressed any intent to do so, the Plan has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

As discussed in Note 3, the Plan was merged into the Auxo Plan in December 2022.

9. Income Tax Status

The IRS determined and informed the Company, by a letter dated January 25, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.
