### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the accompanying financial statements of HowardCenter Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of July 7, 2023 (in liquidation), December 31, 2022 (in liquidation) and 2021 (ongoing), and the related statements of changes in net assets available for benefits (modified cash basis) for the period from January 1, 2023 to July 7, 2023 (in liquidation) and the year ended December 31, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 7, 2023, December 31, 2022 and 2021, for the period January 1, 2023 to July 7, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2 to the financial statements.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ### **Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than U.S. generally accepted accounting principles. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### 1. Description of Plan

The following description of the HowardCenter Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. As described in Note 2, the Plan was terminated effective December 31, 2022.

#### General

The Plan was a tax-exempt, defined contribution retirement plan sponsored by HowardCenter (the Center). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan.

#### Eligibility

The Plan was available to all employees of the Center. Eligible employees were able to begin making elective deferrals to the Plan upon hire.

#### Contributions

Each year, eligible employees made contributions to the Plan through salary deferrals from eligible compensation, as defined in the Plan. The maximum amount that a participant may contribute is limited by provisions of the Internal Revenue Code (Code).

#### Vesting

Participants are 100% vested in their account plus earnings.

#### Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account was credited with the participant's contributions and an allocation of investment income, and charged with an allocation of investment losses and administrative expenses. Allocations were based on participants' earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's account.

#### Notes Receivable from Participants

Notes receivable from participant accounts under the Plan were made available to all qualifying participants on a reasonably equivalent basis. The amount of the loan was limited to the lesser of \$50,000 reduced by the excess, if any, of their highest outstanding balance of loans from the Plan during the one-year period prior to the date of the loan over the current outstanding balance of loans, or 50% of their vested account balance.

All notes receivable from participants were secured by participant balances.

### **Investments**

Upon enrollment in the Plan, a participant directed his or her account balance among the various investments offered by the Plan. The Plan offered investments in shares of mutual funds and a money market fund.

### **Payment of Benefits**

Participants shall become eligible to receive their vested account balance upon retirement (the normal retirement age is 65), death, disability or termination. Participants were allowed to withdraw their account balances upon attaining age 59 1/2. Participants received their benefit payments in a single lump sum payment, installment or ad hoc distribution.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the modified cash basis of accounting. Accordingly, certain revenue and related assets are recognized when received, rather than when earned, and certain expenses are recognized when paid, rather than when incurred.

In 2022, the Center elected to terminate the Plan in favor of the Retirement Plan for the Employees of HowardCenter (the 401(k) Plan), a 401(k) plan subject to ERISA operating by the Center. This resulted in a liquidation of all Plan assets during 2023. The effective date of the termination was December 31, 2022 and all assets were transferred to the 401(k) Plan or fully distributed by July 7, 2023. The 2022 and 2023 financial statements have been prepared using the liquidation basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments in mutual funds and the money market fund are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of the fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the cash basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

### **Administrative Expenses**

The Center absorbs the majority of the costs of administering the Plan.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Subsequent Events**

Management has considered transactions or events occurring through October 13, 2023, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Income Tax Status**

The Plan was designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan was required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). The plan administrator believes the Plan was operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **4. Information Prepared and Certified by Fidelity**

The investments, investment transactions, notes receivable from participants, net appreciation (depreciation) in fair value of investments, and interest and dividend amounts were obtained by management and agreed to or derived from the information certified by Fidelity as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits (Modified Cash Basis)
- Statements of Changes in Net Assets Available for Benefits (Modified Cash Basis)
- Schedule H, line 4i - Schedule of Assets (Held at End of Year)

### 5. Parties-In-Interest

Certain Plan investments are managed by Fidelity; therefore, these transactions qualify as party-in-interest transactions. Recordkeeping fees of \$99 and \$309 were paid to Fidelity for the period January 1, 2023 to July 7, 2023 and for the year ended December 31, 2022, respectively.

The Center provides administrative services to the Plan at no charge and absorbs significant costs associated with administration of the Plan.

### 6. Plan Termination

The Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective December 31, 2022, the Center ceased contributions as provisions were made to formally terminate the Plan. All assets were distributed or transferred to the 401(k) Plan as of July 7, 2023.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

### 8. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Mutual funds and the money market fund are valued using market quotations.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There were no Plan assets at July 7, 2023.
