1. Description of the Plan and Plan Termination

Wurl, Inc. (the Company) established the Wurl, Inc. 401(k) (the Plan), effective January 1, 2019, to provide participants with a means to fund their retirement on a tax-deferred basis. The Plan was amended and restated as of January 1, 2022. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

In March 2022, the Company entered into an acquisition agreement whereby AppLovin Corporation acquired 100% ownership of the Company. Participants became eligible to contribute to the acquiring Company's employee benefit plan on April 1, 2022, and contributions to the Plan ceased. Effective June 13, 2022, the Plan was liquidated and all Plan assets were distributed to participants. Plan operations concluded on June 13, 2022, at which date the Plan ceased to exist.

General:

The Plan was a defined contribution plan under Sections 401(a) and 401(k) and related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company was the Plan sponsor and Plan administrator. The Plan was administered by a Retirement Plan Committee, which comprised Company employees, and was responsible for selecting investment options offered under the Plan and monitoring investment performance. Ascensus Trust Company (Ascensus) was the Plan's trustee and record keeper. Ascensus held, invested and reinvested Plan assets in the interest and direction of the participants and their beneficiaries.

Eligible Participants:

Eligible employees, as defined by the Plan agreement, were eligible to participate in the Plan immediately upon hire.

Contributions:

Participants were permitted to make voluntary pre-tax salary deferrals and after-tax contributions up to 100% of their annual compensation, as defined in the Plan agreement. Participants who had reached the age of 50 could also elect to withhold additional "catch-up" contributions under the Code. Participants could also contribute amounts representing distributions from other tax-qualified plans (rollovers), subject to Code regulations.

Contributions: (continued)

The Company had elected to administer the Plan as a safe harbor plan. The safe harbor Company matching contributions were calculated to reflect 100% of participant elected salary deferrals, up to 3% of eligible compensation, plus 50% of participant elected salary deferrals from 3% to 5% of eligible compensation. The Company made safe-harbor contributions of \$146,493 to the Plan in 2022. The Company could also make discretionary profit sharing contributions to the Plan.

Contributions were subject to certain limitations under the Code.

Participant Accounts:

Participant accounts comprised a salary deferral account, Company contribution account and, where applicable, a rollover account. Participant's accounts were credited with participant contributions, Company matching and any non-elective contributions, and earnings or losses, thereon. The benefit to which participants were entitled was the benefit that can be provided from the participant accounts.

Participants could elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants could authorize transfers among investment options at any time.

Vesting:

Participants were fully (100%) vested in their account balances.

Notes Receivable from Participants:

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the Plan agreement. Note receivable transactions with participants qualified as party-in-interest transactions and were exempt from the prohibited transaction rules of ERISA.

Notes Receivable from Participants: (continued)

Participants could borrow up to one-half of their account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a longer term could be granted. Participants were allowed to have one note outstanding at any time. Participant notes were evidenced by a written note, bore a rate of interest equal to the prime rate published by The Wall Street Journal and were collateralized by the participant account balance. Repayment of principal and interest was typically made through payroll deductions.

Payment of Benefits:

On termination of service for any reason, benefits were paid to participants in a lump-sum cash distribution equal to the value of the participant account balance. Accounts between \$1,000 and \$5,000 could be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Benefits were recorded when paid.

Plan Expenses:

Several of the investment fund options were subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees were charged directly against the fund's investment performance and, thus, were not separately disclosed in the financial statements. Advisory services, as well as certain investment, account maintenance and note fees may be charged to participant accounts. All other administrative expenses related to the Plan were paid by the Company and were not reflected in the Plan's financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements were prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments:

The Plan's mutual funds were valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted prices in active markets. It was not probable the funds would be sold at amounts that differed materially from the NAV of shares held.

Fair Value Measurement:

The Plan used a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritized within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focused on an exit price and was defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments were not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement was defined as follows:

- Level I:** Inputs to the valuation methodology were quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level II:** Inputs to the valuation methodology included quoted prices for similar assets and liabilities in active markets, and inputs that were observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level III:** Inputs to the valuation methodology, which were significant to the fair value measurement, were unobservable.

A financial instrument's categorization within the fair value hierarchy was based upon the lowest level of input that was significant to the fair value measurement.

The Plan's mutual funds were classified as Level I within the fair value hierarchy through their disposition.

Income Recognition:

Purchases and sales of investments were recorded on a trade date basis. Interest income was recorded on the accrual basis of accounting. Dividends were recorded on the ex-dividend date. Net depreciation included gains and losses on the Plan's investments bought, sold or held during the year.

Ascensus, as the Plan's investment trustee, has certified the fair value of the following assets held at June 13, 2022, and the net loss for the period from January 1, 2022 through June 13 2022 , that were used in the preparation of the financial statements.

4. Income Tax Status

The Plan was a prototype plan offered by Ascensus, LLC. The Internal Revenue Service has determined and informed Ascensus, LLC by a letter dated June 30, 2020, that the plan submitted for review was qualified under applicable provisions of the Code. The Plan and the Plan sponsor believed the Plan was operated in compliance with the applicable requirements of the Code and related state statutes through its cessation date and was, therefore, qualified and the trust that formed a part of the Plan was exempt from federal and state income taxes.

GAAP require Plan management to evaluate income tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, through June 13, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes all Plan years after 2019 remain subject to income tax examinations.
