### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Slayton Wireless, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Slayton Wireless, LLC (the “Company”, “Plan Sponsor” or “Employer”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, which was originally established on January 1, 2012 and was amended most recently as of August 12, 2021 and covers all eligible employees of the Company. Effective with the August 12, 2021 amendment, an employee who has attained the age of 21 is eligible upon completion of 90 days of service, with quarterly entry dates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Participants can contribute up to 100% of pre-tax and/or post-tax compensation, up to the annual Internal Revenue Service (“IRS”) dollar limit. In addition, the Plan contains a catch-up option for participants who have attained age 50 before the end of the year permitting them to make additional elective deferral contributions up to the amounts limited by the IRS.

The Plan also has a Safe Harbor Match contribution. Safe Harbor Match contributions are made by the Company in an amount equal to 100% of deferrals up to the first 3% of Plan compensation, plus 50% of deferrals up to the next 2% of Plan compensation.

The Company may also make discretionary matching contributions and discretionary profit-sharing contributions as deemed appropriate. There were no discretionary contributions made for the year ended December 31, 2022.

Rollover contributions consist of amounts rolled over by participants from another qualified plan as defined by the Internal Revenue Code (“IRC”).

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Participants are also immediately vested in the Safe Harbor matching contribution. Plan participants acquire vested nonforfeitable interest in the Plan Sponsor’s discretionary matching and profit-sharing contributions according to the following schedule:

Forfeitures

As forfeitures become available, they shall first be used to pay any administrative expenses of the Plan. Any remaining forfeitures are used to reduce employer contributions. The Plan's forfeitures balance totals \$28,507 and \$24,962 at December 31, 2022 and 2021, respectively.

Participant Accounts

Separate accounts are maintained by the recordkeeper in the name of each participant. Participants direct their contributions and matching Plan Sponsor contributions to be invested into various investment options offered by the Plan.

Notes Receivable from Participants

The Plan allows for loans to participants from their individual account balances, which are limited to the lesser of \$50,000 or 50% of the participants' available balance, reduced by the excess of the highest outstanding loan balance of loans from the Plan to the participant during the one year period ending on the day before the date on which such loan was made. The loans have specific repayment schedules and interest rates at the Prime Rate plus 1%. Prior to the August 12, 2021 Plan amendment, interest rates were at the Prime Rate plus 0%. For deemed loan balances of inactive participants, the participant loan balance is reduced and a benefit payment is recorded.

Benefits

On termination of service, if a participant's account is less than \$5,000 the participant will receive a lump-sum amount equal to the value of his or her vested account balance. If the participant's account exceeds \$5,000, the participant may elect to defer distribution until a later date.

In the event of financial hardship, participants may apply to receive a distribution from their fund accounts, subject to IRS mandated rules for hardship withdrawals.

Termination Provisions

Although the Company has not expressed any intent to terminate the Plan, it reserves the right to do so at any time. In the event of termination, the accounts of the participants will be distributed in a manner determined by the Plan Administrator and in accordance with the provisions of the Plan.

Administrative Fees

The Plan pays all administrative fees, unless paid by the Company.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Fair Value Measurements

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Investment Valuation and Income Recognition

The Plan's investments in money market funds, mutual funds, and comingled funds are reported at fair value. The Plan's investment in the fully benefit-responsive guaranteed investment contract is reported at contract value, which approximated fair value as of December 31, 2022. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans and are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Repayments of principal and interest are recognized in the period in which payroll deductions are processed.

Reclassification

The classification of certain investments reported in Note 4 as of December 31, 2021 has been reclassified, in order to conform to the December 31, 2022 financial statement presentation.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Money market funds: Valued based on the underlying investments traded on the active market.
- Mutual funds: Valued at the closing prices reported on the active market in which the individual securities are traded.
- Commingled funds: the fair value of the underlying assets are used to determine the net asset value (NAV) of the funds. The NAV is used as a practical expedient to estimate fair value. This practical

expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methods. The investments listed above have no unfunded commitments and provide for daily redemption.

NOTE 5 - INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan has a traditional fully benefit-responsive investment contract with Voya Institutional Trust Company (“Voya”). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, transfers to and from other investment accounts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 6 - TAX STATUS

The Internal Revenue Service has issued an opinion letter dated June 30, 2020, that the prototype plan is a qualified plan under Section 401(a) of the Internal Revenue Code (“IRC”) and is exempt from tax under present income tax laws. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The prototype plan has been amended since receiving the opinion letter. However, the Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan’s qualified status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.

NOTE 7 - PARTY-IN-INTEREST

Certain Plan investments are shares of money market funds managed by the Trustees. There are also expenses paid to the Trustees deducted directly from investment earnings.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

In connection with certain transactions which occurred at the Plan Sponsor, effective January 1, 2023 the Plan was renamed the Alliance Mobile, 401(k) Plan. Concurrently, participants from the former MMS (Midwest Mobility Solutions) 401(k) Plan were merged into the Plan. The Plan is expected to continue as the ongoing successor.
