NOTE A - DESCRIPTION OF PLAN

The following description of The Stevinson 401(k) Plan & Trust ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Stevinson Automotive, Inc. and affiliated companies ("Company") whose employees are covered under the Plan and who have three months of service and are age twenty-one or older. Three months of service, in general, means a three consecutive month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participation in the Plan begins on the first day of the Plan month coinciding with or following the date eligibility requirements are met. The Trustee is responsible for oversight of the Plan. The Trustee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The plan was restated in 2015, and a new trustee was engaged, Great-West Trust Company, LLC.

On May 31, 2022, management elected to terminate The Stevinson 401(k) Plan and Trust. The plan's assets were distributed by September 30, 2022.

Investments

The Plan's investments were held in trust by Great-West Trust Company, LLC & Great-West Life & Annuity Insurance Company. The Plan's trust agreement requires the Trustee to invest the Plan's assets into various fund options as directed by each participant. Participants direct the investment of their contributions into various investment options offered by the Plan. An annuity contract is carried under the Key Guaranteed Portfolio Fund, which is a fixed annuity. The values are reported in this report. This fund is valued based on observable inputs.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan up to a maximum amount set under Internal Revenue Code limits. Contributions are subject to certain limitations. A condition of participation in the Plan is that an employee must contribute at least \$300 per year of compensation. The Company makes discretionary matching contributions to the Plan. Matching contributions were \$369,169 in 2022 and \$304,555 in 2021. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, as well as allocations of Plan earnings, and are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Participants who terminate employment forfeit any non-vested portion of their account. At September 30, 2022 and December 31, 2021, the balance held in the forfeiture account was \$ 0 and \$40,610. These accounts may be used to reduce future employer contributions. Forfeited nonvested accounts were \$18,436 and \$23,657 for the years 2022 and 2021 respectively. During the period of January 1, 2022 through September 30, 2022 forfeitures were utilized to reduce the employer contribution. The forfeitures were not utilized in 2021 and remained in a holding account in 2021.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The Company's matching contributions vested percentage are determined as follows:

Payments of Benefits

Upon termination of service due to death, disability, retirement or upon termination of employment, a participant may elect to receive the participant's vested interest in his or her account in a lump sum amount or annual installments. A participant's vested account balance is paid in a lump sum amount without the need for the participant's consent, upon termination due to attainment of retirement age or in the event the participant's vested account balance does not exceed \$5,000 and service is terminated due to death, disability, or termination of employment. Participant's may request an in-service distribution once attaining age 59 1/2 or for hardship as defined in the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in any investment options available under the Plan and its policies of the Trustee, Great-West Trust Company, LLC ("Trustee"). The investment alternatives available under the Plan include:

- (A) Vanguard Target Retirement
- (B) Various Mutual Funds
- (C) Various Janus Funds
- (D) Key Guaranteed Portfolio Fund
- (E) Invesco Equally WTD

Each of the investment alternatives, the objectives of each alternative, and the risk and return characteristics of each alternative, is described more fully and detailed in the investment information available from the Trustee. Participants may change their investment options quarterly.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As described in financial Accounting Standards Board Staff Position, FSP AAG INV-1 and SOP 94-4-1, Reporting of Fully Benefit-Responsive Investment Contracts Held by Certain Investment Companies Subject to the AICPA Investment Company Guide and Defined-Contribution Health and Welfare and Pension Plans (the FSP). Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. As required by the FSP, the Statements of Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis for fully responsive investment contracts.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the Plan's investment in the Key Guaranteed Portfolio Fund, which is valued at contract value, (approximates fair value). The fair value of investments is calculated by the Trustee, which values represent the net asset value of shares held by the Plan at year end. As more fully described in Note D, plan investments consist primarily of shares of mutual funds managed by the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments sold as well as held during the year.

Payment of Benefits

Benefits to participants are recorded when paid.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participant contributions. The Plan distributed \$0.00 in 2022 or 2021 excess contributions to the applicable participants.

NOTE C - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Key Guaranteed Portfolio Fund, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings and transfers in, less participant withdrawals, transfers out and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2022 and 2021, was \$ 0.00 and \$ 710,053 respectively. The average yield earned by the Fund for 2022 and 2021 was 0.0% and 0.90% respectively, while the actual average yield earned by the Fund for 2022 and 2021 was 0.0% and 0.90% respectively.

Certain events limit the Plan's ability to transact at contract value with Great West. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

As discussed in Note A, no investments were held as of September 30, 2022, as the Plan transferred all assets out of the Plan on September 30, 2022.

SFAS No. 157, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 3 inputs were available to the Plan, and Level 2 inputs were only used when Level 1 inputs were not available.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on quoted market values.

NOTE E - RELATED-PARTY TRANSACTIONS AND PARTY-IN INTEREST TRANSACTIONS

The Plan is invested in fixed and variable group annuity contracts managed by Great-West Life & Annuity Insurance Company. Great-West Life & Annuity Insurance Company is the trustee and record keeper for the Plan and, therefore, these transactions qualify as party-in interest transactions.

Great-West Life & Annuity Insurance Company, as the Plan's third party administrator, receives indirect compensation from investment fund providers for recordkeeping, administration, communication, and other shareholder services provided on behalf of the registered investment companies. Certain indirect compensation is offset against administrative expenses charged to the Plan.

If the revenue received by Great-West Life & Annuity Insurance Company from such fund providers exceeds the amount owed under the service agreement. Great-West Life & Annuity Insurance Company remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Plan Sponsor may make a payment to Great-West Life & Annuity Insurance Company for administrative expenses not covered by revenue sharing.

NOTE F - INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2021, net appreciation in fair value of investments and interest and dividends for the period from January 1, 2022 through September 30, 2022 and the year ended December 31, 2021, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by

NOTE G - PLAN TERMINATION

The Company sold the dealerships assets on December 6, 2021. The Company has the right under the Plan to discontinue or terminate the Plan subject to the provisions of ERISA, and the Company elected to terminate the Plan May 31, 2022; all active participants were considered 100% vested in their accounts. The Plan was terminated May 31, 2022 with all assets remaining having been transferred out of the Plan by September 30, 2022.

NOTE H - TAX STATUS

The Plan is intended to qualify under Internal Revenue Code Section 401(a) and the Trust created under the Plan is intended to be exempt under Internal Revenue Code Section 501(a). The Plan is a prototype plan called the Sherman and Howard Regional Prototype Defined Contribution Plan and Trust. Sherman and Howard has obtained an opinion letter from the Internal Revenue Service that the Plan qualifies under the Internal Revenue Code Section 401. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J - SUBSEQUENT EVENTS

The Company terminated the Plan May 31, 2022; all active participants were considered 100% vested in their accounts. Management has evaluated subsequent events through September 30, 2022, the date on which the financial statements were available to be issued. Any unallocated assets of the Plan should be allocated to participant accounts and in such a manner as the Company may determine.
