NOTE 1 – Plan description

The following brief description of the People Care Holdings, Inc. Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for complete information.

People Care Holdings, Inc., the Company and plan sponsor, established the People Care Holdings, Inc. Profit Sharing Plan effective as of January 1, 2007 in relevant part, as a leveraged employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by an independent fiduciary appointed by the Company.

The Plan purchased Company common shares using the proceeds of a bank borrowing guaranteed by the Company, and formerly held the stock in a trust established under the Plan. The Plan borrowing of funds from the Company was scheduled to be repaid over a period of twenty years by fully deductible Company contributions to the trust fund with prepayments of the loan available without penalty. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the Code. As of December 31, 2020, the contribution receivable that was paid in 2021 operated to pay the loan in full.

The Plan was amended and restated January 22, 2016 to incorporate into a single document all of the amendments to the plan since January 1, 2011 and reflect changes in the tax laws. The ESOP has been amended twice since the 2016 restatement. The ESOP was terminated on April 15, 2019.

The plan was terminated in 2022 and a final 5500 was filed.

Eligibility

Prior to the termination of the Plan, Employees of the Company and its participating subsidiaries were generally eligible to participate in the Plan after one year of service provided they worked at least 500 hours during such plan year and are at least 21 years of age. Participants who did not have at least 500 hours of service during such plan year or were not employed on the last working day of a plan year were generally not eligible for an allocation of company contributions for such year.

Notwithstanding the foregoing, Employees of the Company and its participating subsidiaries who are "Home-Care Aides" in the City of New York or in the counties of Nassau, Suffolk or Westchester in the State of New York were generally eligible to participate in the Plan after they completed at least one (1) Hour of Service during the plan

year and were eligible to share in the allocation of company contributions for each plan year in which they were credited with at least one (1) Hour of Service.

On Plan termination, no new participants were eligible to participate in the Plan.

Entrance dates for the plan were January 1 and July 1; the final entrance date prior to plan termination was January 1, 2019.

Payment of benefits

Prior to Plan termination, distributions from the Plan were not made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company and its participating subsidiaries and is vested in his or her Plan accounts.

Prior to Plan termination, distributions were made in cash or shares of stock.

Prior to Plan termination, under the provisions of the Plan, the Company was obligated to repurchase participant shares of company stock which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations.

Pass-Through Direction Voting rights

Prior to Plan termination, each participant was entitled to exercise certain pass-through direction voting rights attributable to the shares of company stock allocated to his or her stock account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee was required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries. See discussion of April 15, 2019 Plan Termination below.

Plan termination

The Company reserved the right to terminate the Plan at any time, subject to Plan provisions and such provisions were invoked on April 15, 2019 to terminate the Plan.

Participant accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Prior to the plan termination, each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non vested accounts based on contributions made by the Company. Only those participants who were eligible employees of the Company on the last day of the plan year received an allocation. Allocations of contributions are based on a participant's eligible compensation, relative to total eligible compensation.

Vesting

Prior to the plan termination, if a participant's employment with the Company ended for any reason other than retirement, permanent disability or death, he or she vested in the balances in his or her account based on total years of service with the Company. Participants vest 20% per year after two years of service and are 100% vested upon attaining six or more years of service. Upon termination of plan participants were fully vested.

Put option

Prior to the plan termination, under Federal income tax regulations, the employer stock that was held by the Plan and its participants and was not readily tradable on an established market, or was subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Prior to the plan termination, diversification was offered to active participants in accordance with the Plan document close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their stock account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

Contributions, participant accounts and forfeitures

Prior to the plan termination, discretionary contribution amounts were determined by the Board of Directors of the Company.

Employer contributions and Plan forfeitures are allocated to participant's accounts' based upon the relation of the participant's compensation to the total compensation for the Plan year of the participants for which the discretionary contribution was made to the Plan.

Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

Plan termination

On April 15, 2019, the Trustee the plan sold the stock of the company to an independent third party. The plan received \$50,000.00 for all 10,000,000 shares of Company Stock that the ESOP owned, plus a cash contribution in the aggregate amount of \$5,350,668, consisting of \$4,657,458 for the 2018 plan year and \$693,210 for the 2019 plan year for "Home-Care Aides" in the City of New York or in the counties of Nassau, Suffolk or Westchester in the State of New York. The Plan was terminated as of the date of the sale and all participant's balances became fully vested on that date. On September 6, 2019, a request was submitted to the Internal Revenue Service to confirm the qualification of the Plan on termination. At Plan termination, the plan's name changed to the People Care Holdings, Inc. Profit Sharing Plan and Trust. Participants have been offered partial distributions from the Plan pending the review by the Internal Revenue Service and all assets of the Plan are currently in the process of being distributed to participants following the receipt of a favorable determination letter from the Internal Revenue Service on April 29, 2020.

NOTE 2 – Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The common shares of the Company were valued at fair value on April 15, 2019. Fair value was determined by annual independent appraisal.

Operating expenses

The Trust paid \$242,485 in administrative expenses in the year ended December 31, 2022.

NOTE 3 – Tax status

The Internal Revenue Service has determined and informed the company by a letter, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Internal Revenue Service has further determined on April 29, 2019 that the termination of the plan operates in accordance with applicable sections of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2014, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes that it is no longer subject to income tax examinations for years prior to 2013.

NOTE 4 – Administration of plan assets

The Plan assets consisted of the interest-bearing cash and cash equivalents and investments at Wilmington and UBS.

Company contributions were received and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

NOTE 5 – Fair value measurements

Financial Accounting Standards Board Codification Section 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB Codification Section 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets

Level 2

Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2020.


