Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the MoLo Solutions 401(k) Plan (the "Plan") provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution profit sharing and 401(k) plan covering eligible employees of MoLo Solutions, LLC (f/k/a DJM Logistics, LLC) (the "Company"). Employees are eligible to participate upon completion of one month of service and attaining age 21 (Note H-1). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

2. Contributions

The Plan is funded by voluntary pre-tax and Roth contributions of participants and discretionary matching and profit sharing contributions of the Company (Notes H-2, H-3 and H-4). Participants may contribute to the Plan, through regular payroll deductions, and participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also roll over amounts representing distributions from other qualified employee benefit plans. The Company has provided discretionary matching contributions of \$576,219 to the Plan for year ended December 31, 2022. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

3. Investment Options

Participants must direct their salary deferral contributions and the Company's contributions into a variety of investment options made available and determined by the Investment Committee. Participants may change their investment options at any time.

4. Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions (Note H-4), and an allocation of plan earnings. The Company's discretionary matching contribution is allocated based on a percentage of the participant's contribution. The Company's discretionary profit sharing contribution is based on a ratio of each eligible participant's compensation to total compensation for all eligible participants (Note H-3). Plan earnings are allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

5. Vesting

Participants are immediately fully vested in participant and rollover contributions plus the actual earnings thereon. The portion of the participants' accounts attributable to the Company's contributions becomes 25% vested after one year of service and continues to vest at the rate of 25% for each successive year until 100% vested after four years of service. In the event of death or disability, participants become fully vested (Note H-5).

6. Payment of Benefits

On termination of service, including death/disability and normal retirement, a participant may elect to receive a single, lump-sum payment equal to the value of his or her vested account balance, or a direct rollover distribution. In service withdrawals are permitted to participants who have reached age 59 1/2 and hardship withdrawals are also permitted by the Plan.

7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants are permitted to take loans from the Plan up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are collateralized by the borrowers' respective vested account balances and bear interest at 4.25% to 8.50%. Principal and interest are paid through payroll deductions over a period not to exceed five years, unless for the purchase of a primary residence.

8. Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net depreciation in fair value of investments.

9. Forfeitures

At December 31, 2022 and 2021, unallocated plan assets resulting from forfeited nonvested accounts totaled \$26,548 and \$10,410, respectively. These accounts will be used to reduce future discretionary Company contributions. Forfeitures of \$21,768 were used to reduce discretionary Company contributions related to the Plan year ended December 31, 2022.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note B-2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

4. Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

NOTE C - INFORMATION CERTIFIED BY RELIANCE TRUST COMPANY

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the "Trustee" of the Plan).

NOTE D - TAX STATUS

Effective January 1, 2022, the Plan adopted a standardized pre-approved plan sponsored by the Trustee (Note H). The pre-approved plan have received opinion letters from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is currently and was previously designed and being operated in compliance with the applicable provisions of the Internal Revenue Code ("IRC").

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants may become fully vested in their respective account balances (Note K).

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by the Trustee, as defined by the Plan, and T. Rowe Price, the recordkeeper; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

The Plan issues loans to participants, which are secured by the vested balance in the participant's accounts and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest. Employees of the Company provide administrative services to the Plan for which no fees are charged.

**NOTE H - PLAN AMENDMENT, RESTATEMENT AND SUBSEQUENT EVENTS**

Effective January 1, 2022, the Plan was amended and restated to be in compliance with the most recent IRS cycle requirement.

Effective January 1, 2023, the Plan was amended and restated. The Plan was changed to mirror the plan document of the Company's new plan sponsor (Note K). The significant changes include the following:

1. **Eligibility**

Eligible participants are defined as each employee of the company with the "casual employee" being excluded as defined by the amendment as well as collective bargaining unit and leased employees being excluded as well. Eligible employees shall not be subject to an age or service requirement for elective deferrals.

2. Contributions

Catch-up contributions and student loan repayment amounts are specifically excluded from matched employee contributions.

3. Discretionary Profit Sharing Contributions

In order to share in the allocation of discretionary profit sharing contributions, the participant must complete at least one thousand (1,000) hours of service for the Company during such Plan year and either (a) remain an employee on the last day of such Plan year, or (b) incur a termination of employment during such Plan year on account of death, disability, or after attaining normal retirement age.

4. Other Contributions

The Company may elect to make special DC deposits in the sole discretion of the Company to those Participants who (a) remain an employee on the last day of the Plan year, or (b) incur a termination of employment during such Plan year on account of death, disability, attaining normal retirement age, or attaining age fifty-five (55) with at least ten (10) years of vesting service. An employee who has incurred a termination of employment after attaining normal retirement age or age fifty-five (55) with at least ten (10) years of vesting service must be a participant in the Plan during the Plan year for not less than ninety (90) days prior to the employee's termination of employment in order to be eligible for a special DC deposit.

5. Vesting

Year of vesting service shall mean a period of time of three hundred sixty five (365) days under the elapsed time method. In addition, discretionary matching contributions, discretionary profit sharing contributions and special DC deposits shall vest based upon the participant's number of years of vesting service prior to the participant's termination of employment. Less than 3 years, vesting remains at 0%. Three or more years, vesting is 100%.

Significant provisions of these amended and restated plan documents are consistent with those of the current plan document, other than disclosed above. Interested parties should refer to the most recent plan document for a more complete description of the Plan's provisions.

NOTE I - PROHIBITED TRANSACTIONS

The Plan Sponsor failed to deposit participant contributions within the required timeframe as stated by the Department of Labor ("DOL"). The DOL considers late deposits to be prohibited transactions as disclosed in the accompanying supplemental information. The Plan has corrected these deficiencies in 2022 as disclosed in the accompanying supplemental schedule.

NOTE J - EXCESS CONTRIBUTIONS PAYABLE

Excess contributions payable represents amounts withheld from participants in excess of IRS limitations that are to be refunded at year end. As of December 31, 2022 and 2021, \$21,321 and \$17,849, respectively, of excess contributions are required to be refunded prior to December 31, of the subsequent year. Excess contributions are adjusted against contributions in the statement of changes in net assets available for benefits.

NOTE K - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through October 10, 2023, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions, except those disclosed in Note H and below, have occurred subsequent to the statement of net assets available for benefits date that require disclosure in the financial statements.

On April 24, 2023 the Investment Committee of the Plan, voted to merge the Plan via merger into the ArcBest 401(k) and DC Retirement Plan (the "New Plan"). As a result, the Investment Committee determined liquidation was imminent in the 2023 plan year. On June 1, 2023, the Plan assets totaling approximately \$7,755,000 were transferred to the New Plan. The participants' vested account balances in the New Plan equaled the vested account balances in this Plan upon the transfer. The merger does not impact participant benefits as the benefit provisions were incorporated into the New Plan. Interested parties should refer to the New Plan's adoption agreement and plan document for a complete description of the New Plan.
