As further discussed in Note 8 to the financial statements, Advanced Urology Institute, LLC, the Plan's sponsor, terminated the Advanced Urology Institute 401(k) Plan effective February 28, 2022, and management determined liquidation was imminent. As a result, the Advanced Urology Institute 401(k) Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Advanced Urology Institute 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Advanced Urology Institute 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Advanced Urology Institute 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Advanced Urology Institute 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General:

The Plan was a defined contribution plan covering substantially all employees of Advanced Urology Institute, LLC (the “Company”), who had attained age 21 and completed 12 months and 1,000 hours of service. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company terminated the Plan effective February 28, 2022. On termination, participants became fully invested in their discretionary matching and profit-sharing contributions and the benefits were paid to the participants.

Contributions:

Each year, participants could contribute a percentage of their gross annual compensation, subject to certain limitations. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company made safe harbor matching contributions equal to 3% of included compensation. Discretionary matching and profit-sharing contributions could be made at the option of the Company. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered a common/collective trust fund, mutual funds, and a self-directed brokerage account. The self-directed brokerage account allowed participants to invest their account balances in a wide range of publicly traded investments beyond those available in the core investments of the Plan. Certain participants also held investments in common stock under a custodial arrangement with Raymond James.

Participant Accounts:

Each participant’s account was credited with the participant’s contribution, any employer contributions and an allocation of Plan earnings, and charged with withdrawals, administrative expenses, and an allocation of Plan losses. Allocations were based on the participant’s account balances and contributions, as defined. Participants could choose to invest their accounts in one or more funds established by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Vesting:

Participants were immediately fully vested in their voluntary contributions and Company safe harbor contributions plus actual earnings thereon. Participants became vested in discretionary matching and profit-sharing contributions based on a 6-year graded vesting schedule. However, participants become fully vested in employer contributions upon disability or death.

Notes Receivable from Participants:

Participants who had outstanding participant loans that were originated under the Central Florida Urology Specialists, LLC 401(k) Plan transferred outstanding loan balances to this Plan in 2014 in accordance with procedures established by the Plan administrator. Plan participants could not apply for a new loan from the Plan.

Forfeitures:

Forfeitures of terminated participants' non-vested matching and profit-sharing contributions were used to offset future employer profit-sharing or matching contributions or pay Plan expenses if the Company elected not to pay such expenses directly. No plan expenses were paid from this account during 2022. In 2022, employer contributions were reduced by \$44,236 from forfeited non-vested accounts. There were no unallocated forfeitures at December 31, 2022. At December 31, 2021, unallocated forfeitures totaled \$42,736.

Payment of Benefits:

Upon termination of service or retirement, or upon attainment of age 59½, participants received their benefits in the form of a lump-sum distribution or installment payments. A participant could also request a distribution in case of hardship as detailed in the Plan provisions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared on the liquidation basis of accounting as of and for the year ended December 31, 2022. The financial statements of the Plan are prepared on the accrual basis of accounting as of December 31, 2021.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants:

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan. Interest income on notes receivable from participants was recorded when earned.

Valuation of Investments and Income Recognition:

The Plan's investments were stated at fair value. If available, quoted market prices were used to value investments. Investments that have no quoted market price were stated at estimated fair value. The self-directed brokerage account invested in publicly traded securities that were valued at fair value based on quoted market prices.

Investment income was recorded as earned. Purchases and sales of investments were accounted for on a trade-date basis. Dividends were recorded on the ex-dividend date.

The Plan presented the net appreciation/depreciation in the fair value of its investments, which consisted of realized gains or losses and the unrealized appreciation or depreciation of those individual investments.

Payment of Benefits:

Benefits were recorded when paid.

Administrative Expenses:

Administrative expenses were paid by the Plan or the Company as provided in the Plan document.

Subsequent Events:

Management has evaluated subsequent events through October 9, 2023, which is the date the financial statements were available to be issued.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

The Plan held investments managed by T. Rowe Price Trust Company, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. No investments were held by this party at December 31, 2022. The fair value of the investments held by this party at December 31, 2021 totaled \$18,021,504.

NOTE 5 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, defines fair value, establishes a framework for measuring fair value, and requires disclosures about fair value measurements. The guidance establishes a fair value hierarchy about the assumptions used to measure fair value and clarifies assumptions about risk and the effect of a restriction on the sale or use of an asset.

ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

Three levels of inputs may be used to measure fair value:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, and other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect a plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for financial instruments measured at fair value:

Common/collective trust fund: Value was derived from the fair value of the underlying securities based on quoted market prices in active or inactive markets.

Self-directed brokerage account: Account primarily consisted of cash, common stock, mutual funds, and exchange-traded funds that were valued based on the closing price reported on the active market where the individual securities were traded.

Common stock: Valued was the investee company's book value, which approximated fair value.

Mutual funds: Valued was the net asset value ("NAV") of shares held by the Plan at year end.

NOTE 6 - INCOME TAX STATUS

The Plan used a defined contribution volume submitter basic plan document sponsored by Hill Ward & Henderson Professional Association (“HWH”). HWH received an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, which stated that the pre-approved document satisfied the applicable provisions of the Internal Revenue Code (“IRC”). The Plan itself had not received a determination letter from the IRS. The plan document had been amended since receiving the opinion letter to comply with the regulations required by law. However, the Plan’s management believes that the Plan was designed and was operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - PLAN TERMINATION

Effective February 28, 2022, the Company exercised its right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants became 100% vested in their discretionary matching and profit-sharing contributions. The Plan trustee was directed to distribute the remaining net assets available for benefits to eligible participants. The net assets of the Plan were distributed, in accordance with Plan provisions, to the participants. Plan participants were given the option to roll over balances to a qualified plan or individual retirement account (“IRA”) or take a cash distribution.


