Our opinion is not modified with respect to this matter.

#### **Note 1 - Description of plan:**

The following description of the Sac ProFloors (the “Company”) 401k Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. *General* - The Plan is a defined contribution plan covering substantially all employees of the Company. Except for excluded employees, all employees who have reached six months of service are eligible to participate in the Plan. Entry into the Plan occurs on the first day of the month following the date an employee meets the eligibility requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established as of January 1, 2021. The Plan trustees are responsible for oversight of the Plan, including the appropriateness of the Plan’s investment offerings and investment performance.
- b. *Plan termination* - On July 27, 2022, the Company adopted a resolution to terminate the Plan. The Plan was terminated on September 30, 2022. Upon termination, all participant accounts became 100% vested. The net assets were distributed to participants. Participants chose amongst several options regarding the type of distribution. Participants elected a lump sum payment or an individual retirement account rollover. Plan distributions were completed by the final Plan short period-end of November 30, 2022. No liabilities were recognized in connection with the termination.
- c. *Contributions* - Each period, participants may contribute to the Plan, in the form of employee 401(k) salary deferral contributions (pre-tax 401(k) and Roth 401(k) deferrals), up to the lesser of 90% of eligible compensation or the maximum amount allowable by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan period are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans, commonly referred to as rollovers. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are presented net of corrective distributions which consist of excess participant contributions refunded to participants during or subsequent to the Plan period. Corrective distributions related to participant contributions were approximately \$13,000 and \$35,000 for the periods ended November 30, 2022 (in liquidation) and December 31, 2021 (ongoing), respectively.

#### **Note 1 - Description of plan (continued):**

*Contributions (continued)* - The Company makes employer matching contributions equal to 50% of the participant's elective deferrals, with a maximum limit at 2% of a participant's compensation to be determined by the employer each pay period. Contributions are subject to certain limitations. Employees must be actively employed at the end of the pay period, have completed at least six months of service, and be actively contributing employee 401(k) salary deferrals in order to be eligible to share in the allocation of matching contributions. The Company made matching contributions of approximately \$38,000 and \$35,000 for the periods ended November 30, 2022 (in liquidation) and December 31, 2021 (ongoing), respectively. Contributions are presented net of corrective distributions which consist of excess matching contributions refunded to participants during or subsequent to the Plan period. Corrective distributions related to matching contributions were approximately \$12,000 for each of the periods ended November 30, 2022 (in liquidation) and December 31, 2021 (ongoing). Contributions are also presented net of forfeitures applied during the Plan period, which are disclosed in section h. of Note 1.

- d. *Participant accounts* - Each participant's account is credited with the participant's contribution and discretionary Company matching contributions as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e. *Vesting* - Participants are immediately vested in their deferral contributions, rollover contributions, and qualified non-elective contributions, plus actual earnings thereon. Vesting in the Company's matching contributions is subject to a five-year period at 25% per year of continuous service from years two through five. Upon Plan termination, all participant accounts became 100% vested.
- f. *Notes receivable from participants* - Participants may borrow from their fund accounts from a minimum of \$500 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Note receivable repayment terms generally may not exceed five years, except in the case of the purchase of a primary residence. The notes receivable are secured by the balances in the participants' accounts. The notes receivable interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

#### **Note 1 - Description of plan (continued):**

- g. *Payment of benefits* - Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 59 ½. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the Internal Revenue Code (“IRC”). Payments are made in the form of a lump-sum distribution or annual installments over a period of time of not more than the participant’s life expectancy. If the value of the vested account balance did not exceed \$5,000, then a lump-sum distribution would be made automatically.
- h. *Forfeited accounts* - Any forfeiture would be first used to reduce administrative expenses. Any remaining forfeitures would then be used to reduce employer contributions. For the period ended November 30, 2022 (in liquidation), the Plan Administrator applied approximately \$1,000 in forfeitures to employer contributions. For the period ended December 31, 2021 (ongoing), the Plan Administrator applied no forfeitures to employer contributions. There are no forfeitures remaining in the Plan as of the periods ended November 30, 2022 (in liquidation) and December 31, 2021 (ongoing).

#### **Note 2 - Summary of significant accounting policies:**

Basis of accounting - The accompanying financial statements of the Plan are prepared using the liquidation basis of accounting for the period ended November 30, 2022 (in liquidation) and the accrual basis of accounting for the period ended December 31, 2021 (ongoing) in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of estimates - The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

#### **Note 2 - Summary of significant accounting policies (continued):**

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed as they are incurred. No allowance for credit losses has been recorded as of November 30, 2022 (in liquidation) and December 31, 2021 (ongoing). If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess contributions payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed 2022 excess contributions to the applicable participants prior to November 30, 2022, therefore no payable was deemed necessary for the respective period-end. The Plan distributed the 2021 excess contributions to the applicable participants prior to March 15, 2022.

Payment of benefits - Benefit payments to participants are recorded when paid. At November 30, 2022 (in liquidation) and December 31, 2021 (ongoing), there were no distributions approved that were not disbursed prior to period-end.

Administrative expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events - Subsequent events are evaluated through the date of the independent auditors' report, which is the date the financial statements were available to be issued and determined that no material subsequent events require an estimate to be recorded or disclosed as of the period ended November 30, 2022 (in liquidation).

#### **Note 3 - Fair value:**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### **Note 3 - Fair value (continued):**

- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in techniques used for assets measured at fair value.

- *Mutual funds:* Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a calculation of value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies of assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's assets within the fair value hierarchy were entirely composed of level 1 mutual funds at December 31, 2021 (ongoing).

#### **Note 4 - Certified investments:**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2021 (ongoing), and net appreciation (depreciation) in fair value of investments, interest and dividend income, and interest income on notes receivables from participants for the periods ended November 30, 2022 (in liquidation) and December 31, 2021 (ongoing), was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company ("Reliance"), the trustee of the Plan.

#### **Note 5 - Party-in-interest transactions:**

Certain Plan investments are units in mutual funds managed by Reliance. Reliance is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Reliance provides certain administrative services to the Plan pursuant to an agreement between the Company and Reliance. Reliance receives revenue from mutual fund service providers for services that Reliance provided to the funds. This revenue is used to offset certain amounts owed to Reliance for administrative services to the Plan.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. If the revenue received by Reliance from such mutual fund service providers exceeds the amount owed under the agreement, Reliance remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or the Sponsor may make a payment to Reliance for administrative services not covered by revenue sharing.

Notes receivable from participants represent a portion of the Plan's receivables. These transactions also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
