### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of MISCOR Group 401(k) Plan & Trust (“Plan”) subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



## NOTES TO FINANCIAL STATEMENTS

### MISCOR Group 401(k) Plan & Trust

#### **1 Description of Plan**

The following description of the MISCOR Group 401(k) Plan & Trust (“Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### ***General:***

The Plan is a defined contribution plan covering all employees of IES Subsidiary Holdings, Inc. dba MISCOR Group (“Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective July 1, 2020, the Plan was amended to merge the Plant Power & Control Systems 401(k) Plan into the MISCOR Group 401(k) Plan & Trust. The assets of the Plant Power & Control Systems 401(k) Plan were transferred into the Plan in July 2020. Effective April 1, 2021, the Plan was amended to merge the Wedlake Fabricating, Inc. 401(k) Profit Sharing Plan into the MISCOR Group 401(k) Plan & Trust. The assets of the Wedlake Fabricating, Inc. 401(k) Profit Sharing Plan were transferred into the Plan in April 2021.

Effective January 1, 2022, the Plan was amended and restated to bring it into compliance with the legislative and regulatory changes set forth in Internal Revenue Service (“IRS”) Notice 2017-37.

Effective January 1, 2023, the Plan was merged into the IES Holdings, Inc. Retirement Savings Plan.

##### ***Eligibility:***

All employees under the Company, except for collective bargaining employees, non-resident aliens, reclassified employees, leased employees, independent contractors, and participants in the MISCOR Bargaining Units 401(k) Plan & Trust, are eligible as of their date of hire.

##### ***Contributions:***

Cash or Deferred option [401(k)] – Participants may elect up to 100% of their compensation to be contributed to the Plan by the Company. Roth and catch-up contributions are permitted in the Plan.

Employer Matching Contributions – The Company may make discretionary contributions to eligible participants. For 2022 and 2021, the Company contributed 40% of the first 6% of salary deferrals.

Qualified Non-Elective Contributions – The Company may also make a qualified non-elective contribution on a discretionary basis. This additional contribution, if any, will be allocated to only non-highly compensated participants in proportion to each eligible employee’s compensation as a ratio of all eligible employees’ compensation.

The Company may also make additional profit-sharing contributions. Such additional contributions, if any, shall be allocated to each participant in proportion to his or her compensation for the calendar year. The Company did not make any qualified non-elective or profit-sharing contributions in 2022 or 2021.

**1 Description of Plan, Continued**

***Contributions, Continued:***

Rollover contributions from other plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitation imposed by the Internal Revenue Code, as defined by the Plan agreement.

***Participants' Accounts:***

401(k) Accounts – Each participant's account is credited with the participant's elective contributions, employer matching contributions, earning and losses thereon.

***Vesting:***

All participants are 100% vested in elective deferrals.

Vesting in the participant's matching contribution, profit sharing contribution and non-elective contribution account balance is based on years of service as follows:

Years of Service	Vested %
0 - 2	0%
3	100%

***Forfeitures:***

As of December 31, 2022 and 2021, forfeited non-vested accounts totaled \$0. Forfeitures may be used to reduce future employer contributions or administrative fees incurred by the Plan.

***Notes Receivable from Participants:***

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed five years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2022. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

***Other Plan Provisions:***

Normal retirement age is 65. The Plan provides early payment of benefits after reaching age 59 ½.

### MISCOR Group 401(k) Plan & Trust

#### **1 Description of Plan, Continued**

##### ***Payment of Benefits:***

Upon termination of service by reason of retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account.

##### ***Hardship Withdrawals:***

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

##### ***Investment Options:***

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

#### **2 Summary of Significant Accounting Policies**

##### ***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting.

##### ***Valuation of Investments:***

Investments (except for fully benefit responsive contracts, which are recorded at contract value) are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair value (contract value) of the guaranteed investment contract is based on the underlying principle contributions to the contract plus its stated interest rate.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### ***Administrative Fees:***

All expenses of the Plan are paid by the Company to the extent that they are not paid by the Plan.

## 2 Summary of Significant Accounting Policies, Continued

### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### *Risks and Uncertainties:*

The Plan's investments include investments in mutual funds, money market, and a guaranteed investment contract with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets available for Plan Benefits.

### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 28, 2023, which is the date the financial statements were available to be issued.

## 3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets.
- \* Quoted prices for identical or similar assets or liabilities in inactive markets.
- \* Inputs other than quoted prices that are observable for the asset or liability.
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**3 Fair Value Measurements, Continued**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

***Mutual Funds & Money Market Account:***

The fair value of the mutual funds are based on quoted market prices. The fair value of the money market account is based on high-quality, short-term money market instruments issued by the U.S. government and its agencies and instrumentalities. The mutual funds and money market account are classified in the Level 1 category of the valuation hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022 and 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement. There were no assets that fell within Level 2 or 3 of the valuation hierarchy.

**4 Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2022, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### 6 Party-in-Interest Transactions

The Plan pays fees to MG Trust Company, LLC (“Custodian”) and CUNA Mutual Retirement Solutions for third party administration over the Plan and, as defined by the Plan, these transactions qualify as party-in-interest. Usual and customary fees were paid by the funds for the administrative services. In addition, the Plan has arrangements with various service providers and these arrangements qualify as party-in-interest transactions.

#### 7 Benefit-Responsive Contract

The Plan holds a guaranteed investment contract with CUNA Mutual Group. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The Guaranteed Annuity Contract is a fixed, group annuity contract issued by CUNA Mutual Group Life (“CMFG”). A new guaranteed interest rate and period apply to each payment. Interest is applied on annual basis. Any stated interest rate may not have been adjusted to reflect Plan administration, transaction or contract fees. Certain contract fees are currently waived. All guarantees are subject to the ability of CMFG Life to honor such guarantees.

#### **7 Benefit-Responsive Contract, Continued**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan's failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code, (2) the establishment of a defined contribution plan that competes with the Plan for employee contributions, (3) any substantive modification of the Plan or the administration of the Plan that is not consented to by the wrap issuer, (4) complete or partial termination of the Plan, (5) any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on a portfolio's cash flow, (6) merger or consolidation of the Plan with another plan, the transfer of assets to another plan, or the sale, spin-off or merger of a subsidiary or division of the Plan Sponsor, (7) any communication given to participants by the Plan Sponsor or any other Plan fiduciary that is designed to induce or influence participants not to invest in a portfolio or to transfer assets out of a portfolio, (8) exclusion of a group of previously eligible employees from eligibility in the Plan, (9) any early retirement program, group termination, group layoff, facility closing, or similar program, and (10) any transfer of assets from a portfolio directly to a competing option. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants is probable.

The issuer may terminate the contract for cause at any time.
