Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Responsibilities of Management for the Financial Statements

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: Description of Plan

The following description of the Athenix Cyber & SIGINT Solutions, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan was established on April 1, 2022. Athenix Cyber & SIGINT Solutions, LLC is the plan sponsor and administrator and responsible for all plan oversight.

General

The Plan is a defined contribution plan covering substantially all employees of Athenix Cyber & SIGINT Solutions, LLC and subsidiaries (“Athenix” or the “Companies”) who are eighteen years of age or older. The Plan excludes union employees, and nonresident aliens. Participants can enter the plan immediately upon reaching the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Administrators are responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute pre-tax and after-tax annual compensation as defined in the Plan up to the limits of the Internal Revenue Code as defined in the Plan. Participants may defer a maximum of 75% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover).

Participants direct the investment of their contributions into various investment options offered by the Plan. Athenix contributes a safe harbor matching contribution. The safe harbor contribution is equal to 100% of participant deferrals up to 4% of the participant’s compensation. For the nine month period ended December 31, 2022, the Companies made \$565,706 of safe harbor contributions into the Plan.

In addition, every year Athenix may make discretionary profit sharing contributions. In order to receive a portion of the profit-sharing contribution, participants that are employed at year end or terminated due to retirement or because of death or disability must have completed 1000 hours of service. For the nine month period ended December 31, 2022, Athenix elected not to make a profit sharing contribution. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Note 1: Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Companies' discretionary matching and profit-sharing contributions, if any, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances within the elected investments.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all contribution types plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their total vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest in the Plan. The notes are secured by the balance in the participant's account. The notes bear a reasonable rate of interest based on rates available for similar loans from commercial lending institutions. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump-sum amount equal to the balance of the participant's vested interest in his or her account. An involuntary distribution can be made at the Plan's discretion for participants that have terminated service and that have an account with a vested balance of less than \$5,000. An in-service distribution may be taken by any participant that has attained the age of 59 and 1/2. The Plan allows for participants to take a hardship distribution from their account balance of pre-tax or after-tax deferrals. Hardship withdrawals cannot be in excess of the amount of their immediate and heavy financial need.

Plan Transfer of Net Assets to New Plan

Effective December 31, 2022, the Companies announced the merger of the Plan and intention to transfer existing account balances into a successor plan, Athenix Solutions Group, LLC 401(k) Plan. Participants were eligible to participate in the new plan immediately.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contributions to the applicable participant subsequent to March 15, 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Note 2: Summary of Significant Accounting Policies (Continued)

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

For the nine month period ended December 31, 2022, the plan administrator has evaluated subsequent events for potential recognition and disclosure through October 13, 2023 the date the financial statements were available to be issued.

Note 3: Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the nine month period ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the trustee of the Plan).

Note 4: Tax Status

The IRS has opined and informed the Companies by letter dated September 21, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan may be subject to a routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 6: Party-in-Interest Transactions

Certain Plan investments are mutual funds managed by Schwab Retirement Plan Services, Inc. Charles Retirement Services is the recordkeeper of the Plan and therefore, these investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment administrative services are included in the net depreciation in the fair value of the investments. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7: Reconciliation of Financial Statements to Schedule H of Form 5500

As previously disclosed in Note 1, the Plan merged into a new plan effective December 31, 2022, with all participants immediately participating in the new plan. The assets were not officially transferred into the new plan until 2023 and the 5500 was prepared based on when the assets were physically transferred. The financial statements were prepared based on the merger effective date, which is the date the assets are legally part of the new plan. This results in a reconciliation between the 5500 and the audited financial statements.
