**INDEPENDENT AUDITOR'S REPORT**

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We were engaged to perform an audit of the financial statements of **Qualawash Holdings, LLC 401(k) Retirement Plan II** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of the years ended December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

The following description of Qualawash Holdings, LLC 401(k) Retirement Plan II (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution QACA safe harbor plan that was established effective January 1, 2019 and most recently restated effective January 1, 2022 to bring the Plan into compliance with IRS Notice 2017-37. The Plan covers certain employees of Qualawash Holdings, LLC and its participating employers (collectively, the “Company” or the “Employer”). Employees who are age 21 or older and have completed 60 days of service are eligible to participate unless they are classified as a leased employee, a part-time employee or are nonresident aliens. Additionally, employees hired before January 1, 2019 or whose company was purchased by or merged with Qualawash Holdings, LLC before January 1, 2019 are also excluded from participating in the Plan. Employees become participants on the first day of the month coinciding with or next following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective as of December 31, 2022, the Plan was amended to authorize the merger of the Qualawash Holdings, LLC 401(k) Retirement Plan II into the Qualawash Holdings, LLC 401(k) Retirement Plan. On December 31, 2022, the Plan assets of Qualawash Holdings, LLC 401(k) Retirement Plan II in the amount of approximately \$4,150,000 were transferred into Qualawash Holdings, LLC 401(k) Retirement Plan.

#### Administration

The Plan is administered by the Company. The Plan's assets for the year were maintained and administered by Massachusetts Mutual Life Insurance Company and Empower (the “Trustees”). Empower acquired MassMutual's retirement plan business in January 2021, and began converting customer accounts over to the Empower platform. The Plan's assets were transferred in 2022. The Plan's recordkeeping services, and maintenance of participant account records are managed by the Trustees.

#### Contributions

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. Participants are automatically enrolled into the Plan at a deferral percentage based on their years of service, unless they complete a salary deferral agreement to elect an alternative deferral amount or to elect not to defer. The maximum participant deferral for the year ended December 31, 2022 was \$20,500. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service (“IRS”) limitations of \$6,500 for the year ended December 31, 2022. Participants may also make Roth contributions as well as contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan.

For the year ended December 31, 2022, the Company made QACA safe harbor matching contributions at a rate of 100% of elective deferrals for the first 1% of the participant's compensation and 50% of elective deferrals between 1% and 6% of the participant's compensation.

Each Plan year, the Company also has the option to make discretionary matching and non-elective profit sharing contributions. For the year ended December 31, 2022, the Company did not elect to make discretionary contributions to the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching contribution. Each participant's account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant's account. Allocations of Plan earnings or losses are based on each participant's investment fund balance in proportion to the total investment fund balance.

#### Vesting

Participants are vested immediately in their contributions, rollovers, and actual earnings or losses thereon. Participants are also immediately vested in Employer safe harbor matching contributions. Vesting in Employer QACA safe harbor matching contributions have a 2 year cliff vesting period for participants hired after January 1, 2020. Vesting in non-elective Employer contributions and Employer matching contributions is based on years of continuous service. A participant is 100% vested upon reaching 55 years of age, death, disability, or after four years of credited service as follows:

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable. The maximum note repayment period is five years unless the note is for the purchase of a primary residence in which case the repayment schedule may be for a term in excess of five years. These loans are collateralized by the balance in the participant's account and bear interest of 1% above the Prime rate. Principal and interest are paid by payroll deduction in substantially equal payments over the life of the loan, with payments not less frequently than weekly.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan will be treated as a taxable distribution based upon terms of the Plan document.

#### Distribution of Benefits

After age 59 ½, upon termination of service due to death, as a qualified reservist, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals or installments paid over various periods, as defined in the Plan agreement, less any applicable taxes. Participants may request a hardship withdrawal from their accounts using only participant deferral balances for distribution.

#### Forfeitures

Forfeitures occur when a participant terminates employment and has not vested in a portion of the Company's contribution amount. Forfeitures may be applied to reduce Employer contributions and Plan expenses. Forfeited non-vested accounts totaled approximately \$0 as of December 31, 2022 and 2021, respectively. No forfeitures were used during the year ended December 31, 2022.

### Note B – Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“US GAAP”).

#### Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

#### Valuation of Investments

The Plan’s investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as described in Note F. Quoted market prices are used to value investments. Shares of pooled separate accounts are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Payment of Benefits

Benefit payments to participants are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

#### Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described in the following page.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Pooled separate accounts:* Valued at the net asset value ("NAV") provided by the Trustees. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2022 and 2021. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Investments measured using the NAV as a practical expedient are exempt from being presented in the fair value hierarchy. As all of the Plan's investments as of December 31, 2022 and 2021 are exempt from the fair value hierarchy, the table has been excluded.

### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustees, qualified institutions. For the year ended December 31, 2022, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Trustees, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Income Tax Status

The underlying standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the written form of the underlying prototype document is qualified under Section 401(a) of IRC, and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note E – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or participants of the Plan, any person who provides services to the Plan, or an Employer whose employees are covered by the Plan. Certain Plan investments were managed by the Trustee. Transactions related to these investments qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$14,000 during the year ended December 31, 2022.

As of December 31, 2021, the Plan invested in a guaranteed interest account (Fixed account, “the Fund”). The Fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. As described in Note B, because the Fund is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the Fund. The investment is included in the financial statements at contract value as reported to the Plan by the Fund. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Fund issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan,) (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exempt under ERISA. The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

### **Note G – Subsequent Events**

Subsequent events have been evaluated through October 5, 2023, which is the date the financial statements were available to be issued.
