## INDEPENDENT AUDITORS' REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements*

We have performed an audit of the financial statements of the Genuent Global, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2022 Financial Statements").

#### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of Genuent Global, LLC 401(k) Plan (the “Plan”) provides only general information. Refer to the Plan document for a more complete description of the Plan's provisions.

#### *GENERAL*

The Plan is a defined contribution plan established on January 1, 2001. The Plan is a defined contribution plan covering all eligible employees of Genuent Holding, LLC, Genuent Global, LLC, and Genuent Employment, LLC (collectively, the “Company”, “Employer” or “Plan Sponsor”) who are employed full-time by the Company, who are at least 18 years old and completed 60 days of consecutive employment. Eligible employees can enter the Plan on the first day of each calendar month coincident with or following the date they become eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Custody of the Plan’s investments are entrusted to Reliance Trust Company (“Reliance”) (the “Trustee”).

The plan administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitor investment performance.

#### *PLAN MERGER*

Effective January 1, 2023, the Plan was merged into the P2P Retirement Plan (“P2P Plan”) due the Company being acquired by the plan sponsor of the P2P Plan. In preparation for the merger, the Plan initiated a transfer out of all Plan assets and respective participant account balances to the P2P Plan on December 30, 2022, at which time the assets were no longer held by the Plan. The Plan assets were deposited in the P2P Plan on January 3, 2023.

#### *CONTRIBUTIONS*

Each year, participants may contribute, pre-tax or post tax (Roth), up to 100% of their eligible annual compensation, as defined in the Plan document, subject to the maximum deferral amount allowed by the Internal Revenue Code (“IRC”). Under the IRC, the maximum deferral allowed was \$20,500 for 2022. Additionally, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$6,500 in 2022). Participants may also contribute amounts representing distributions from other qualified plans (“Rollovers”).

##### *CONTRIBUTIONS (CONTINUED)*

The Company may make discretionary matching contributions for eligible participants who contribute to the Plan. The Company may also make a discretionary profit sharing contribution on behalf of eligible participants under the Plan. The amount, if any, is decided upon each year. For the year ended December 31, 2022, the Company did not make a discretionary matching contribution or a discretionary profit sharing contribution.

Participants direct the investment of employee (including Rollovers) and Employer contributions into various investment options offered by the Plan. Participants may change their investment allocation on a daily basis.

##### *PARTICIPANT ACCOUNTS*

Each participant's account is credited with the participant contributions, Rollovers, and allocation of the Company's discretionary matching contribution and discretionary profit sharing contributions, if any, and Plan earnings (losses), net of administrative expenses incurred by the participant. Participant accounts are reduced by any withdrawal or distribution directly associated with the participant. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *VESTING*

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Participants are vested in the Company's discretionary matching and profit sharing contributions in accordance with the following schedule:

##### *NOTES RECEIVABLE FROM PARTICIPANTS*

Under provisions of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account. Participants may have only one note outstanding at any time. Loan terms range from one to five years, except for loans used for the purchase of a principal residence, which may be repaid over a reasonable period of time. The loans are secured by the balance in the participant's vested account. The interest charged on loans is based on the current rates quoted by local financial institutions for similar loans. The interest rate on notes receivable from participants outstanding as of December 31, 2022 (prior to the transfer of such notes receivable to the P2P Plan) ranged from 4.25% to 8.00%. Principal and interest is repaid through periodic payroll deductions.

During 2020, the Plan adopted the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"), which was signed into law on March 27, 2020. The CARES Act temporarily permitted Plan participants to take loans during the 180 day period starting on the date of enactment, up to the lesser of either \$100,000 or 100% of the participant's vested account balance. As of December 31, 2022, certain plan participants have outstanding loans pursuant to this provision.

##### *PAYMENT OF BENEFITS*

The payment of benefits from each account may occur upon retirement, death, disability, termination of employment, or if the participant reaches the age 70½ while still employed. Participants or beneficiaries are entitled to receive a lump sum amount equal to the vested value of the participant's account. The participant may delay the receipt of the benefit unless a distribution is required to be made. Terminated participants whose vested account balances are less than \$1,000 receive automatic distributions as a single lump sum payment. Terminated participants whose vested account balances are greater than \$1,000 but less than \$5,000 will be paid a direct rollover to an individual retirement account chosen by the Plan administrator. Participants who have a vested interest in their account which exceeds \$5,000 may elect to leave their account balance in the Plan or receive a single or partial lump sum payment equal to the vested balance of their account. The minimum distributions age from distributions must begin is 72.

The CARES Act permitted Plan participants to request up to \$100,000 in coronavirus-related distributions through the December 31, 2020, with repayment terms of up to three years.

#### *HARDSHIP WITHDRAWALS*

Under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. During the year ended December 31, 2022, there was a hardship withdrawal of approximately \$1,000, which is included in benefits paid to participants in the accompanying Statement of Changes in Net Assets Available for Benefits.

#### *FORFEITURES*

Forfeitures are created when participants terminate participation in the Plan before becoming fully vested in the Company's discretionary matching contributions or profit sharing contributions under the Plan. Forfeitures are retained in the Plan and may first be used to pay Plan expenses. Any remaining amounts may be used to reduce future Company contributions under the Plan. As of December 31, 2022 and 2021, forfeited non-vested accounts held in the Plan were approximately \$0 and \$11,000, respectively. During the year ended December 31, 2022, the Plan used approximately \$11,000 in forfeitures to pay for Plan expenses.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *BASIS OF ACCOUNTING*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *USE OF ESTIMATES*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States ("U.S. GAAP") requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### *INVESTMENT VALUATION AND INCOME RECOGNITION*

Investments are reported at fair value, except for the Plan's investment in the Transamerica Stable Value Core Option ("Stable Value Fund"), a fully benefit-responsive investment contract ("FBRIC"), which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan valuation policies utilizing information provided by the investment advisor and custodian. See Note 5 for discussion of fair value measurements.

#### *INVESTMENT VALUATION AND INCOME RECOGNITION*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in the fair value of investments includes the Plan's net gains and losses on investments bought and sold as well as held during the year. All gains and losses are reported in the accompanying Statement of Changes in Net Assets Available for Benefits.

#### *INVESTMENT REPORTED AT CONTRACT VALUE*

The Plan had investment holdings in a Stable Value Fund backed by the general account of Transamerica Life Insurance Company and Transamerica Financial Life Insurance Company. The Statements of Net Assets Available for Benefits present the Stable Value Fund under the Transamerica insurance general account at contract value within the total investments of the Plan. Contract value is the relevant measurement attribute for that portion of the Net Assets Available for Benefits of a defined contribution plan which are attributable to FBRIC because contract value is the amount the participants would receive if they were to initiate permitted transactions under the terms of the Plan. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants. The investment balance in the Stable Value Fund totaled \$928,646 as of December 31, 2021. This investment was included in the transfer of assets to the P2P Plan in 2022.

#### *NOTES RECEIVABLE FROM PARTICIPANTS*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2022 (prior to the transfer of such notes receivable to the P2P Plan) or December 31, 2021. Delinquent notes receivable are treated as distributions based upon the terms of the Plan document.

#### *PAYMENT OF BENEFITS*

Benefits are recorded when paid.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *ADMINISTRATIVE EXPENSES*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments and are not separately identified.

##### *SUBSEQUENT EVENTS*

The Plan has evaluated subsequent events through October 9, 2023, the date the financial statements were available to be issued.

#### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2022 (prior to the transfer of such investments to the P2P Plan) and December 31, 2021, and net depreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan). This information has not been audited by the Plan's independent auditors.

#### NOTE 4 - RISKS AND UNCERTAINTIES

The Plan provided for various investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global event which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances. The plan administrator monitored the Plan's investments and risks associated therewith on a regular basis, which the plan administrator believed minimizes these risks.

#### NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures*, are described as follows:

##### ***Level 1***

Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

##### ***Level 2***

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

##### ***Level 3***

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 (prior to the transfer of such investments to the P2P Plan) and 2021.

##### *Mutual Funds*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As a result of the transfer of Plan assets in preparation for the Plan merger into the P2P Plan, there were no Plan investments as of December 31, 2022.

#### NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were previously shares of the Stable Value Fund managed by Transamerica Life Insurance Company, the Plan’s third-party administrator. Therefore, all activities related to these particular investments are considered to be party-in-interest transactions. For the year ended December 31, 2022, fees paid by the Plan to the asset custodian and the third-party administrator for administrative services were approximately \$92,000. These transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

#### NOTE 7- TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan/Money Purchase with CODA (the “Non-Standardized Plan”), which received a favorable opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, which stated that the Non-Standardized Plan and related trust, as then designed, are in accordance with applicable sections of the IRC. The Plan has been amended and certain provisions have been adopted since receiving the opinion letter. The plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

### **NOTE 7- TAX STATUS (CONTINUED)**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 8 – DELINQUENT PARTICIPANT CONTRIBUTIONS**

In certain prior years, participant contributions and loan repayments totaling approximately \$319,000 were not remitted timely to the Plan. The Department of Labor (“DOL”) requires that participant contributions be remitted to the Plan on the earliest date on which they can be reasonably segregated from the Company’s general assets. Failure to remit participant contributions to the Plan in a timely manner results in a nonexempt prohibited transaction under ERISA which must be separately reported to the DOL. During November 2022, the Plan corrected the participant contributions and respective lost interest earnings. The accompanying supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions presents the nonexempt prohibited transactions of the Plan.
