### Scope and Nature of ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Born Group Inc 401K Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

**NOTE 1. DESCRIPTION OF PLAN**

The following description of Born Group Inc 401K Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions.

General

During 2019, Group FMG Inc 401K Plan changed its name to Born Group Inc 401K Plan. The Plan is a defined contribution plan covering all employees of Born Group, Inc. (the "Company" or the "Plan Sponsor") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established on January 10, 2011, and subsequently amended on June 1, 2019. The purpose of the Plan is to provide retirement benefits for the Company's employees. The trustees of the Plan are responsible for the Plan's oversight.

Eligibility

All employees of the Company are eligible to participate in the Plan. There is no minimum service requirement to participate in the Plan. A participant will be entered into the Plan on the first day of the month following the participants date of hire.

Participant contributions

Participants may contribute a portion of their annual eligible compensation as a pre-tax deferral up to the maximum allowed by the Internal Revenue Code ("IRC"), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan within 45 days after becoming eligible to enter the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contribution will be invested in a default investment fund selected by the Company until changed by the participant.

Employer contributions

The Company may also contribute a discretionary nonelective contribution on behalf of non-highly compensated participants, as defined by the Plan document. Employer discretionary profit sharing contributions are subject to certain limitations under the IRC. Employees can only receive the discretionary contribution if they are employed on the last day of the Plan year. There were no discretionary nonelective contributions made by the Company for the year ended December 31, 2022.

**NOTE 1. DESCRIPTION OF PLAN (CONTINUED)**

Participant accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary contribution and an allocation of investment earnings or losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants become 100% vested in the Company's contribution portion of their accounts after one year of continuous service.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan repayment terms may not exceed five years unless the loan is for the purchase of a principal residence, in which case the Plan administrator may permit a longer repayment term. Participants are allowed to have one outstanding note at any given time. Principal and interest are paid ratably through payroll deductions. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 2%, which is commensurate with local prevailing rates as determined by the Plan administrator. At December 31, 2022, the interest rate on outstanding notes receivable from participants is ranging between 5.25% to 9.5%, maturing on various dates through August 2027.

Payment of benefits

Participants may receive all or a portion of their account balance related to their pre-tax deferral if they terminate employment, become disabled, reach age 59-1/2 or on account of financial hardship, as defined in the IRC.

Benefits may be paid in the form of a single lump sum or paid as a "direct rollover" to an individual retirement account, individual retirement annuity, or to another employer's tax qualified plan.

The Plan allows for hardship withdrawals from a participant's elective deferral account. Participants must exhaust all other options before financial hardship withdrawals are allowed. Deferral contributions are suspended for a six-month period after receiving a hardship withdrawal.

Forfeited accounts

The portion of a participant's account balance which is not vested upon termination of employment is forfeited at the time of distribution. Forfeitures of nonvested accounts are available to be allocated to remaining Plan participants, reduce future employer contributions or to pay for the Plan's administrative expenses.

At December 31, 2022 and 2021, there were no forfeited nonvested accounts.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting

The accompanying financial statements of the Plan have been prepared under the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Under this standard, fair value is defined as the exit price, or the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Fair value measurements (continued)

*Level 2* inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and, inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefits paid to participants

Benefits are recorded when paid to Plan participants.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in "Net appreciation in fair value of investments."

Subsequent events

In accordance with FASB ASC 855, *Subsequent Events*, the Plan has evaluated subsequent events through September 27, 2023, the date on which these financial statements were available to be issued.

**NOTE 3. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Collective trust* is made up of a wide variety of underlying investments such as equities, preferred stocks, bonds and mutual funds. The majority of the underlying securities have observable Level 1 quoted pricing inputs; however, the NAV is not publicly quoted.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 7. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the trustee, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of investments, as they are paid through revenue-sharing, rather than a direct payment. Some administrative expenses of the Plan are paid directly by the Plan Sponsor.

**NOTE 8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 9. TAX STATUS**

The Plan agreement is a prototype plan that is intended to operate as a qualified tax-exempt plan under the appropriate sections of the IRC. The recordkeeper has provided the Plan Sponsor a copy of a letter from the Internal Revenue Service ("IRS") dated July 8, 2014, stating that the prototype plan, as designed, is acceptable under Section 401 of the IRC by use of employers for the benefit of their employees. Furthermore, the letter indicates that an employer who adopts this plan may rely on that opinion with respect to the qualifications of their plan under Section 401(a). Accordingly, no provision for income taxes has been included in the Plan's December 31, 2022 and 2021 financial statements. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.
