## Independent Auditor's Report

To the Plan Administrator and Participants  
Crimson Renewable Energy Holdings LLC 401k Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

**NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2022 AND 2021**

**1. Description of Plan**

The following description of the Crimson Renewable Energy Holdings LLC 401k Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution savings and profit sharing plan established January 1, 2008 by SeSequential Biodiesel LLC (the “Company”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and its participating employers. The Plan is administered by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

b. Eligibility

Employees of the Company are eligible to participate in the Plan after reaching the age of 21 and completing three months of service (except union employees, nonresident aliens, residents of Puerto Rico and certain employees during the Code §410(b)(6)(C) transition period). Participants enter the Plan on the first day of the month following the date on which eligibility requirements are met.

c. Participant Contributions

Participants may elect to defer up to 90% of their eligible compensation, limited by the requirements of the IRC. The Plan includes an automatic enrollment feature whereby participants who first became eligible to make salary deferrals on or after December 1, 2017 are automatically enrolled in the Plan with a 3% deferral rate, unless the participant affirmatively elects otherwise. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as allowed by the IRC. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans into the Plan.

d. Employer Contributions

During 2022 and 2021, the Company made safe harbor matching contributions each pay period equal to 100% of the participant’s first 3% of the participant’s compensation and 50% on the next 2% of the participant’s compensation. The Company may also make discretionary employer matching and nonelective contributions for those eligible participants who are eligible participants on the last day of the Plan year, subject to the limits of the IRC. There were no

discretionary employer matching or nonelective contributions made for the years ended December 31, 2022 and 2021.

e. Participant Accounts

Participants are able to direct their account balances into a variety of investments offered by the Plan. Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. The benefit to which a participant is currently entitled to is the benefit that can be provided from the participant's vested account.

f. Vesting

Participants are 100% vested in their elective salary deferrals, catch-up contributions, rollover contributions, safe harbor matching contributions and any earnings (losses) thereon. Participants become vested in their discretionary employer matching and nonelective contributions on a four-year graded scale, with 25% vesting granted for each year of service. A participant is fully vested after four years of credited service or in the event a participant reaches the Plan's normal retirement age, becomes disabled or dies.

g. Payment of Benefits

Upon reaching retirement age, termination of service, disability or death, a participant or their beneficiary may elect to receive a lump-sum, installment, or partial withdrawal amount equal to the participant's vested account balance. Early in-service withdrawals from their vested balance are permitted once participants reach age 59.5, subject to a minimum withdrawal of \$500. Account balances less than \$5,000 may be distributed in the form of a direct rollover to an individual retirement account designated by the Plan Administrator. Account balances less than \$1,000 are distributed in a single lump-sum cash payment to the participant or beneficiary.

h. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, from their vested account balance as a result of an immediate and heavy financial hardship, subject to a minimum withdrawal of \$500. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

i. Notes Receivable from Participants

Participants may borrow the lesser of \$50,000 or 50% of their vested account balance, subject to a \$500 minimum and certain other restrictions. A participant may have one loan outstanding at a time. Loans are secured by the vested account balance of the participant and are repayable through payroll deductions over periods ranging up to five years, unless the loan is used to acquire a principal residence, in which case the loan term may be for a period of 30 years. The interest

rate on participant loans is the Wall Street Journal Prime Rate plus 2%, and is fixed at the inception of the loan. Interest rates on outstanding loans at December 31, 2022 range from 4.25% to 9.50%, and the loans mature through 2028.

j. Forfeitures

Participants who terminate employment forfeit any non-vested portion of employer contributions and earnings thereon. Forfeited amounts may be used to pay administrative expenses of the Plan or to reduce future employer contributions. For the years ended December 31, 2022 and 2021, forfeitures totaling approximately \$3,200 and \$4,800, respectively, were utilized to reduce employer safe harbor contributions. Forfeitures available to reduce future Company contributions or to pay administrative expenses were approximately \$2,000 at December 31, 2022 and 2021.

**2. Summary of Significant Accounting Policies**

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

b. Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles ("GAAP") requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net appreciation (depreciation) in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date.

d. Notes Receivable from Participants

Notes receivable from participants are carried at amortized cost plus accrued interest. Delinquent notes receivable from participants may be treated as a distribution based on the terms of the Plan document.

e. Payment of Benefits

Benefits are recorded when paid.

f. Administrative Expenses

Administrative costs, including trustee, recordkeeping, legal and accounting fees, are paid by the Company. Direct expenses totaling approximately \$8,800 and \$5,200 were paid by the Plan during 2022 and 2021, respectively, representing transactional fees incurred and allocated to specific participants. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified.

**3. Investments**

Plan investment assets are held by Reliance Trust Company. Participants can direct their accounts among a money market fund and various mutual funds.

**4. Fair Value Measurements**

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, establishes a framework for fair value measurement, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Mutual funds and money market fund:* Valued at fair value based on quoted market prices at year end.

## 5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

## 6. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The

following information included in the financial statements and supplemental schedule was provided and certified by the trustee, Reliance Trust Company, as of December 31, 2022 and 2021 and for the years then ended as complete and accurate.

- Investments, at fair value
- Notes receivable from participants
- Investment income (loss)
- Interest income on participant notes receivable
- Schedule of assets (held at end of year)

## **7. Party-in-interest Transactions**

Reliance Trust Company is the trustee as defined by the Plan. Certain investment fees are paid by the trustee and are reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

The Plan sponsor, SeSequential Biodiesel LLC, is a party-in-interest to the Plan. The transactions between the Plan and the Plan sponsor included funding of contributions to the Plan and payment of certain administrative expenses of the Plan, which are exempt transactions.

## **8. Tax Status**

The Plan adopted the Automatic Data Processing Prototype 401(k) and Profit Sharing Plan document which received a favorable opinion letter dated July 8, 2014 in which the Internal Revenue Service ("IRS") stated that the prototype plan document was in compliance with the applicable requirements of the IRC. Effective July 1, 2022, the Plan was restated using the Automatic Data Processing Defined Contribution Basic Plan document, which received a favorable opinion letter dated October 6, 2020 in which the IRS states that the prototype plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, management of the Plan believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt as of and for the years ended December 31, 2022 and 2021.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of

December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**9. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**10. Subsequent Events**

Effective January 1, 2023, the Company's name is Crimson Renewable Energy Holdings, LLC. As a result of the reorganization, effective March 1, 2023, the Plan was restated to reflect the change in participating employers.

Management has evaluated the potential recognition and disclosures in the financial statements of subsequent events that have occurred through October 9, 2023, which is the date the financial statements were available to be issued.
