Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MPS Enterprises 401(k) Profit Sharing Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Description of Plan

The following description of MPS Enterprises 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan's provisions.

General

The Plan, originally effective on January 1, 2007, is a qualified retirement plan covering generally all employees of MPS Enterprises DBA Milford Pipe & Supply Inc. ("Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan has been amended and restated to conform to new tax laws and regulations.

Plan trustee and recordkeeper

The Company serves as plan sponsor and administrator of the Plan. Reliance Trust Company is the trustee of the Plan. ADP, LLC ("ADP") is the recordkeeper.

Eligibility and contributions

Employees are eligible to participate in the Plan after attaining age 18 and after completing two months of service. Upon meeting the eligibility requirements, employees are automatically enrolled in the Plan at 2% of the employee's compensation. Employees may elect a different percentage or elect not to participate by notifying the Company or ADP. The Plan also provides for pre-tax and Roth elective deferrals expressed as a specific percentage of the participant's eligible compensation. Total deferrals in any taxable year may not exceed a dollar limit which is set by law. Eligible participants may also make catch-up contributions upon reaching 50 years of age. Participants at least age 50 or will attain age 50 before the end of a calendar year may defer additional amounts as catch-up contributions. Participants are permitted to modify or revoke their salary deferral elections at any time during the plan year.

The Company will make a matching contribution on behalf of each participant in the amount equal to 100% of the participant's elective deferrals that do not exceed 4% of the participant's compensation. The Plan also allows for discretionary employer contributions for eligible participants employed on the last day of the plan year. There were no discretionary employer contributions for the 2022 plan year.

Participants are also permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Vesting

Participants are immediately vested in their contributions, rollover contributions, and actual earnings thereon. Employer contributions and actual earnings thereon vest in accordance with the following schedule:

Note 1 - Description of Plan (Continued)Participant accounts

Each participant's account is credited with the participant's contributions, employer contributions, rollovers, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their entire interest in the Plan in any of several investment securities. Participants can change their investment options among the various investment securities either through the investment of future contributions or reallocation/transfer of their current account balance.

Notes receivable from participants

Loans are available to participants on a reasonably equivalent basis. All loans must be adequately secured and charged a reasonable rate of interest. No loan in an amount less than \$500 will be made and a maximum amount limited to the lesser of \$50,000 reduced by the highest outstanding balance of loans from the Plan during the prior one-year period or 1/2 of their vested interest in the Plan. Generally, the term of the loan may not exceed five years unless the loan is for the purchase of a principal residence.

Benefit payments

Participants may receive a distribution of the vested portion of some or all of their account in the Plan for termination of employment, normal retirement, disability, or death. If the participant's vested account balance does not exceed \$5,000, then the vested account balance may be only distributed in a single lump-sum payment. If the participant's vested account balance exceeds \$5,000, the participant must consent to any distribution before it is made in the form of a single lump-sum payment, installments, or partial withdrawals.

Participants may be entitled to receive an in-service distribution. Generally, a participant may receive a distribution from the Plan from certain accounts prior to their termination of employment provided they have attained age 59.5 or incurred a financial hardship.

Forfeitures

As of December 31, 2022 and 2021, forfeited nonvested accounts totaled \$3,705 and \$3,593, respectively. These accounts may be used to reduce future employer contributions. During 2022, employer contributions were reduced by \$15,051 from forfeited nonvested accounts.

Plan termination

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will be 100% vested.

Note 2 - Summary of Accounting PoliciesBasis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured as their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Benefit payments

Benefit payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through October 9, 2023, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2022 and 2021.

- Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Collective trusts – Valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liability. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV.

Note 4 - Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan, which obtained its latest opinion letter dated October 6, 2020, in which the Internal Revenue Service ("IRS") stated that the pre-approved plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving its opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance within the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

During 2019 and 2017, the Company did not remit certain participant contributions totaling \$6,769 to the Plan in a timely manner, as defined by ERISA. Delays in remitting to the Plan were due to administrative errors. The Company is responsible for compensating participants for any lost interest resulting from the delay in contributions. The Company believes these prohibited transactions do not affect the tax status of the Plan.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
