Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Markon, LLC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Markon, LLC Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2022 and 2021 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Markon, LLC Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Markon, LLC Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

1. DESCRIPTION OF PLAN

The following description of the Markon, LLC Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Mergers

On October 30, 2020, the Plan Sponsor acquired 100 percent of the outstanding membership interest of Armatus Solutions LLC. Following the acquisition through December 31, 2021, the Armatus Solutions LLC employees continued to be eligible for the Armatus Solutions LLC 401(k) Plan and they were not eligible to participate in the Plan.

On December 28, 2021, the Armatus Solutions LLC 401(k) Plan transferred assets of \$21,245 to the Plan. The transfer occurred prior to the official merger date and has been recognized as a liability on the accompanying statement of net assets available for benefits as of December 31, 2021. On January 5, 2022, the Armatus Solutions LLC 401(k) Plan transferred its remaining plan assets of \$3,280,560 to the Markon, LLC Retirement Plan, which included the transfer that occurred prior to the official merger date and had been recognized as a liability on the accompanying statement of net assets available for benefits as of December 31, 2021. Effective January 1, 2022, the Armatus Solutions LLC 401(k) Plan was merged with the Plan, and the Armatus Solutions LLC employees were eligible to participate in the Markon, LLC Retirement Plan.

During December 2022, the Plan assets were liquidated, transferred and merged with Anser Advisory, LLC 401(k) Profit Sharing Plan. The fair value of the Plan assets of \$31,100,086 was transferred to Anser Advisory, LLC 401(k) Profit Sharing Plan as shown on the statements of changes in net assets available for benefits. All participants of the Plan became fully vested in their account balances as of the merger date.

General

The Plan was a defined contribution plan that covered all eligible employees of Markon, LLC (the Company). During 2021, Markon, Inc. changed its name to Markon, LLC, and effective September 8, 2021, the Markon, Inc. Retirement Plan changed its name to Markon, LLC Retirement Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on November 1, 2007. The Plan was most recently amended effective January 1, 2022 and terminated as of December 31, 2022.

Markon, LLC had the responsibility for remittance of participant and employer contributions, appointing a committee to administer the Plan, and determining funds available for investment under the Plan.

Markon, LLC paid for a portion of the administrative expenses and provided administrative and accounting services for the Plan.

Eligibility Requirements

All employees were eligible to participate in the Plan except for union employees and nonresident aliens. There were no minimum age or service requirements to participate; employees became eligible on their date of hire. Employees assigned to the International Division or Services Division were eligible to participate in the Plan but are excluded from sharing in the corporate matching or profit sharing contributions.

1. DESCRIPTION OF PLAN (continued)

Contributions

Each year, participants may elect to contribute a percentage of pretax annual compensation, as defined in the Plan. Participants may also make Roth (after-tax) elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan offered various common/collective trusts, pooled separate accounts and mutual funds as investment options for participants.

The Company made matching contributions in 2022 and 2021 equal to 50 percent of the participant's election deferral, up to a maximum of 8 percent of a participant's compensation.

The Plan automatically enrolled eligible participants for a 4 percent pre-tax salary deferral under its automatic enrollment feature, unless the participant elects an alternative deferral amount or elects not to defer under the Plan in accordance with the deferral procedures of the Plan.

Effective December 31, 2022, all contributions to the Plan ceased and no employees were permitted to enter the Plan after this date.

The Company may also elect to make additional discretionary contributions for participants who were employed at year end. There were no discretionary contributions for the years ended December 31, 2022 and 2021. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account were credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or individual account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions and the employer matching contributions (beginning in 2014) plus the actual earnings thereon. Employees are 100 percent vested in the Company's nonelective profit sharing contributions after 3 years of service.

The vesting for the assets merged into the Plan from Armatus Solutions LLC 401(k) Plan were 100 percent vested.

An employee was also 100 percent vested if termination was due to retirement (65th birthday), early retirement as defined in the Plan, permanent or total disability, or death.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 minus the highest outstanding loan amount during the prior 12-month period, or 50 percent of the participant's vested account balance.

Notes Receivable from Participants (continued)

Loans must be repaid within 5 years, unless the loan is used for the purchase of a primary residence. Loans bear interest at the prime rate (for loans entered after 2012) or 2 percent above the prime rate (for loans entered prior to 2013). The loans are secured by the vested balance in the participant's account. Principal and interest is paid ratably through payroll deductions. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive the value of the participant's vested interest in his or her account as a lump sum amount. Upon termination of employment, if an account balance (excluding rollovers) is less than \$5,000, the participant will be forced out of the Plan.

In-service distributions may be made to a participant who has not separated from service after the participant has reached aged 59½.

Hardship Distributions

Hardship distributions were permitted from pre-tax elective deferrals and Roth elective deferrals, for accounts that were fully vested. The minimum hardship distribution amount allowed is \$1,000, with a maximum of one distribution per participant per Plan year.

Forfeited Accounts

Forfeited balances resulting from the termination of nonvested participants may be used to reduce the Company's future contributions or administrative expenses of the Plan. There was a balance in the forfeiture account of \$-0- and \$77,185 at December 31, 2022 and 2021, respectively. No forfeitures were used for the years ended December 31, 2022 and 2021.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The accounting and reporting policies used in the financial statements conform to U.S. generally accepted accounting principles. The significant policies are summarized below.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Financial Statement Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

As permitted by U.S. generally accepted accounting principles, the Plan uses net asset value (NAV) as a practical expedient to determine the fair value of certain investments, and these investments have not been classified in the fair value hierarchy.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Liability for Armatus Solutions LLC 401(k) Plan Assets Received Prior to Plan Merger

The Armatus Solutions LLC 401(k) Plan was merged into the Plan effective January 1, 2022. The Armatus Solutions LLC 401(k) Plan assets that were transferred into the Plan on December 28, 2021, which was prior to the official Plan merger date, were recorded as a liability as of December 31, 2021.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses, including fees paid through revenue sharing arrangements, are included in net (depreciation) appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 12, 2023, the date the financial statements were available to be issued.

3. CERTIFIED FINANCIAL INFORMATION

Certain information related to investments disclosed in the accompanying financial statements as of December 31, 2022 and 2021 and net (depreciation) appreciation in fair value of investments, interest and dividends for the years ended December 31, 2022 and 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and the Delaware Charter Guarantee and Trust Company conducting business under the trade name Principal Trust Company, a member of the Principal Financial Group (collectively "Principal"), the custodian of the Plan. Notes receivable from participants are not certified by Principal Life Insurance Company or Principal Trust Company.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value focuses on the price that would be received to sell the asset or paid to transfer the liability regardless of whether an observable liquid market price existed (an exit price). The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – inputs to the valuation methodology are based upon unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability, and market-corroborated inputs. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 assets and liabilities measured at fair value are based on one or more of three valuation techniques (market, cost, or income approach). The market approach evaluates prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities. The cost approach evaluates the amount that would be required to replace the service capacity of an asset (i.e., replacement cost). The income approach uses techniques that convert future amounts to a single present amount based on market expectations (including present value techniques, option-pricing models, and lattice models).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Collective trust fund - target date funds: Valued based on the NAV per share of the individual trusts included in each respective fund, which is based on the fair value of the underlying assets. The NAV is used as a practical expedient to estimate fair value.

Stable value collective trust fund - short-term fixed income: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that pool the capital of many investors and invest it in stocks, bonds, short-term money market instruments, and other securities. Mutual funds are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued daily at the NAV of the underlying investments at year end. The NAV is used as a practical expedient to estimate fair value.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. RELATED PARTY TRANSACTIONS

Principal is the Plan's custodian and third-party administrator (see Note 3). Plan assets include investments in pooled separate accounts and common/collective trusts, which are managed by Principal. As Principal is the Plan's custodian and third-party administrator, transactions with the custodian qualify as party-in-interest transactions under ERISA. Effective June 12, 2014, Principal provides certain administrative services to the Plan pursuant to a Service and Expense Agreement between the Plan Sponsor and Principal. Principal receives revenue from mutual fund service providers for services Principal provides to the funds. The revenue is used to offset certain amounts owed to Principal for its administrative services to the Plan. Certain fees incurred by the Plan for the investment management services are included in the net (depreciation) appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. In addition, the Plan made a direct payment to the third party administrator, which was not covered by revenue sharing, which is shown as administrative expenses on the statements of changes in net assets available for benefits for the years ended December 31, 2022 and 2021. The Plan Sponsor pays directly any other fees related to the Plan's operations.

7. TAX STATUS

Through December 31, 2021, the Plan relied on an opinion letter dated March 31, 2014, in which the Internal Revenue Service stated that the Plan and related Trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Effective January 1, 2022, the Plan adopted a Non-Standardized Defined Contribution Pre-Approved Plan with an opinion letter dated November 30, 2020, in which the Internal Revenue Service stated that the Plan and related Trust, as then designed, were in compliance with the applicable requirements of the IRC.

The Plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related Trust was tax-exempt.

8. RISKS AND UNCERTAINTIES

The Plan invests in a combination of investment securities that are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

9. MERGER WITH ARMATUS SOLUTIONS LLC 401(k) PLAN

On January 5, 2022, the Armatus Solutions LLC 401(k) Plan transferred its remaining plan assets to the Plan. A summary of the transferred net assets is as follows.
