## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Biorasi LLC 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021 and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Biorasi LLC 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

**1. DESCRIPTION OF PLAN**

The following description of the Biorasi LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for more detailed information of the Plan’s provisions.

**General**

The Plan is a defined contribution plan. The Plan covers all employees of Biorasi, LLC (the “Company”), who are 21 years old or older and complete 3 months of service following the employee’s employment commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on January 1, 2013 and amended January 1, 2015.

**Contributions**

Participants’ contributions are made to the Plan by means of salary deferral by which the participant is entitled to defer the lesser of 92% of their compensation or a fixed amount determined annually by the Internal Revenue Service (“IRS”). Participants who have reached at least 50 years of age by the end of the Plan year, may elect to make catch-up contributions not to exceed a fixed amount determined annually by the IRS. The Company matches participant contributions at a rate of 50% on the first 6% of eligible compensation deferred to the Plan. Matching contributions of \$226,615 were made to the Plan for the year ended December 31, 2022. The Company may also make discretionary Qualified Non-Elective Contributions under the Plan. Such contributions are allocated in the same ratio as each non-Highly Compensated Employee’s Compensation for the applicable Plan Year bears to the total Compensation of all non-Highly Compensated Employee’s entitled to an allocation for such Plan Year. For the year ended December 31, 2022, no Qualified Non-Elective Contributions or discretionary profit-sharing contributions were made to the Plan.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, discretionary profit-sharing contributions, and an allocation of Plan earnings. Allocations of plan earnings are based on participant balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested interest in their account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Loans to Participants fund. Loans must be repaid within 5 years, except in limited circumstances, such as the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates at the initiation of the loan, as determined quarterly by the Plan administrator. Interest rates on active loans ranged from 4.25% to 9.00% as of December 31, 2022. Principal and interest are paid through payroll deductions.

**Forfeitures**

Amounts forfeited from terminating participants’ nonvested portion of their Company contributions and earnings on Company contributions are used to pay administrative expenses of the Plan or to reduce any employer contributions. During the year ended December 31, 2022, forfeitures of \$19,374 were used to reduce employer contributions and forfeitures of \$24,129 were used to pay administrative expenses of the Plan. At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$10 and \$10, respectively.

**Vesting**

Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon. Vesting in each participant's Company contribution and earnings thereon is determined in accordance with the following table:

**Payment of Benefits**

Upon reaching the retirement age of 65, upon termination of service or upon death, a participant may receive a lump-sum payment equal to the vested value of his or her account. Due to certain participants' service hours not being updated, these participants' vested balances were forfeited upon distribution in 2021. Because of the vesting error, those forfeited amounts are payable back to these participants. Therefore, they are reflected as benefits payable as of December 31, 2022.

**Administrative Expenses**

All expenses incurred by the Plan are paid from the Plan's assets to the extent the expenses have not been paid by the Company. For the years ended December 31, 2022, administrative expenses of \$35,754 were paid for by the Plan. In addition, certain investment related expenses have been offset with investment income and are not readily determinable.

**Corrective Distributions**

Corrective distributions of \$10,594 were required for the year ended December 31, 2022, to return certain active participants' excess deferral contributions to satisfy the relevant nondiscrimination provisions of the Plan. The Plan distributed the 2022 excess contributions to the applicable participants subsequent to year end. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

**Investments**

Each participant directs the allocation of his or her contribution, and employer matching and discretionary profit-sharing contributions to one or more of the investment options offered by the Plan.

**Risks and Uncertainties**

The Plan provides for various investment options in registered investment companies (mutual funds) and common collective trusts which invest in investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits and the Statement of Changes in Net Assets Available for Plan Benefits.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The financial statements have been prepared in compliance with the Department of Labor Rules and Regulations for reporting and disclosure under ERISA.

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

**Investment Valuation and Income Recognition**

Investments are measured at quoted prices in an active market and have been certified complete and accurate by Reliance Trust Company, the Plan's custodian (Note 4). Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Subsequent Events**

The Plan evaluated subsequent events through October 9, 2023, the date these financial statements were issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

**3. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets:

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Registered Investment Companies (Mutual Funds)*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Following is a description of the valuation methodologies used for assets measured at Net Asset Value (“NAV”) as the practical expedient to estimate fair value:

*Common/Collective Trust (“CCT”)*

Valued at NAV which is based on the fair value of the underlying investments of the CCT, less any liabilities. CCT are comprised solely of the MetLife Stable Value Fund (“SVF”). The SVF invests in short-term high quality fixed income investments. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The redemption of the SVF is subject to the preference of individual Plan participants and contains no restrictions on the timing of redemption. The SVF has no unfunded commitments.

**5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, so that each participant receives 100% of his or her account balance as of the date of termination.

**6. TAX STATUS**

The Plan document is a non-standard pre-approved profit sharing plan that received a favorable opinion letter from the IRS on October 6, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC").

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PARTY-IN-INTEREST TRANSACTIONS**

The Plan pays administrative expenses to parties-in-interest who provide services to the Plan and for whom a statutory exemption exists. Additionally, notes receivable from participants are considered party-in-interest transactions.

**8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

The Form 5500 was prepared on the cash basis of accounting for the years ended December 31, 2022 and 2021 with regard to corrective distributions payable and benefits payable.
