INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of FXDirect Dealer, LLC Savings and Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

NOTE 1 - DESCRIPTION OF PLAN

The following description of FXDirect Dealer, LLC Savings and Investment Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan was established effective May 1, 2014. The Plan is a defined contribution plan covering all full-time eligible employees of FXDirect Dealer, LLC and its participating affiliates (the "Employer") who are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Management of the Employer is responsible for oversight of the Plan. The Plan's administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

CONTRIBUTIONS

The Plan allows pre-tax elective deferrals and/or Roth elective deferrals. Each year, participants may elect to contribute up to 60% of their annual compensation, as defined by the Plan. All employees are limited to a maximum contribution of \$20,500 in 2022 by Code Section 402(g) of the Internal Revenue Code ("IRC").

Participants age 50 or older before the end of the plan year are eligible to make additional annual "catch-up" contribution of up to \$6,500 as a pre-tax and/or Roth contribution. If any participant's compensation deferrals for a year exceed the maximum allowable for that year, the excess amount is to be returned to the participant as taxable compensation.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes a matching contribution equal to 40% of the amount that a participant contributes to the Plan. However, any contribution made by the participant in excess of 6% of their compensation will not be considered for a matching contribution. In addition, the Employer may make a discretionary non-elective profit sharing contribution to the Plan. The profit sharing contribution is allocated to the participants based upon a formula of participant compensation to total participant compensation. For the year ended December 31, 2022, matching contributions totaled \$122,189. The Employer did not make a profit sharing contribution.

PARTICIPANT ACCOUNTS

Each participant's account is credited with (a) the participant's contribution, (b) allocations of the Employer's matching and profit sharing contributions, if any, (c) rollover contributions, if any, and (d) earnings and appreciation in the value of the investments; and charged with (a) distributions made to participant, (b) depreciation in the value of the investments and (c) allocation of participant account administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately and fully vested in their contributions and rollover contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. Participants begin vesting in employer matching and profit sharing contributions after one year of service, vesting at a rate of 20% per year thereafter, and are fully vested after six years of service. In the event of total disability or death, the participant will become 100% vested in their account.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. However, the \$50,000 will be reduced by the excess, if any, of the highest outstanding note balance during the previous one-year period over the amount of the new loan. Participants may only have one outstanding note at any time. Notes must be fully repaid within five years unless the note is used for the purchase of a primary residence, in which case the plan administrator may permit a longer repayment term. Principal and interest must be paid through payroll deductions. The notes are adequately secured by the balance of the participant's account. These notes bear interest at the rate of Prime plus 1% determined at the time of the loan.

PAYMENT OF BENEFITS

Upon termination of service, participants may elect to have their benefits paid to them as a single lump sum, paid as a direct rollover to another qualified plan or individual retirement account, or distributed in installments or partial withdrawals. Termination of service may result from the death of the participant, total disability of the participant,

retirement, or termination of employment. Active participants may make a withdrawal at 59 ½. If the participant's account balance is less than \$5,000, the participant may not defer the distribution to a later date and the fund balance is distributed in a lump sum or direct rollover as soon as it is administratively feasible following the termination event. If the participant's account is greater than \$5,000, the participant may choose to receive a lump sum, monthly installments, partial withdrawals, or defer receiving payments until age 72 (age 73 if participant reaches age 72 after December 31, 2022). In the event of a death of a participant prior to retirement, 100% of the participants vested account is paid to their beneficiary in a single lump sum.

FORFEITED ACCOUNTS

If a participant terminates before becoming fully vested in their account balance, the non-vested portion of the participant's account balance will be forfeited as of the earlier of the distribution of the entire vested portion of the participant's account or the last day of the plan year in which the former participant has a five-year break in service. Forfeitures may be used by the Plan to pay for administrative expenses or to reduce employer matching or profit-sharing contributions. For the year ended December 31, 2022, forfeitures that reduced employer matching contributions amounted to \$4,516. The balance in the forfeiture account as of both December 31, 2022 and 2021 was \$20.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNT POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP"). The Plan follows the accounting and reporting guidance as prescribed by Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 962, "Plan Accounting - Defined Contribution Pension Plans."

USE OF ESTIMATES

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates and assumptions.

RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for the discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent or defaulted notes receivables from participants are written off as "deemed" distributions therefore, no allowance for credit losses has been recorded as of December 31, 2022 and 2021.

PAYMENT OF BENEFITS

Benefit payments to participants are recorded upon distribution.

EXPENSES

The costs and expenses of administering the Plan are paid by the Plan's participants unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from the financial statements. Administrative expenses incurred by the Plan include note receivable and benefit payment fees charged directly to the participant's accounts. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2023, the date the financial statements were available to be issued. Except as noted below, there were no other events identified requiring recognition or disclosure in the financial statements.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

MUTUAL FUNDS

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - PLAN TERMINATION

Although the Employer has not expressed any intent to do so, the Employer has the right, under the plan agreement, to amend any or all provisions of the Plan, as well as discontinue contributions and terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants are 100% vested in their accounts.

NOTE 5 - TAX STATUS

The Plan adopted Automatic Data Processing, Inc.'s Prototype Non-standardized Profit Sharing Plan (the "Prototype Plan"), which is qualified under Section 401 of the IRC as a tax-exempt plan. The Prototype Plan has received an opinion letter from the IRS dated July 16, 2014.

Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the application requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

In 2022, the Plan adopted the ADP, LLC Non-Standardized Pre-Approved Profit Sharing/Money Purchase / CODA Plan ("Pre-Approved Plan"). The Pre-Approved plan is qualified under Section 401 of the IRC as a tax-exempt plan. The Pre-Approved Plan received an opinion letter from the IRS dated October 6, 2020.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

NOTE 6 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments and interest and dividends for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (“Reliance”) (the trustee of the Plan). This information has not been audited by the Plan’s independent auditors.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were invested in mutual funds managed by Reliance. Reliance is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.
