Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed an audit of the financial statements of Sunpro Solar 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 29, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to December 29, 2022, and the related notes to the financial statements.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Sunpro Solar 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Sunpro Solar 401(k) Plan is a defined contribution plan which was adopted on January 1, 2017, covering substantially all employees of Marc Jones Construction, LLC dba ADT Solar LLC (the Company or Employer) and its other participating employer Buildpro, L.L.C. In order to be eligible to participate in the Plan, employees must be 18 years of age and have completed 6 months of service. The effective Plan entry date is January 1 or July 1 coinciding with or the next following date on which such eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 29, 2022, the Plan was merged into the ADT Security Corporation Retirement Savings and Investment Plan, and total assets of \$9,486,811 were transferred out of the Plan. Participants received credit for their service in the Plan for purposes of eligibility and vesting in the ADT Security Corporation Retirement Savings and Investment Plan.

Contributions

Participants may make elective contributions to the Plan by deferring a percentage of their compensation, as defined by the Plan, up to the maximum allowed by the Internal Revenue Code. In addition, a participant who has attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with limitations under the Internal Revenue Code. The total of deferrals and Company matching contributions cannot exceed the yearly statutory maximum. The Plan implemented a Safe Harbor plan design as permitted by the Internal Revenue Service ("IRS"), which exempted the Plan from certain compliance issues, primarily associated with non-discrimination testing. If eligible, participants will receive a safe harbor matching contribution equal to 100% of the amount the participant contributes to the Plan for each payroll period up to the first 3% of Plan compensation plus 50% of the amount the participant contributes between 3% and 5% of Plan compensation. Additional Employer non-elective or profit-sharing contributions may be made to the Plan. There were no additional Employer non-elective or profit-sharing contributions made to the Plan for the period from January 1, 2022 through December 29, 2022.

Participant accounts

Each participant's account is credited with the participant's contribution and allocation of the Company contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount or installments, equal to the value of the vested interest in his or her account. Upon reaching age 59 ½, participants are also eligible for in-service distributions. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the participant's elective deferral and rollover accounts into the Plan. Balances under \$5,000 for terminated participants may be paid out at the discretion of the Company.

Administrative expenses

The Company absorbs significant administrative costs of the Plan. Administrative expenses paid by the Plan arise from fees for the processing of distributions and loans that are charged to their respected participants' accounts. In addition, certain investment accounts charge asset and participation fees that are allocated among the respected participants.

Vesting

Participants are immediately vested in their voluntary contributions and basic safe harbor matching contributions plus actual earnings thereon. Vesting for additional Employer non-elective or profit-sharing contributions is based on years of service. A participant becomes 20% vested after two years of service, 40% after three years, 60% after four years, 80% after five years, and 100% vested after six years of service. A year of service is defined as 1,000 hours of service within a Plan year. Participants will become fully vested if they are employed by the Company on or after their normal retirement date at age 65. If a participant dies or becomes permanently disabled before attaining the normal retirement age, the participant's account becomes 100% vested.

Investment options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions in a variety of investment options. Participants may change their investment allocations any time via telephone, internet or written instructions.

Forfeitures

Forfeitures occur after termination of employment at the earlier of when participants with non-vested account balances, as defined by the Plan, have either five consecutive 1-year breaks in service or receive a distribution of their entire vested portion of their account balance. Forfeitures are used to reduce administrative expenses and then any remaining will be added to any discretionary Employer contributions. If the participant is re-employed and fulfills certain requirements, as defined by the Plan, the participant's account will be reinstated. In 2022, forfeitures in the amount of \$460 were used to reduce administrative expenses of the Plan. Forfeitures available to offset future Employer contributions and administrative expenses were \$31,850 at December 31, 2021.

Notes receivable from participants

Loans to participants from the Plan are not permitted.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition

Plan investments are stated at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid by the Plan.

Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3 - FEDERAL INCOME TAX STATUS

The Plan adopted a prototype plan document effective October 1, 2014. The prototype plan received an opinion letter from the Internal Revenue Service dated March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended and restated since receiving the letter, including amendments made to comply with recent law changes. The Plan itself has not separately applied for a determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

United States generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is not subject to United States federal and state income tax examinations by tax authorities beyond three years from the filing of those returns.

NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments held at December 31, 2021, and net depreciation in fair value of investments for the period ended December 29, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Life Insurance Company.

NOTE 5 - FAIR VALUE MEASUREMENT

FASB Statement Accounting Standards Codification ("ASC") 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 29, 2022 and December 31, 2021.

Pooled separate accounts (PSA):

Valued daily based on the market value of the underlying net assets in each separate account, based on the reported net asset value ("NAV") or its equivalent. The redemption frequency of each of these PSA's are daily, and there are no redemption restrictions. There are no unfunded commitments related to the Plan's investment in PSA's.

Investment contract:

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract is designed to accrue interest based on credit rates

established by the contract issuer. The stable value option has been presented at fair value which approximates contract value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different measurement at the reporting date.

NOTE 6 - PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are pooled separate accounts managed by Transamerica Life Insurance Company. Transamerica Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. All of the party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - RISKS AND UNCERTAINTIES

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - DELINQUENT PARTICIPANT CONTRIBUTIONS

For the year ended December 31, 2021, the Employer identified late remittances of participant contributions in the aggregate amount of \$408,722. The late remittances were remitted to the Plan in January 2022.
