### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Parks Manufacturing, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

#### Note 1. Plan Description

The following description of the Parks Manufacturing, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all full-time employees of Parks Manufacturing, LLC (the Company), who have three months of continuous service, as defined by the Plan Agreement and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective April 1, 2023, the Plan was amended in order to change age requirements from age 21 or older to age 18 or older.

**Contributions:** Each year, individual participants may elect to contribute a percentage of their annual compensation as defined in the Plan Agreement limited to the maximum amount allowed by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes Safe Harbor matching contributions, whereby the Company contributes 100% of the participant deferral and catch-up contributions up to 3% plus 50% of the next 2% of deferrals. The Company may, at its discretion, make an additional matching contribution or a profit-sharing contribution to the Plan. Additional service requirements, as defined by the Plan Agreement, are necessary in order for a participant to receive the profit-sharing contribution. Company contributions are invested in a manner similar to participant contributions. Contributions are subject to certain limitations. Safe Harbor matching contributions for the year ended December 31, 2022 were \$172,093. No additional matching contributions or profit-sharing contributions were during the year ended December 31, 2022.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, if any, (b) Plan earnings, and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions and the Company's Safe Harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and the Company's profit-sharing contribution, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service.

**Investment options:** Upon enrollment in the Plan, participants direct the investment of their contributions into a variety of investment options, as more fully described in the Plan's literature. Participants may change their investment options at any time.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Two outstanding loans are permitted per participant at any time. The maximum loan term allowed is five years. The loans are collateralized by the balance in the participant's account and bear interest at rates commensurate with prevailing rates as determined by the third-party administrator. At December 31, 2022, interest rates on outstanding notes receivable from participants ranged from 5.25% to 9.00%. Principal and interest are payable each pay period, primarily through payroll deductions.

#### Note 1. Plan Description (Continued)

**Forfeitures:** Forfeitures of Company contributions are used to reduce future Company contributions to the Plan. In 2022 and 2021, there were no forfeited nonvested accounts. During 2022, no forfeitures were used to reduce Company contributions.

**Payment of benefits:** Upon resignation, termination, or retirement from the Company, distributions of benefits are made in a lump-sum amount equal to the vested value of the participant's account. Partial withdrawals or installments are permitted for participants or beneficiaries who must receive required minimum distributions. Benefits are recorded when paid.

**Administration of Plan assets:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Company and, therefore, are not reflected in the Plan's financial statements.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by investment advisors, the custodian and other third parties. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 11, 2023, the date the financial statements were available to be issued.

Nationwide has also certified to the completeness and accuracy of \$199,774 of net depreciation in the fair value of investments for the year ended December 31, 2022.

#### Note 4. Fair Value Measurements

Accounting standards established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

**Shares of registered investment companies:** Valued at the closing price reported on the active market on which the individual securities are traded.

**Money market funds:** Valued at cost, which approximates fair value.

**Unallocated insurance contract funds:** Valued at the fair market value of the fund contract which is equal to the book value less contingent deferred sales charge.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

For the year ended December 31, 2022 on a net basis, there were no significant transfers in or out of the BOA-Fixed account, a Level 3 investment.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **Note 6. Related-Party and Party-In-Interest Transactions**

Certain Plan investments are managed by Nationwide. Nationwide performs services for the Plan, and therefore, these transactions qualify as party-in-interest. Fees paid to Nationwide by the Plan for the year ended December 31, 2022 were \$25,746.

#### **Note 7. Tax Status and Uncertain Tax Positions**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. federal, state, or local tax authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken by or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress. With few exceptions, the client is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2019.

#### **Note 8. Risks and Uncertainties**

The Plan Sponsor's majority owners have historically provided additional capital to fund operating deficits and cash shortfalls of the Plan Sponsor. If the Plan Sponsor is unable to generate sufficient cash to support their obligations without the support of their majority owners, this may cause uncertainty as to the continuation of the Plan. As of the date of this report, there is no intent to terminate the Plan. Therefore, the financial statements of the Plan do not include any adjustment that might result from this uncertainty. See Note 5 for discussion regarding plan termination.
