As described in Note 1 to the financial statements, the Plan merged into the Twin Star International, Inc. 401(k) Profit Sharing Plan & Trust effective January 1, 2023. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1 – DESCRIPTION OF PLAN

The following description of the Classic Accessories 401(k) Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan Sponsor is Classic Accessories, LLC (the “Company”, “Sponsor”, or “Classic Accessories”).

General: The Plan is a defined contribution plan covering all eligible employees of the Company as described in the Plan agreement. An employee shall become a participant on the first day of the month coinciding with or following the date the employee completes the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 1, 2022, the Plan agreement was amended to switch record keeper and trustee to ADP and Reliance Trust Company, respectively. The amendment also includes changes to certain eligibility requirements, removal of the autoenrollment feature, updates to employee deferral limits and revisions to the loan policy. Participants should refer to the amendment for a more complete description of the Plan's updated provisions.

Effective January 1, 2023, the Plan merged into the Twin Star International, Inc. 401(k) Profit Sharing Plan & Trust (the “Merger”). In anticipation of the Merger, the Plan's investments were liquidated and presented as cash in-transit on the statement of net assets available for benefits at December 31, 2022.

Contributions: Participants could contribute up to 100% of eligible compensation, as defined in the Plan. Effective May 1, 2022, participants may contribute up to 90% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may make discretionary matching contributions. For 2022, the Company matched contributions equal to 50% up to 2% of each participant's eligible compensation as defined in the Plan. For the year ended December 31, 2022, the discretionary matching contributions were approximately \$30,000. The Company also makes safe harbor nonelective matching contributions equal to 3% of each participant's eligible compensation. For the year ended December 31, 2022, the safe harbor matching contributions were approximately \$112,000. Forfeitures totaling approximately \$3,000 were used to reduce employer contributions for the year ended December 31, 2022. In addition, the company may make additional profit-sharing contributions to the Plan. There were no profit-sharing contributions for the current Plan year. Contributions are subject to certain limitations.

The Plan also included an auto-enrollment feature whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rates initially set at 2% of eligible compensation. Effective May 1, 2022, the Plan no longer includes an auto-enrollment feature.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings, and (c) forfeitures of employer matching and profit-sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their contributions and rollovers plus actual earnings thereon, and all matching contributions.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$1,000 are automatically distributed to participants as a lump sum payment. Benefit amounts greater than \$1,000 and less than \$5,000 will automatically receive a rollover into an individual retirement plan designated by the Plan Administrator. Participants (or their beneficiaries upon the death of the participant) with benefit amounts exceeding \$5,000 may elect to receive their vested account balances as a single lump sum, partial withdrawal or rollover. Effective May 1, 2022, participants also have the option to elect to receive their vested account balances in equal installments. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loan term may not exceed 5 years, except for a loan to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate at the time of the loan application as determined by the loan administrator. All loans are covered by demand notes and are repayable through payroll deductions.

Forfeitures: Forfeitures are used to reduce future employer contributions or administrative expenses of the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Notes 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants as disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company and Fidelity Management Trust Company (the trustees of the Plan). Reliance Trust Company held the Plan's investment assets and executed investment transactions from April 30, 2022 to December 31, 2022. Fidelity Management Trust Company held the Plan's investment assets and executed investment transactions for the period from January 1, 2021 to April 29, 2022.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

As of December 31, 2022, all investments of the Plan were liquidated into cash in anticipation of the merger into Twin Star International, Inc. 401(k) Profit Sharing Plan & Trust. Investments measured at fair value on a recurring basis are summarized below:

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan invests in shares of mutual funds and collective trusts issued by Fidelity Investments, an affiliate of Fidelity Management Trust Company (FMTC), the Plan's former trustee. Transactions in such investments issued by Fidelity Investments qualified as party-in-interest transactions as December 31, 2021 and for the period from January 1, 2022 to April 29, 2022. The Plan's payment of record keeping and investment management fees to ADP, Inc., FMTC, Fidelity Investments, and Reliance Trust Company qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated October 6, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.
