## Independent Auditor's Report

To the Plan Administrator

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Mas Restaurant Group LLC 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). #### **Note 1 - Description of Plan**

The following description of Mas Restaurant Group LLC 401(k) Profit Sharing Plan & Trust (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan adopted by Mas Restaurant Group LLC (the "Plan Sponsor" or the "Company"), effective January 1, 2019 and subsequently amended and restated on January 1, 2021. The Plan covers all full-time employees of the Company who have completed one year and 1,000 hours of continuous service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's administration is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

On June 2, 2021, Mas Restaurant Group LLC acquired 100% of a business that owned and operated Taco Bell locations in Ohio. Upon closing the transaction, the employees of the acquired business were eligible to participate in the Plan, and had the option of:

- (a) Rolling their account, including outstanding participant loan balances, into the Plan
- (b) Rolling their account into any other qualified plan
- (c) Taking a cash distribution

As of November 30, 2022, the Company elected to terminate Plan and transfer all assets into another plan. At November 30, 2022, all assets in the Plan were transferred into the Securian Pooled Employer Plan and Trust, a new plan established by the Company.

##### **Contributions**

Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan's agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100% of up to the first 4% and 50% on contributions greater than 4% but less or equal to 6% of participant's contributions (Safe Harbor Matching Contributions). Additional discretionary profit sharing contributions may be contributed at the option of the Company. Participants also direct the investment of Company contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations, which was \$20,500 (\$27,000 for eligible employees 50 or older) for 2022.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of the Company's discretionary profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon, the Company's Safe Harbor Matching Contributions, and discretionary matching contributions, if any. There were no discretionary matching contributions made during the period ended November 30, 2022.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate, determined based on the date the loan is requested, is set at prime rate plus 1%. The loan repayment period will be 60 months (five years), unless support is provided that the loan is being used for purchase of the primary residence. Principal and interest are paid ratably through monthly payments made by participants.

#### **Payment of benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installments determined by the participant within custodian limits and not to exceed the participant's life expectancy, joint and survivor annuity or annuity contract not to exceed the participant's life expectancy or that of their beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### **Hardship withdrawals**

Participants may withdraw their employee pretax contributions (but not earnings on the pretax contributions) and rollover contributions, if applicable, to satisfy immediate and significant financial needs. In accordance with the IRS regulations, participants must first exhaust all other assets available before obtaining a hardship withdrawal. All hardship withdrawals must be approved by the Plan administrator. Pursuant to the Bipartisan Budget Act of 2018, adopted by the Plan on January 1, 2021, participants are no longer required to suspend elective deferrals to the Plan for a period of six months after receiving a hardship distribution.

### **Note 2 - Summary of accounting policies**

#### **Basis of accounting**

The financial statements of the Plan are prepared on the liquidation basis of accounting as of November 30, 2022 and for the period from January 1, 2022 through November 30, 2022. As of December 31, 2021, the statement of net assets available for benefits was prepared on the going concern basis of accounting.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 30, 2022 or December 31, 2021.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

#### Subsequent events

The Plan has evaluated subsequent events through October 13, 2023, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability; and
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2022 and December 31, 2021:

Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no financial assets as of November 30, 2022. The following table set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021.

#### Note 4 - Related party transactions and party-in-interest transactions

The Plan allows for loans to participants which are considered party-in-interest transactions.

#### Note 5 - Plan termination

As disclosed in Note 1, the Company elected to terminate the Plan effective November 30, 2022. On November 30, 2022, all assets in the Plan were transferred into another plan established by the Company, the Securian Pooled Employer Plan and Trust. In accordance with GAAP, the Plan has changed its basis of accounting used to value Plan assets to the liquidation basis for the period from January 1, 2022 through November 30, 2022.

#### Note 6 - Tax status

The prototype Plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter on July 16, 2014, in which the IRS stated that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 8 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at November 30, 2022 and December 31, 2021, and investment loss and interest income on notes receivable from participants for the period from January 1, 2022 through November 30, 2022, that are disclosed in the accompanying financial statements, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

#### **Note 9 - Operational error**

For one pay period during the period ending November 30, 2022, the Company did not withhold the employee contributions from employees' compensation and did not contribute the matching safe harbor contribution. Management is in the process of correcting these operational deficiencies and plans to fund participants accounts within the Securian Pooled Employer Plan and Trust, a new plan established by the Company, for the missed employer matching contribution and 25% of the missed employee deferrals.

For the Plan period ending November 30, 2022 the Company did not correctly calculate the safe harbor matching contribution for certain employees totaling approximately \$3,200. Management is in the process of correcting these operational deficiencies and plans to fund participants accounts within the Securian Pooled Employer Plan and Trust, a new plan established by the Company for the missed employer matching contribution.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's administration is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

On June 2, 2021, Mas Restaurant Group LLC acquired 100% of a business that owned and operated Taco Bell locations in Ohio. Upon closing the transaction, the employees of the acquired business were eligible to participate in the Plan, and had the option of:

- (a) Rolling their account, including outstanding participant loan balances, into the Plan
- (b) Rolling their account into any other qualified plan
- (c) Taking a cash distribution

As of November 30, 2022, the Company elected to terminate Plan and transfer all assets into another plan. At November 30, 2022, all assets in the Plan were transferred into the Securian Pooled Employer Plan and Trust, a new plan established by the Company.

#### **Contributions**

Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan's agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100% of up to the first 4% and 50% on contributions greater than 4% but less or equal to 6% of participant's contributions (Safe Harbor Matching Contributions). Additional discretionary profit sharing contributions may be contributed at the option of the Company. Participants also direct the investment of Company contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations, which was \$20,500 (\$27,000 for eligible employees 50 or older) for 2022.

#### **Participant accounts**

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of the Company's discretionary profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon, the Company's Safe Harbor Matching Contributions, and discretionary matching contributions, if any. There were no discretionary matching contributions made during the period ended November 30, 2022.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate, determined based on the date the loan is requested, is set at prime rate plus 1%. The loan repayment period will be 60 months (five years), unless support is provided that the loan is being used for purchase of the primary residence. Principal and interest are paid ratably through monthly payments made by participants.

#### **Payment of benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installments determined by the participant within custodian limits and not to exceed the participant's life expectancy, joint and survivor annuity or annuity contract not to exceed the participant's life expectancy or that of their beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### **Hardship withdrawals**

Participants may withdraw their employee pretax contributions (but not earnings on the pretax contributions) and rollover contributions, if applicable, to satisfy immediate and significant financial needs. In accordance with the IRS regulations, participants must first exhaust all other assets available before obtaining a hardship withdrawal. All hardship withdrawals must be approved by the Plan administrator. Pursuant to the Bipartisan Budget Act of 2018, adopted by the Plan on January 1, 2021, participants are no longer required to suspend elective deferrals to the Plan for a period of six months after receiving a hardship distribution.

### **Note 2 - Summary of accounting policies**

#### **Basis of accounting**

The financial statements of the Plan are prepared on the liquidation basis of accounting as of November 30, 2022 and for the period from January 1, 2022 through November 30, 2022. As of December 31, 2021, the statement of net assets available for benefits was prepared on the going concern basis of accounting.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 30, 2022 or December 31, 2021.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

#### Subsequent events

The Plan has evaluated subsequent events through October 13, 2023, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability; and
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2022 and December 31, 2021:

Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no financial assets as of November 30, 2022. The following table set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021.

#### Note 4 - Related party transactions and party-in-interest transactions

The Plan allows for loans to participants which are considered party-in-interest transactions.

#### Note 5 - Plan termination

As disclosed in Note 1, the Company elected to terminate the Plan effective November 30, 2022. On November 30, 2022, all assets in the Plan were transferred into another plan established by the Company, the Securian Pooled Employer Plan and Trust. In accordance with GAAP, the Plan has changed its basis of accounting used to value Plan assets to the liquidation basis for the period from January 1, 2022 through November 30, 2022.

#### Note 6 - Tax status

The prototype Plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter on July 16, 2014, in which the IRS stated that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 8 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at November 30, 2022 and December 31, 2021, and investment loss and interest income on notes receivable from participants for the period from January 1, 2022 through November 30, 2022, that are disclosed in the accompanying financial statements, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

#### **Note 9 - Operational error**

For one pay period during the period ending November 30, 2022, the Company did not withhold the employee contributions from employees' compensation and did not contribute the matching safe harbor contribution. Management is in the process of correcting these operational deficiencies and plans to fund participants accounts within the Securian Pooled Employer Plan and Trust, a new plan established by the Company, for the missed employer matching contribution and 25% of the missed employee deferrals.

For the Plan period ending November 30, 2022 the Company did not correctly calculate the safe harbor matching contribution for certain employees totaling approximately \$3,200. Management is in the process of correcting these operational deficiencies and plans to fund participants accounts within the Securian Pooled Employer Plan and Trust, a new plan established by the Company for the missed employer matching contribution.
