## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees and Participants of  
Trinitas Regional Medical Center Tax Sheltered Annuity Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements

We were engaged to perform an audit of the financial statements of Trinitas Regional Medical Center Tax Sheltered Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements ("2022 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Disclaimer of Opinion on the 2022 Financial Statements

We do not express an opinion on the accompanying 2022 financial statements of Trinitas Regional Medical Center Tax Sheltered Annuity Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion on the 2022 Financial Statements section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### Basis for Disclaimer of Opinion on the 2022 Financial Statements

Trinitas Regional Medical Center Tax Sheltered Annuity Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 1 to the financial statements, Trinitas Regional Medical Center Tax Sheltered Annuity Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

### **Responsibilities of Management for the 2022 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Trinitas Regional Medical Center Tax Sheltered Annuity Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the 2022 Financial Statements**

Our responsibility is to conduct an audit of Trinitas Regional Medical Center Tax Sheltered Annuity Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion on the 2022 Financial Statements section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Trinitas Regional Medical Center Tax Sheltered Annuity Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

### **Other Matters**

#### *Auditor's Report on the 2021 Financial Statements*

The financial statements of Trinitas Regional Medical Center Tax Sheltered Annuity Plan, whose report dated September 12, 2022 as of and for the year ended December 31, 2021, were audited by a predecessor auditor who expressed a disclaimer of opinion on those statements and included an other-matter paragraph that because of the significance of the disclaimer of opinion it was inappropriate to and they did not express an opinion on the 2021 supplemental schedule.

The basis of the disclaimer of opinion related to Trinitas Regional Medical Center Tax Sheltered Annuity Plan not maintaining sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, the predecessor auditor was unable to apply auditing procedures sufficient to determine the extent to which the 2021 financial statements may have been affected by these conditions.

Trinitas Regional Medical Center Tax Sheltered Annuity Plan excluded from the 2021 financial statements certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to such accounts were also excluded from the 2021 financial statements. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the 2021 financial statements.

## 1. Description of the Plan

The following description of the Trinitas Regional Medical Center Tax Sheltered Annuity Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan under Section 403(b) of the Internal Revenue Code ("IRC") covering all employees of Trinitas Regional Medical Center (the "Medical Center"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan's Pension Plan Committee is responsible for oversight of the Plan. The Pension Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees. The Plan's assets are administered under contracts with Fidelity Management Trust Company ("Fidelity"), the Trustee of the Plan. The Trustee invests funds received from contributions, investment sales, interest and dividend income and makes distribution payments to participants.

Effective December 31, 2022, the Plan was merged with and into the RWJBarnabas Health 403(b) Savings Plan. The majority of the assets were transferred on December 30, 2022, with the remaining balance transferred on January 6, 2023. All investments were reflected in the RWJBarnabas Health 403(b) Savings Plan as of December 31, 2022. Fidelity will remain the Plan's Trustee. All specific attributes will stay the same for the Plan after the merger.

The Internal Revenue Service ("IRS") has limited a participant's annual tax deferred contribution to \$20,500 (or \$27,000 with catch-up contributions for those over 50 years of age) for 2022.

## **Participant Accounts**

Each participant's account is credited with (a) the participant's salary deferrals, (b) rollovers from other qualified plans, and (c) allocations of investment income (losses) and realized and unrealized appreciation (depreciation) in fair value of investments, and charged with an allocation of administrative expenses that are paid by the Plan, as applicable, or reduced by withdrawals, if any. Each participant directs their contributions to the investment options offered by the Plan. Allocations are based on participant earnings (losses) or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **Payment of Benefits**

Participants may receive all or a portion of their participant deferral account balance upon reaching 59-1/2 years of age. Upon termination of service for any reason, a participant is eligible to receive the interest in his or her account in a lump sum or an annuity payment. If the participant balance does not exceed \$5,000, a single lump sum payment will be made to the participant. The annuity option is available only if the vested interest exceeds \$5,000. In addition, the Plan allows for hardship distributions if certain criteria are met. Under the IRC, a hardship withdrawal must be used to meet extraordinary medical expenses, educational expenses, expenses used to purchase a principal residence, prevent eviction from a principal residence, funeral expenses or casualty expenses. The application for the hardship withdrawal must be approved by the plan administrator.

## **Custodial Accounts Excluded from Financial Statements**

As permitted by the Department of Labor's ("DOL") Field Assistant Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans ("FAB 2009-02"), the Plan Administrator has elected to exclude certain annuity and custodial accounts from the Plan's financial statements. These annuity and custodial accounts were limited to employee contributions held under a voluntary 403(b) plan arrangement prior to January 1, 2009. Presentation of this information is required by accounting principles generally accepted in the United States of America ("GAAP"). The effects of the departure from GAAP on these financial statements are not determinable as of December 31, 2022 and 2021 and for the year ended December 31, 2022. The Plan Administrator has concluded that the annuity and custodial accounts have met the criteria required under FAB 2009-02 and as such, have been excluded from the Plan's financial statements.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of assets and liabilities in the financial statements and accompanying notes. Actual results could differ from those estimates.

## **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension Plan Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold as well as held during the year. Certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

## **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Medical Center and are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses.

## **Payment of Benefits**

Benefits paid to participants are recorded when paid.

## **Recent Accounting Standards**

The Plan is not aware of any new accounting standards that were required to be adopted in 2022, or yet to be adopted, that would significantly impact the Plan's 2022 financial statements.

### **3. Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA for 2022 and 2021, and therefore, as permitted, no auditing procedures were performed by the independent auditor with respect to the information certified by the Trustee. The Trustee has certified to the completeness and accuracy of the investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2022, and the related investment activity and notes receivable activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022.

### **4. Insurance Company Guaranteed Interest Annuity Contracts**

The Plan entered into two guaranteed interest annuity contracts with certain insurance companies (the Insurers). The Insurers maintain the contributions in the guaranteed interest annuity contracts and are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value, as reported by the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value, subject to certain restrictions, therefore, the contracts are not fully benefit responsive. The Insurers have stated that the contract value of the guaranteed interest annuity contracts approximates fair value.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rates are determined based on a formula agreed upon with the issuers. Under this methodology, different interest crediting rates are applied to contributions based predetermined intervals. Interest crediting rates are established semiannually or quarterly. When establishing interest crediting rates for these products, the Insurers consider many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuers' general account. These rates are established without the use of a specific formula. The contract cannot be terminated before the scheduled maturity date. The minimum crediting rate under the contracts range from 1 to 3 percent. The average yield earned and credited to participants was between 1 and 3 percent in 2022 and 2021, respectively.

## 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value of the assets and liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

- Money market fund is valued at the quoted net asset value (“NAV”) of shares held by the Plan at year end.
- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Other investments and insurance contracts are valued indirectly using observable data including interest rates and contract terms.

### **6. Related Party and Party-In-Interest Transactions**

Certain of the Plan's investments are managed by the Trustees, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Certain administrative functions of the Plan are performed by officers or employees of the Medical Center. No such officer or employee receives compensation from the Plan.

### **7. Income Tax Status**

The Plan has been designed to qualify under Section 403(b) of the IRC. While the Plan document has not been updated for the post-2009 regulatory updates, the Plan Administrator believes the Plan is operating in accordance with the applicable requirements of Section 403(b) of the IRC and therefore believes the Plan is qualified and the related custodial accounts are tax-exempt.

Management evaluates tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

### **8. Plan Termination**

The Committee has the right to terminate the Plan subject to the provisions of ERISA.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### **10. Subsequent Events**

Management evaluated all events and transactions that occurred after December 31, 2022 and through October 10, 2023, which is the date the financial statements were available to be issued. The Plan did not have any material recognizable subsequent events during the period.



