## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of  
ARSI 401(k) Profit Sharing Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ARSI 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of August 17, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to August 17, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ARSI 401(k) Profit Sharing Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules ("DOL") and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 17, 2022 and December 31, 2021 and for the period from January 1, 2022 to August 17, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

As a result of a merger of American Recovery Service Incorporated with another company, the net assets of ARSI 401(k) Profit Sharing Plan in the amount of \$8,050,322 was merged into and with the retirement plan of the surviving entity effective August 17, 2022. Immediately after the Plan merger, ARSI 401(k) Profit Sharing Plan was terminated.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of ARSI 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was a defined contribution plan covering substantially all employees of American Recovery Service Incorporated (the "Company" or the "Plan Sponsor") who have at least one year of service, as defined, and are age 18 or older. The trustee of the Plan controlled and managed the operation and administration of the Plan. John Hancock Life Insurance Company served as the trustee of the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Plan Administration**

The Employer is the Plan administrator. The plan administrator was responsible for oversight of the Plan and has the authority to appoint person(s) or entities to carry out the operation of the Plan. The Investment Committee determined the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

**Plan Merger**

As a result of a merger of American Recovery Service Incorporated with another company, the net assets of ARSI 401(k) Profit Sharing Plan in the amount of \$8,050,322 was merged into and with the retirement plan of the surviving entity on August 17, 2022. Immediately after the Plan merger, ARSI 401(k) Profit Sharing Plan was terminated.

**Contributions**

The Plan permitted employees to contribute 100% of their pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Code limitations. Participants who have attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). During 2022, the Company made discretionary matching contributions of 25% of the first 6% of base compensation that a participant contributes to the Plan. The Company may also make qualified discretionary non-elective contributions. No discretionary non-elective contributions were made during 2022.

**Participant Accounts**

Each participant's account was credited with the participant's contributions, allocations of the Company's contributions and allocations of the Plan's earnings and charged with the participant's withdrawals, allocations of the Plan's losses, and allocations of the Plan's expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' non-vested accounts may be used to reduce Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants were immediately vested in their contributions and qualified non-elective contributions, plus actual earnings thereon. Vesting in Company matching contributions and Company profit sharing contributions was based on years of continuous service, as defined. A participant becomes 20% vested after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service and 100% vested after six years of service. However, upon reaching normal retirement age, or if an active participant dies or becomes permanently disabled prior to attaining normal retirement age, the participant's account becomes 100% vested.

**Investment Options**

Participants directed both employee deferrals and employer contributions to be invested in various investment options as made available and determined by the plan administrator.

**Benefit Payments**

A participant may withdraw the vested interest in their account only in the event of termination of employment, retirement, death, disability, financial hardship or when they reach age 59 ½. On termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a portion of the total vested balance at the participant's discretion, as permitted under the terms of the Plan.

**Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000, up to a maximum of \$50,000 or 50% of the vested portion of their account balance, whichever is less. The notes were secured by the balance in the respective participant's account and bear interest at rates that range from 5.25% to 7.50%, which were commensurate with local prevailing rates for similar notes at the time funds were borrowed. Principal and interest were paid ratably through payroll deductions.

**Forfeited Accounts**

Forfeited balances of terminated participants' non-vested accounts were used to reduce future Company contributions or to pay administrative expenses of the Plan. As of August 17, 2022 and December 31, 2021, forfeited non-vested accounts were \$0. During 2022 and 2021, the Company used all their forfeited non-vested accounts which amounted to \$0 and \$5,038, respectively, to reduce the Company discretionary matching contributions.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 17, 2022 or December 31, 2021. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

**Terminated and Defaulted Notes**

Notes receivable from participants are terminated when a participant withdraws from the Plan. Any unpaid note balance will be reduced by the amount of the vested interest in the account balance upon distribution. Notes with any scheduled repayment that remain unpaid as of the last business day of the calendar quarter following the calendar quarter in which repayment was due, or with an outstanding principal balance existing after the last scheduled repayment date, are in default.

**Investment Valuation and Income Recognition**

Investments are measured at quoted prices in an active market and have been certified complete and accurate by John Hancock Life Insurance Company, the Plan's trustee (Note 3). Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's investments recorded at fair value consists solely of pooled separate accounts ("PSA") valued at net asset value ("NAV") as a practical expedient. Accordingly, these investments are excluded from the fair value hierarchy disclosures.

PSA are valued at NAV which is based on the fair value of the underlying investments of the PSA, less any liabilities. The underlying investments of the PSA are mainly equity and fixed income securities and short-term investments. The investment strategies of the Plan's PSA vary generally based on the investment objectives of the asset class of which they are a part. Such investment strategies include investments in fixed income securities and investments in equity securities in domestic and international markets for growth and value objectives as well as to replicate market indexes and to invest in emerging markets. The Plan had no unfunded commitments related to PSA. The redemption of PSA is subject to the preference of individual Plan participants and contains no restrictions on the timing of redemption.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net decrease in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction charges for participant loans and benefit payments, if any, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments and are not readily determinable.

**NOTE 3 – INFORMATION CERTIFIED BY PLAN TRUSTEE (UNAUDITED)**

No auditing procedures were performed by the independent auditor as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA with respect to information certified as complete and accurate by John Hancock Life Insurance Company, the trustee, except for comparing such information with information reported in the financial statements. Based on information provided and certified by the trustee, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, for 2022 and 2021.

**NOTE 4 – PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Additionally, the Plan has notes receivable from participants which are considered exempt party-in-interest transactions. For 2022, total fees paid to John Hancock Life Insurance Company by the Plan for investment management services was \$31,030.

**NOTE 5 – INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the sponsor of the prototype plan adopted by the Company, by a letter dated May 7, 2015, that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code. Per Revenue Procedure 2005-16, a Company adopting such a plan may rely on the prototype plan's letter if the terms of the Plan are followed in operation. Accordingly, this reliance on the favorable opinion letter is equivalent to a favorable determination letter issued to the Company. The Plan has been amended since receiving the prototype plan's letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 17, 2022 and December 31, 2021, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing and other jurisdictions. However, there are currently no audits in progress for any prior tax periods.

**NOTE 6 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

*Level 1* - These inputs into the valuation methodology consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Examples of these inputs into the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - These Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments including pooled separate accounts. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements. The Plan is subject to review by certain regulatory authorities. Management does not believe that the effect of such reviews, if any, will have a significant impact on the Plan.
