INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees and Participants of
Trinitas Hospital Savings and Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements

We have performed an audit of the financial statements of Trinitas Hospital Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements ("2022 financial statements").

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Trinitas Hospital Savings and Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2022 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Trinitas Hospital Savings and Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Trinitas Hospital Savings and Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Auditor's Report on the 2021 Financial Statements

Predecessor auditors performed an audit of the 2021 financial statements of Trinitas Hospital Savings and Retirement Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated September 12, 2022 indicated that (a) the amounts and disclosures in the 2021 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2021 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2021 supplemental schedule, other than the information in the 2021 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2021 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following description of the Trinitas Hospital Savings and Retirement Plan (the "Plan"), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1986 and is a defined contribution and profit sharing plan covering all employees of Trinitas Regional Medical Center (the "Medical Center"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan's Pension Plan Committee is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees. The Plan's assets are administered under contracts with Fidelity Management Trust Company ("Fidelity"), the Trustee of the Plan. The Trustee invests funds received from contributions, investment sales, interest and dividend income and makes distribution payments to participants.

Effective December 31, 2022, the Plan merged with and into the RWJBarnabas Health 401(k) Savings Plan. The majority of the assets were transferred on December 30, 2022 with the remaining balance transferred on January 6, 2023. All investments were reflected in the RWJBarnabas Health 401(k) Savings Plan as of December 31, 2022. Fidelity will remain the Plan's Trustee. All specific attributes will remain the same for the Plan after the merger.

Eligibility

Employees of the Medical Center are eligible to participate after completion of one year of service (at least 1,000 hours) and attaining the age of 21.

Contributions

Each year, highly compensated participants may contribute up to six percent and non-highly compensated participants may contribute up to 50 percent of pretax annual compensation up to the maximum limits of the Internal Revenue Code ("IRC"). The Plan includes a Roth 401(k) feature in which participants may contribute post-tax annual compensation subject to the contribution provisions of the Plan and the maximum limits of the IRC. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the plan.

The Medical Center, at its discretion, may make a discretionary match equal to 50 percent of that portion of a participant's contribution which does not exceed three percent of the participant's pay each period. The Medical Center may also make discretionary nonelective contributions, qualified matching contributions or qualified nonelective contributions at the option of the Medical Center's Board of Trustees. All contributions are made to Fidelity. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the plan. Medical Center contributions are invested in the same manner as the participant contributions.

In 2022, the Medical Center made a discretionary match but did not make discretionary nonelective contributions, qualified matching contributions, or qualified nonelective contributions to the Plan.

As dictated by the Plan, the maximum participant contributions to a participant's account for a plan year is limited to the lesser of \$20,500 (or \$27,000 with catchup contributions for those over 50 years of age) for 2022 or 100% of the participant's annual compensation. The Internal Revenue Service ("IRS") has limited a participant's annual tax deferred contribution to \$20,500 (or \$27,000 with catch-up contributions for those over 50 years of age) for 2022.

Vesting

The participants have full and immediate vesting in their contributions, including related earnings therein, qualified matching Medical Center contributions and qualified nonelective Medical Center contributions. For all participants hired prior to April 1, 2003, discretionary matching Medical Center contributions will vest at 100 percent immediately.

The vesting schedule related to discretionary matching Medical Center contributions (participants hired after April 1, 2003) and discretionary nonelective Medical Center contributions is as follows:

Forfeited Accounts

Participants who terminate before becoming fully vested forfeit that portion of their account related to the employer contribution to which they are not vested. Any forfeited funds will periodically be used by the Medical Center to reduce its required contributions to the Plan. Forfeited funds were used to reduce the Medical Center's required contribution for the plan year ended December 31, 2022 in the amount of \$169. At December 31, 2022 and 2021, there were \$0 and \$27,922, respectively, of forfeitures available to be used to reduce the Medical Center's future required contributions.

Participant Accounts

Each participant's account is credited with (a) the participant's salary deferrals, (b) matching and non-elective contributions (c) rollovers from other qualified plans, (d) allocations of investment income changes in fair value of investments, and (e) charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Participants may receive all or a portion of their participant deferral account balance upon reaching 59-1/2 years of age as a cash lump sum payment, or a series of equal periodic installments payable for a specified number of fixed monthly or annual payments. Upon termination of service, a participant will receive a lump sum payment if the value of his or her account is \$1,000 or less. If the termination is for a reason other than death and the participant's account balance is greater than \$1,000, the participant may elect either a lump sum distribution or a 50 percent qualified joint and survivor annuity, which may defer minimum required distributions upon age 70-1/2 while the participant is still employed by the Medical Center. If payment of benefits is for reason of death, the payment is made as the participant elected upon entering the Plan. Under the IRC, a hardship withdrawal must be used to meet extraordinary medical expenses, educational expenses, expenses used to purchase a principal residence, prevent eviction from a principal residence, funeral expenses or casualty expenses. The application for the hardship withdrawal must be approved by the Plan administrator.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Borrowings are secured by the balance in the participant's account and had interest at rates that ranged from 4.25% to 7.25% throughout 2022, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid through payroll deductions each period. Terms for a loan generally range from one to five years, unless the loan is for the purchase of a principal residence, in which case the terms range from 5 to 10 years. Notes receivable are deemed to be in default and deemed distributed from the Plan immediately upon separation of employment, death or disability.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of assets and liabilities in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year. Certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's elective deferrals and qualified nonelective contributions, under certain circumstances, in accordance with the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by Medical Center and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Recent Accounting Standards

The Plan is not aware of any new accounting standards that were required to be adopted in 2022, or yet to be adopted, that would significantly impact the Plan's 2022 or prospective financial statements.

3. Information Certified by Trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2022 and 2021, and therefore, as permitted, no auditing procedures were performed by the independent auditor with respect to the information certified by the Trustee. The Trustee has certified to the completeness and accuracy of the investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2022 and 2021, and the related investment activity and notes receivable activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value:

- Money market fund is valued at the quoted net asset value (“NAV”) of shares held by the Plan at year-end.
- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price.
- Stable value funds are valued at the NAV. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. Related Party and Party-In-Interest Transactions

Certain of the Plan's investments are managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Medical Center. No such officer or employee receives compensation from the Plan.

6. Income Tax Status

The Plan has received a favorable determination letter dated June 30, 2020, in which the IRS stated that the Plan is in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Management evaluates tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

7. Plan Termination

The Committee has the right to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in employer contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

A claim arising in the normal course of operations is pending against the Plan Sponsor. While the ultimate effect of such actions cannot be determined at this time, any costs and other liabilities related to this suit, above insured limits, will be paid by the Plan Sponsor and not charged to Plan assets.

9. Subsequent Events

Management evaluated all events and transactions that occurred after December 31, 2022 and through October 10, 2023 which is the date the financial statements were available to be issued. The Plan did not have any material recognizable subsequent events during the period.



