Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We were engaged to perform audits of the financial statements of The University of Vermont Health Network - Home Health and Hospice, Inc. 403(b) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by the banks or similar institutions or insurance carrier that are regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institutions in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion on the Financial Statements

We do not express an opinion on the accompanying 2022 financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion on the Financial Statements section of our report, we have not been able to obtain sufficient, appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion on the Financial Statements

Prior to January 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained, and the custodians did not provide sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.

As further discussed in Note 8 to the financial statements, the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans, allows the Plan to exclude from these financial statements certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, and the related income and distributions. Prior to 2009, annuity and custodial accounts of the Plan were maintained as individual accounts and were not combined for plan level reporting. As a result, the Plan's books and records may exclude certain accounts entered into prior to January 1, 2009. U.S. generally accepted accounting principles require that these accounts and the related income and distributions be included in the accompanying financial statements. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Plan merged into the University of Vermont Health Network 403(b) Retirement Savings Plan effective December 31, 2022. As a result, subsequent to the merger, the Plan is no longer a going concern.

Responsibilities of Management for the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

(1) Description of Plan

The following description of The University of Vermont Health Network - Home Health and Hospice, Inc. 403(b) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan was established January 1, 1997 as a defined contribution plan funded by employer and employee contributions. All participants in the Plan are or were employees of The University of Vermont Health Network - Home Health and Hospice, Inc. (formerly, the VNA of Chittenden and Grand Isle Counties, Inc.) (the “Organization”). An employee shall be eligible to participate in the Plan on the first day that the employee first performs service for the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective September 21, 2020, The University of Vermont Health Network - Home Health and Hospice, Inc. Defined Contribution (“DC Plan”) Plan was terminated and as of December 31, 2021 plan transfers from the DC Plan amounted to \$6,607,866.

Effective December 31, 2022, the Plan merged into the University of Vermont Health Network 403(b) Retirement Savings Plan (UVMHN Plan).

(b) Contributions

Contributions to the Plan were made by both the Organization and the employee. Participants could contribute 1% to 100% of their annual compensation, as defined by the Plan, subject to the Internal Revenue Service (IRS) limits. The Plan also allowed for rollover contributions from other qualified plans.

The Organization could make annual discretionary matching contributions, up to 3% of compensation deferred, to participants who had attained the age of 18, had been employed for one year and had been credited with 1,000 hours of service. Catch-up contributions were not matched. The Organization matched 100% of the first 3% that was deferred during the years ended December 31, 2022 and 2021.

(c) Vesting

A participant was 100% vested in their account at all times.

(d) Participant Accounts

Each participant's account was credited with the participant's contribution, allocations of the Organization's contributions, and Plan earnings. Earnings were allocated to participant accounts based on account balances. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Plan management had excluded from investments in the accompanying statements of net assets available for plan benefits and statement of changes in net assets available for plan benefits certain annuity accounts issued to former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The value of these accounts has not been determined.

The Plan offered participants the option to choose between mutual funds, money market funds, guaranteed income accounts, and pooled separate accounts. Investments were participant directed.

(e) Notes Receivable

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account and would bear interest at current market rates. Principal and interest was repaid directly to the respective custodian.

(f) Payments of Benefits

Upon retirement or disability at any age, the participant would be entitled under the terms of the Plan to purchase a monthly or periodic income annuity option or choose a lump-sum distribution. In the event a participant died prior to commencement of retirement benefit payments, the full current value of the account was then payable to the beneficiary or beneficiaries named by the participant.

A participant terminating employment for reasons other than retirement or disability could choose a lump-sum distribution or choose to wait until they reached retirement age.

Hardship distributions were permitted in an amount not to exceed the total participant's elective deferral amount. In-service distributions from custodial accounts were not permitted. In-service withdrawals of employer matching contributions from annuity contracts were allowed after attainment of age 59 ½.

Participants could also withdraw rollover contributions at any time.

(g) Plan Termination

The Plan merged into the University of Vermont Health Network 403(b) Retirement Savings Plan effective December 31, 2022.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles required the Plan Administrator to make estimates and assumptions that affected the reported amounts of net assets available for plan benefits and changes therein during the reporting period. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Mutual funds, money market funds, and pooled separate accounts were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold, as well as held during the year.

Certain guaranteed income accounts were reported at contract value which was the relevant measurement attributable to fully benefit-responsive investment contracts because contract value was the amount participants would have received if they were to initiate permitted transactions under the terms of the Plan. The Plan invested in investment contracts through a common/collective trust.

(d) Administrative Expenses

In general, expenses of the Plan were paid by the Organization. Certain investment and administrative expenses were paid by the Plan.

(e) Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

(f) Notes Receivable

Notes receivables from participants were reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Adoption Agreement.

(g) Benefit Payments

Benefits were recorded when paid.

(h) Subsequent Events

The Plan evaluated subsequent events through October 13, 2023, the date the Plan's financial statements were available to be used.

(3) Information Certified by the Plan's Custodians

The Plan Administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Fidelity Management Trust Company and The Variable Annuity Life Insurance Company, the custodians of the Plan, had certified as being complete and accurate the investments on the statements of net assets available for plan benefits as of December 31, 2022 and 2021, and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2022 and 2021. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's custodians.

(4) Investment Contract

The Plan had entered into fully benefit-responsive guaranteed investment contracts. The accounts were credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses. The guarantee investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the guaranteed investment income contracts were fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contracts. The guaranteed investment contracts were presented on the face of the statements of net assets available for plan benefits at contract value.

Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates were reviewed on a quarterly basis for resetting.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment option or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that caused a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would have allowed the issuer to terminate the contract with the Plan and settled at an amount different from contract value. Examples of such events included (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, (d) a material misrepresentation. The Plan Administrator did not believe that any events that would limit the Plan's ability to transact at contract value with plan participants were probable of occurring.

The guaranteed investment contracts did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(5) Fair Value Measurements

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds and money market: Valued at the closing price reported on the active market on which the individual securities were traded.

Pooled separate accounts: These accounts, whose sole asset is an underlying mutual fund, were reported at fair value based on the quoted market prices of the underlying mutual funds.

The preceding methods described could produce a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

(6) Income Tax Status

The Plan was based on a prototype plan and was relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated March 31, 2014. This letter stated that the prototype and related trust were designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Although the Plan had been amended since receiving the opinion letter, the Plan Administrator and prototype sponsor believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

(7) Related Party Transactions

The Plan had arrangements in place with several service providers. These transactions were considered party-in-interest transactions under ERISA.

(8) Unavailability of Accounting Records and Supporting Documents Relating to Certain Annuity and Custodial Accounts

The Plan historically was viewed as a combination of individual annuity and custodial accounts. The Plan and its service providers did not maintain financial information at the Plan level. As of January 1, 2009, the Plan's service providers began to provide the Plan administrator with annual certified statements summarizing the Plan's activities and holdings. Because certain historical records were not maintained or are not available at the Plan level, the Plan may have excluded from investments in the accompanying statements of net assets available for benefits certain annuity and custodian accounts, and related activity, issued to current and former employees prior to January 1, 2009. This election is permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans* (FAB 2009-02), however, accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements. The amounts of these excluded annuity and custodial accounts and the related income and distributions are not determinable.
