### **Independent Auditors' Report**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Price Chopper Associate 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021 and the related statements of changes in net assets available for benefits for the years ended December 31, 2022 and 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Price Chopper Associates 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2022 and 2021 and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## Notes To Financial Statements

### **Note 1: Description Of Plan**

The following description of the Price Chopper Associate 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering eligible employees of the Golub Corporation (the Company). Eligible employees become participants in the Plan following completion of four months of work following an employee's commencement of employment and attainment of age 21. The Plan's entry dates are the first day of the month coinciding with or next following the date in which an employee meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute a percentage of annual compensation, as defined in the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary matching contribution each year to the Plan. For the years ended December 31, 2022 and 2021, employer matching contributions were \$2,100,000 for each year. All contributions are subject to Internal Revenue Code limitations.

Participants' accounts - Each participant's account is credited or charged with the participant's contribution, an allocation of the Company's discretionary contribution, plan earnings (losses), payments, withdrawals, expenses, or other deductions made to or from such accounts during the year. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's portion of their accounts is based on years of continuous service. Upon the attainment of three years of service, participants become fully vested in company discretionary contributions.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans must be adequately secured and made in accordance with the terms of the Plan. Principal and interest is paid ratably through payroll deductions. The Plan allows for no more than one outstanding loan at any time.

#### **Note 1: Description Of Plan (Continued)**

Payment of benefits - On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's interest in his or her account. A participant can also elect to receive their benefit in the form of installment payments. Hardship withdrawals may be made due to immediate financial need, as defined by the Plan.

Plan termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue and terminate the Plan at any time subject to the provisions of ERISA. In the event the Plan terminates, each participant's account will be distributed in accordance with the Plan agreement.

#### **Note 2: Summary Of Significant Accounting Policies**

Investment valuation and income recognition - Accounting principles generally accepted in the United States of America establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The three levels of the fair value hierarchy in accordance with accounting principles generally accepted in the United States of America are described below:

Level 1: Unadjusted quoted prices in active markets for identical, unrestricted assets, or liabilities that the Plan has the ability to access at the measurement date;

Level 2: Quoted prices which are not active, quoted prices for similar assets or liabilities in active markets, or inputs other than quoted prices that are observable (either directly or indirectly) for substantially the full term of the asset or liability; and

Level 3: Significant unobservable prices or inputs (including the Plan's own assumptions in determining the fair value of investments) where there is little or no market activity for the asset or liability at the measurement date.

### Notes To Financial Statements

#### **Note 2: Summary Of Significant Accounting Policies (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Purchases and sales of securities are recorded on a trade-date basis with the gain or loss based upon the actual cost of the securities. Interest and dividend income are recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes receivable from participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Income taxes - The Plan is exempt from federal income tax under the Internal Revenue Code. Tax positions are evaluated and recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The Plan has adopted a non-standardized pre-approved document which has an IRS opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. The application of these accounting principles involves the exercise of judgment and use of assumptions as to future uncertainties and, as a result, actual results could differ from these estimates. The Plan periodically evaluates estimates and assumptions used in the preparation of the financial statements and makes changes on a prospective basis when adjustments are necessary.

Presentation - Certain reclassifications, when applicable, are made to the prior year financial statement presentation to correspond to the current year's format. Reclassifications, when made, have no effect on net assets available for benefits or changes in net assets available for benefits.

The information certified includes total investments and notes receivable from participants of \$-0- and \$270,320,470 at December 31, 2022 and December 31, 2021, respectively and related investment income (loss) of \$(54,147,003) and \$34,456,143 for the years ended December 31, 2022 and 2021, respectively.

#### **Note 4: Fair Value Measurements**

The following is a description of the valuation methodologies used for assets at fair value at December 31, 2022 and 2021:

*Mutual funds:* Valued at quoted market prices at year end.

*Common collective trusts:* Valued and redeemable at net asset value on a daily basis.

*Stable value fund:* The stable value fund is composed primarily of investment contracts contained in a collective trust and is valued at the Net Asset Value (NAV) of the units of the collective trust. The NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. The objective of the Fund is to provide preservation of capital and relatively stable returns consistent with comparatively low risk.

The preceding methods may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

In accordance with accounting principles generally accepted in the United States of America, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. **Note 5: Excess Contributions Payable**

Contributions received from participants for December 31, 2022 and 2021 are net of \$468,955 and \$513,841, respectively for excess contributions payable. These amounts relate to excess deferral contributions paid or owed to certain active participants as required by the nondiscrimination provisions of the Plan. The amount is also included in the Plan's statements of net assets available for benefits as excess contributions payable at December 31, 2022 and 2021.

The total contributions and earnings returned by the Plan, included in benefit payments, during the years ended December 31, 2022 and 2021, in order to satisfy the nondiscrimination tests, were approximately \$513,000 and \$500,000, respectively.

#### **Note 6: Related Party Transactions**

Certain fees for administrative services may be paid by the Company. Certain plan investments are managed by Principal Trust Company. Principal Trust Company is the Trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

#### **Note 7: Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

#### **Note 8: Commitments And Contingencies**

The Plan follows the guidance for uncertainty in income taxes. As of December 31, 2022, the Plan believes that it has appropriate support for the income tax positions taken and to be taken on its returns based on an assessment of many factors including experience and interpretations of tax laws applied to the facts of each matter. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits.

#### **Note 9: Plan Transfer**

On April 25, 2022, the Plan received a transfer of \$58,593,852 of cash consideration from the Golub Corporation Profit Sharing Plan.

#### **Note 10: Plan Merger**

During the year ended December 31, 2022, Price Chopper Associate 401(k) Plan transferred the assets of this plan into the Tops Markets, LLC 401(k) Retirement Savings Plan. As a result, investments and notes receivable from participants totaling \$245,302,769 were transferred from the Plan into the Tops Markets, LLC 401(k) Retirement Savings Plan. Combined, the two plans became Northeast Grocery 401(k) Plan. The Northeast Grocery 401(k) Plan allows for employee elective deferrals, employer discretionary contributions, and an employer safe harbor matching contribution.
