## Independent Auditor's Report

To the Plan Administrator  
Sheltered Savings Plan of Bank Leumi USA

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Sheltered Savings Plan of Bank Leumi USA (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### *Opinion*



### Notes to Financial Statements December 31, 2022 and 2021

#### Note 1 - Description of the Plan

The following is a brief description of the Sheltered Savings Plan of Bank Leumi USA (the "Plan") and is presented for general information purposes only. As of December 31, 2022 and 2021, the participating employer of the Plan is Bank Leumi USA ("BLUSA" or "Plan Sponsor").

Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### General

The Plan is a defined-contribution plan covering substantially all permanent employees of the Plan Sponsor. A permanent employee is defined as an individual who is hired for an unspecified period of time. An employee is eligible to participate in the Plan upon their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Effective December 30, 2022, the Plan merged with and transferred all Plan assets and liabilities into Valley National Bank Savings and Investment Plan. These Plan assets and liabilities were transferred out at the fair market value on December 30, 2022. As a result of the transfer, no amount under the Plan was used for or diverted for purposes other than for exclusive benefit of the participants.

#### Contributions

*Participant Contributions:* Participant contributions consist of "Pre-tax contributions," "After-tax contributions" and "Rollovers." Pre-tax contributions reduce the participant's taxable compensation. After-tax contributions do not reduce a participant's taxable compensation. Rollovers are transfers from other qualified retirement plans.

For each Plan year, participants are eligible to make pre-tax contributions of up to 25% of their earnings (as defined). Pre-tax contributions during 2022 and 2021 are limited by Internal Revenue Service ("IRS") Section 402 to \$20,500 and \$19,500, respectively. Individuals who attain age 50 may make additional pre-tax "catch-up" contributions up to \$6,500 for 2022 and 2021.

*Employer Contributions:* In 2022 and 2021, the employer contribution was 66.7%-100% of each participant's contribution; however, the contribution is limited to 6% of employee base compensation plus eligible bonuses determined by years of service, as defined by the Plan. Contributions are allocated to the Plan's investment funds determined by the investment election of each participant.

New hires are automatically enrolled in the Plan. The default contribution is 6%. Employees have 30 days to opt out of the Plan if they wish to do so. The American Target Date Funds are the default funds if no investment elections are made.

*"415 Limitation":* Under Section 415 of the Internal Revenue Code (the "Code"), annual additions to a participant's account under the Plan, as well as total benefits a participant can obtain under all qualified plans, may not exceed the lesser of \$61,000 or \$58,000, or 100% of a participant's compensation (up to \$305,000 or \$290,000 as adjusted by the IRS) for 2022 and 2021, respectively.

*Limitation on Contributions for Highly Compensated Employees ("HCE"):* Sections 401(k) and 401(m) of the Code also limit the amount of pre-tax, after-tax, and Plan Sponsor contributions that can be made to the Plan for HCE.

#### Group annuity contract

##### **New York Life Guaranteed Interest Account**

The New York Life Guaranteed Interest Account is a stable value investment option with a guarantee of principal and accumulated interest provided by New York Life Insurance Company ("New York Life"). Contributions to the Guaranteed Interest Account are invested in a group annuity contract issued by New York Life. Contributions to the contract are currently invested in a broadly diversified fixed income portfolio within New York Life's general account. The investments in the general account are intended to provide a stable crediting rate consistent with preservation of principal. The general account is invested primarily in a conservative array of securities and cash-equivalent investments in accordance with the investment restrictions of New York insurance law. The primary objective of the general account is to ensure that New York Life can meet its obligations to policyholders and contract holders. Investments in a group annuity contract are measured at the contract value, which equals the value of deposits made to the contract plus earnings at the guaranteed credit ratings, less withdrawals and fees.

There are no events that would limit the ability of the Plan to transact at contract value paid either immediately or, depending upon the rate environment and cash flow levels, over time. There are no events that allow the issuer to terminate the contract and which require the Plan Sponsor to settle at an amount different than contract value.

#### Self-directed brokerage account

In addition to the above, participants can establish a self-directed brokerage account to invest in stocks and bonds of their choice. The total fair value of this account was \$0 and \$2,255,968 as of December 31, 2022 and 2021, respectively.

#### Participant loans

Participants are permitted to borrow from their accounts. Participant loans are limited to 50% of a participant's vested eligible account balance up to a maximum of \$50,000. Such loans bear interest as determined by the trustees and are collateralized by the participants' account in the Plan. The interest rate for those loans ranged from 4.25% to 8.50% during December 31, 2022 and 2021, respectively.

#### Participant accounts

Each participant has two accounts in the Plan: an employee account and a company account. The participant's employee account reflects all contributions made by the employee and income, gains, losses, withdrawals, distributions, and expenses attributable to these contributions. The participant's company account reflects his or her share of Plan Sponsor contributions for each Plan year and the income, gains, losses, withdrawals, distributions, and expenses attributable to these contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Distributions and withdrawals

Participants age 59-1/2 or older are permitted to make withdrawals from their vested accounts, subject to certain limitations as set forth in the Code. Upon termination of service, a participant may elect to receive a distribution of the vested portion of his or her account in a lump-sum amount. The unvested portion is forfeited and used to reduce the Plan Sponsor contribution or reduce Plan expenses.

#### **Vesting**

For 2022 and 2021, participants are immediately vested in their elective contributions plus earnings thereon. Participants become vested in employer contributions plus earnings thereon based on years of service and become 100% vested after three years of service (33% per year for three years).

#### **Forfeitures**

If a participant is not fully vested and terminates their employment, the units representing the non-vested portion of his or her account shall constitute forfeitures. Forfeitures may be used for payment of Plan expenses or used to reduce the Plan Sponsor's contribution. In 2022, employer contributions were reduced by \$187,842 from forfeited nonvested accounts and \$0 of the forfeitures were used to reduce Plan expenses. As of December 31, 2022 and 2021, the balances in forfeited nonvested accounts were \$0 and \$171,049, respectively.

#### **Note 2 - Summary of significant accounting policies**

##### **Basis of presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

##### **Administrative costs**

All administrative costs of the Plan are borne by the Plan Sponsor, except a portion of the administrative fees.

##### **Security transactions and income recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized on an accrual basis. Dividend income is recorded on the ex-dividend date. Net depreciation and appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Investment valuation**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at measurement date. See Note 3 for discussion and disclosures related to fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### **Notes receivable from participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of benefits

Benefits are recorded when paid.

#### Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Risks and uncertainties

The Plan provides various investment options. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

#### Subsequent events

Management evaluated subsequent events of the Plan through October 12, 2023, the date the financial statements were available to be issued, and determined that there are no subsequent events to be recognized in these financial statements.

#### Note 3 - Fair value measurements

Fair value is defined under Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). To measure fair value, a hierarchy has been established that requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs. As such, the hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy in ASC 820 are described as:

- Level 1: Quoted market prices in active markets for identical assets or liabilities.
- Level 2: Quoted prices in active markets for similar assets and liabilities, quoted prices for identically similar assets or liabilities in markets that are not active and models for which all significant inputs are observable either directly or indirectly.
- Level 3: Unobservable inputs reflecting the reporting entity's own assumptions or external inputs for inactive markets.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Cash equivalents:* Valued at amortized cost, which approximates fair value.

*Mutual funds:* Valued at the net asset value of shares held by the Plan as reported on the active market at year end.

The preceding methods described may produce a fair value calculation that may not indicate net realizable value or reflect future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 4 - Income tax status

The Plan obtained its latest Letter of Determination on May 2, 2017, in which the Internal Revenue Service (the "IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

The Plan administrator and the Plan's counsel believe that the Plan is currently operating in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more-likely-than-not, based on the technical merits, to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5 - Exempt party-in-interest transactions**

Certain officers and employees of BLUSA (who may also be participants of the Plan) perform administrative services related to the operation, recordkeeping, and financial reporting of the Plan. BLUSA pays these salaries and other administrative expenses on behalf of the Plan. These transactions may be deemed party-in-interest transactions. However, they are covered by statutory administrative exemptions from the Code and ERISA's rules on prohibited transactions.

Certain Plan investments may be shares of mutual funds, a money market investment and self-directed brokerage accounts managed by the trustee, as defined by the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions.

#### **Note 6 - Certified Investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the \*Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2022 and 2021, and investment income and interest income on notes receivable from participants for the year ended December 31, 2022, that are disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee and recordkeeper of the Plan.
