Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 DESCRIPTION OF PLAN

The following description of U.S. Venture Affiliates 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Tire's Warehouse, Inc. (the Company) who are at least 21 years of age (effective March 1, 2022, no age requirement). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

During 2022, the Plan was restated to change the Plan name to U.S. Venture Affiliates 401(k) Retirement Savings Plan (formerly Tire's Warehouse 401(k) Retirement Savings Plan) and change the Plan Sponsor to U.S. Venture, Inc. (formerly Tire's Warehouse, Inc.). The restatement also changed plan provisions by removing the age requirement for eligibility, adding new contribution sources, increasing the contribution limit, modifying automatic enrollment and automatic increase provisions, and allowing loans.

Plan Mergers

Effective May 2, 2022, the plan assets of the Treadmaxx Tire Distributors, Inc. 401(k) Plan were transferred into the Plan under a merger transaction that put the Plan under common control. The total amount of the transfer was \$8,593,096. All eligible participants in the Treadmaxx Tire Distributors, Inc. 401(k) Plan became eligible to participate in the Plan.

Effective December 31, 2022, participant account balances and all assets were transferred and merged into the U.S. Venture 401(k) Retirement Savings Plan (a related entity). The total amount of the transfer was \$22,910,524. Effective January 1, 2023, participants in the Plan were eligible to participate in the U.S. Venture 401(k) Retirement Savings Plan.

Contributions

Each year, participants may contribute up to 90% (75% prior to March 1, 2022) of annual compensation, as defined in the Plan. Participants may elect to have any portion, or all of their contributions designated as pre-tax, Roth, or post-tax 401(k) contributions (Roth and post-tax added February 1, 2022). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have Roth deferrals set at a rate of 5% of eligible compensation and their contributions invested in the applicable retirement fund based on the participant's year of birth until changed. Effective February 1, 2022, any participant electing a deferral rate of less than 15% will have a percent deferral automatically increased annually unless they affirmatively elect not to participate in automatic increase.

Contributions (continued)

The Company contributes 100% of the first 3% and 50% of the next 2% of eligible compensation that a participant contributes to the Plan. During 2022 and 2021, the Company made \$1,919,319 and \$1,309,173 of safe harbor matching contributions to the Plan, respectively. A discretionary nonelective contribution may be contributed at the option of the Company's Board of Directors. No such nonelective contribution was made to the Plan during 2022 or 2021.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, as well as allocations of the Company's nonelective contributions and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, Company match contributions and actual earnings thereon. Additional nonelective contributions are allowed under the Plan but not made in the current year and would be subject to vesting based on years of continuous service. Participants would be 100% vested in the Company's nonelective contributions after five years of credited services.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from one to five years; however, a longer repayment period may be permitted if the loan is for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at the market rate as determined at the time of the loan by the Plan administrator. Principal and interest is paid ratably through biweekly payroll deductions.

Benefit Payments

Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution, partial payments, or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. However, if the value of the vested benefit is less than \$5,000, a lump-sum distribution will be made regardless of whether or not an election has been made.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022. Delinquent notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Administrative Expenses

Administrative expenses may be paid either by the Plan or by the Company. Expenses paid by the Company are excluded from these financial statements. Certain administrative expenses of maintaining the Plan that are paid by the Plan are included in administrative expenses. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 12, 2023, the date on which the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

T. Rowe Price Trust Company, qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021 and the statements of changes in net assets available for benefits for the years then ended.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021. The Plan held no assets as of December 31, 2022.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Collective Trust Funds: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions. During 2022, the Plan Sponsor made the decision to merge the Plan into the U.S. Venture 401(k) Retirement Savings Plan (see Note 1).

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS on the nonstandardized pre-approved profit sharing plan with cash or deferral arrangement indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of funds managed by the qualified institution of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management, trust services, and other administrative services are included under administrative expenses on the statements of changes in net assets available for benefits for the years ended December 31, 2022 or 2021. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain employees and officers of the Plan sponsor, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

NOTE 9 PROHIBITED TRANSACTIONS – PARTICIPANT CONTRIBUTIONS

The Company failed to remit employee 401(k) deferral contributions for one payroll period within the timeframe prescribed by the Department of Labor regulations totaling \$56 for the year ended December 31, 2022. This is deemed a prohibited transaction in accordance with ERISA and the Internal Revenue Code. The Plan Administrator is in the process of taking corrective action and depositing the missed contributions, along with lost earnings, to the U.S. Venture 401(k) Retirement Savings Plan.
