Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pediatric Therapy Holdings, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

Note 1: Description of Plan

The following description of the Pediatric Therapy Holdings, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective July 18, 2022, the Plan was amended and restated. Under the restatement, the Plan changed plan sponsors from Theraplay, Inc. to Pediatric Therapy Holdings, Inc. and, as a result, the plan name changed from Theraplay, Inc. 401(k) Profit Sharing Plan to Pediatric Therapy Holdings, Inc. 401(k) Plan. Theraplay, Inc., Positive Steps Therapy, Children's Therapy Center and Fleming Therapy Services, Inc. were removed from being participating employers in the Plan as a result of the restatement.

General

The Plan, sponsored by Pediatric Therapy Holdings, Inc. (the "Company", is a defined contribution plan covering all eligible employees who are age 21 or older. Non-resident aliens, employees hired to work less than 20 hours per week, and leased employees are not eligible to participate in the Plan. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Participating employers of the Plan include Austill's Rehabilitation Services, Inc. and AOT, Inc.

Contributions

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Participants may make Roth elective deferrals and catch-up contributions are permitted for participants who have attained age 50 before the end of the plan year. Participants may also contribute amounts representing distributions from a previous qualified plan (rollover), excluding after-tax employee contributions and in-kind rollovers. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants who have worked at least 1,000 hours during the plan year are eligible for Company matching and discretionary contributions. The participant must be employed and an eligible employee on the first day of the first or seventh month to be eligible for the Company matching and discretionary contributions. The Company contributes 20% of elective deferrals up to 6% of compensation that a participant contributes to the Plan. Additional discretionary profit sharing amounts may also be elected by the Plan. The Plan did not make a discretionary profit sharing contribution for 2022.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Plan matching contributions, and allocations of (a) Company profit sharing contributions, if applicable, (b) plan earnings (losses), and (c) administrative expenses that are paid out of the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions, rollover contributions, Plan safe harbor matching contributions and the Company's discretionary matching contribution portion of their accounts plus actual earnings (losses) thereon. Vesting in the Plan's profit sharing contribution portion of their accounts plus actual earnings (losses) thereon is based on years of continuous service. Participants become fully vested based on a graded schedule of six years.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates from 4.25% to 6.00%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Participants are limited to one outstanding loan balance at a time.

Payment of Benefits

Participants' benefits under the Plan are payable to participants, their beneficiaries or their estates, upon termination of employment, normal retirement (as defined in the Plan document), disability, death, hardship or upon the attainment of age 59-1/2. Benefits are payable in the form of lump sum distributions. The Plan may elect to make a mandatory distribution of account balances that are less than \$5,000. For any mandatory distribution exceeding \$1,000, the participant shall be given the option to receive the distribution directly or rollover into a qualified plan.

Forfeitures

Forfeited nonvested accounts totaled \$7,276 and \$1,983 as of December 31, 2022 and 2021, respectively. These accounts may be used to reduce future Plan contributions or to pay administrative expenses of the Plan in accordance with the plan document. Forfeitures were not used during the year ended December 31, 2022.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States. Under this basis, investment income and contributions are recorded when received, and plan expenses are recorded when paid, rather than recording such items on an accrual basis.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded when cash is disbursed or received. Interest and dividend income is recorded when cash is received. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when paid. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 12, 2023, which is the date the financial statements were available to be issued.

Effective March 23, 2023, the Pediatric Therapy Holdings, Inc. 401(k) Plan Administrator changed the name of the Plan to the Associated Occupational Therapists, Inc. 401(k) Plan.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

Mutual funds held in pooled separate accounts: Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company, (the Custodian of the Plan).

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by John Hancock Life Insurance Company, the Custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for administration and investment management services were \$40,319 for the year ended December 31, 2022.

Fees paid by the Plan to Associated Benefit Planners, the Plan's Third Party Administrator, amounted to \$4,950 for the year ended December 31, 2022. Fees paid by the Plan to Newton One Advisors, LLC for investment advisory services amounted to \$40,838 for the year ended December 31, 2022.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7: Tax Status

The Plan adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties and Concentration of Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits - modified cash basis.

At December 31, 2022, four investment securities represented 52% of plan net assets. At December 31, 2021, three investment securities represented 35% of plan net assets.

Note 9: Partial Plan Termination

During the year ended December 31, 2022, the Company terminated the employees of the Theraplay, Inc., Positive Steps Therapy, Children's Therapy Center and Fleming Therapy Services, Inc. In aggregate, the terminations represented a partial termination of the Plan. As a result of this partial termination, all accumulated benefits of affected employees were fully vested as of July 18, 2022, the date on which the employees were terminated.


