## Independent Auditor's Report

To the Plan Administrator  
RSC Insurance Brokerage, Inc. 401(k) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of RSC Insurance Brokerage, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

*Supplemental Schedules Required by ERISA*

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### Note 1 - Description of Plan

The following description of the RSC Insurance Brokerage, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all employees of RSC Insurance Brokerage, Inc. and related companies (the "Company"). The Plan covers all employees who are 21 years of age and have completed three months of service that are not leased employees, non-resident aliens or residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Fiduciary Governance Committee.

##### **Contributions**

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants may designate all or a portion of their contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified (and certain nonqualified) defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% pre-tax of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may also elect to contribute a discretionary matching contribution. For the year ended December 31, 2022, the Company will match 66% of deferrals up to 6% of eligible compensation up to a maximum contribution of \$4,000. The Company may make discretionary profit-sharing contributions; however, no discretionary profit-sharing contributions were elected for the year ended December 31, 2022. Participants also direct the investment of Company contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

##### **Participant accounts**

Each participant's account is credited with the participant's and Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in all salary deferral, employer matching and rollover contributions plus actual earnings thereon.

For profit sharing contributions, participants become fully vested after six years of vested service. At least 1,000 hours of service must be rendered in a year to qualify as a year of service for vesting purposes. Vesting occurs ratably over a six-year period as indicated in the following schedule:

<u>Years of vesting service</u>	<u>Percentage vested</u>
Less than 2 years	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%
6 years or more	100%

Upon termination of service due to death, disability, or reaching the normal retirement age, participants' Company profit sharing contribution accounts become fully vested.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate is set by the Plan Administrator based on interest rates currently being charged on similar commercial loans by persons in the business of lending money. Principal plus interest are paid ratably through payroll deductions.

#### **Payment of benefits**

On termination of service for any reason, a participant may elect to receive his or her distribution in a lump-sum equal to the value of his or her account. Participants with an account balance of \$1,000 or less will receive a lump-sum amount equal to the value of the participant's interest in his or her account. For terminated participants with account balances of \$1,000 or more but less than \$5,000 who do not elect a form of distribution from the Plan will have their account balances rolled over into an individual retirement account as allowed by the Plan. Participants with an account balance greater than \$5,000 may defer payment of benefits until a later date, unless a minimum distribution is required.

Participants who are at least 59 ½ years of age may withdraw all or a portion of the vested balance in their account prior to termination for any reason. Withdrawals from the vested portion of a participant's account may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan.

#### **Forfeited accounts**

At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$18,588 and \$2,568, respectively. These forfeited non-vested accounts are used to reduce the Company's future contributions to the Plan or to pay for Plan expenses. During 2022, the Company did not use forfeitures to reduce employer contributions.

### **Note 2 - Summary of accounting policies**

#### **Basis of presentation**

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

#### Use of estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

#### Benefit payments

Benefit payments are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payments of benefits to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

#### Subsequent events

The Company has evaluated subsequent events through October 13, 2023, the date the financial statements were available to be issued.

Effective on September 1, 2023, the Company entered into an agreement for the trust of the plan to be administered by Fidelity Workplace Services ("FWS"). In conjunction with the change in trust administration to FWS, Fidelity Management Trust Company ("Fidelity") became the trustee of the Plan's assets. Accordingly, all Plan assets were transferred to the custody of Fidelity.

On January 1, 2023, the plan sponsor changed from RSC Brokerage, Inc. to Apex Insurance Holdings, Inc. and the Plan was amended and renamed to the Risk Strategies - One80 401(k) Plan. A new entity was formed, One80 Intermediaries Inc. A subset of employees was moved to the One80 Intermediaries, Inc. entity and both entities, One80 Intermediaries, Inc. and RSC Insurance Brokerage, Inc., became participating employers of Apex Insurance Holdings, Inc. April 18, 2023, Apex Insurance Holdings, Inc. changed its name to Accession Risk Management Group, Inc. and amended the Plan to reflect the name change.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022 and 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds and the money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds and the money market funds held by the Plan are deemed to be actively traded.

#### Note 4 - Certification by the custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2022 and 2021, and investment loss and interest income on notes receivable from participants for the year ended December 31, 2022, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Newport Trust Company, the custodian of the Plan.

#### Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### Note 6 - Tax status

The Plan has been designed using a volume submitter plan document designed by The Angell Pension Group, Inc. The Angell Pension Group, Inc. received an advisory letter dated June 30, 2020, in which the IRS stated that the volume submitter plan satisfies the applicable requirements of the Internal Revenue Code (the "IRC"). Although the Plan has been amended since receiving the advisory letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Related party and party-in-interest transactions**

Newport Trust Group manages the Plan's investment assets. Newport Trust Group is owned by investment funds managed by Kelso & Company, which also indirectly owns, through certain of its managed investment funds, 54.5% of the Company. Newport Trust Group is the custodian as defined by the Plan and, therefore, these transactions also qualify as party-in-interest. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions. Indirect fees paid to the custodian for certain investment management services are included in the net depreciation in fair value of investments. Fees paid by the Plan to the custodian for investment management and administrative services amounted to \$303,086 for the year ended December 31, 2022.

#### **Note 8 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 9 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain Plan contributions were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 CFR2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the years ended December 31, 2022 and 2021. During 2022, the Plan corrected the 2021 nonexempt transaction by remitting the lost earning to the affected participants' accounts. Plan management is working with the third-party administrator to calculate and fund the necessary corrective contribution for 2022 delinquent remittances.
